Minutes of February 19, 2024

The Huntington Township Trustees met in regular scheduled meeting at 7:00 PM called to order with the pledge of Allegiance. Attendees: Robert Holmes, Walter Rollin, Jed Lamb, Sheila Lanning, Matt Combs, Carl Strekely and Neal Durfey. *Motion* by Holmes with a second by Rollin to approve the minutes of the February 5, 2024 regular scheduled meeting as written. Roll call: three yeas. Checks 10580-10586 and payments totaling \$5,538.73 were approved for payment. *Motion* by Holmes with a second by Rollin to authorize *Resolution 2024-37* amending appropriations as presented. Roll call: three yeas. Lanning: 2023 election expenses are \$434.63 and will be deducted from the first 2024 real property tax settlement.

PUBLIC COMMENTS- none

COMMITTEE REPORTS:

WATER- Lamb: Took care of Rural Water visual inspection of water backflow. Holmes: request an email confirmation of the visual completion.

LORCO- Lamb: getting finances figured out.

AMBULANCE- Holmes: January mileage 3830, no maintenance costs. Ambulance and Fire will be on alert on eclipse date that is 49 days away, discussion on use of Huntington Park for viewing. Lamb: it is a public park, as long as rules are followed there is no issue, use the parking lot and picnic area.

FIRE- Rollin- getting radio's programming done, will be up and running in 30-60 days.

OPWC & SWAC- Combs: No word

CEMETERY- Lanning: provided a graph of costs/revenue and lots available to sell.

ROADS- Combs: getting ready for chip/seal patching. Carl Strekely: thanks for patching the hole by my home. Holmes: no complaints received, two calls on the status of Griggs Road culvert replacement by the County.

SAFETY SERVICE BUILDING- Holmes: contacted grant writing company, waiting on their response.

EQUIPMENT- Combs: took the trucks in for review/repair. The International needs \$6182.82 repair, the Freightliner is good. *Motion* by Holmes with a second by Rollin to authorize \$6,182.82 for International repairs from M&R truck service. Roll call: three yeas. Combs: zero turn is 14 years old, starting to smoke. Lamb: get trade in allowance from Wellington before season starts. Combs: roller starter done, took up to MAC's for repair.

ZONING- Holmes: received resolutions to allow or not Cannabis distribution from Lorain County Township Association and Lorain County Prosecutor's Office. Lamb: would like to hear from constituents before deciding. Rollin: don't want to act upon this tonight.

LCTA- Holmes: 22 Trustees & Fiscal Officers attended and 30 Politicians. Flu report was received, the Directory will be updated, sending it to Sheila for review. Commissioners looking to add a County Permissive Motor Vehicle fee to fund highway and bridge projects. The program next month is MOPEC Gas / Electric Consortium.
