Lamb stated the County is also bench marking for Griggs Road water that floods the road. No other bids for LED light replacement work received. *Motion* by Rollin with a second by Holmes to authorize Lamb Electric to replace 4 wall type fixtures on Township Hall and 2 Flood fixtures at Cemetery flags for \$1560.65. Roll call: 2 yeas, Lamb abstained. Clark Road burglaries. The thieves parked at the cell tower drive rummaged through the stolen items. Szynal stated thieves are about opportunity- lock your cars. Baseball team called and asked if Township could spray in field. Email received and pavilion reserved for May 26<sup>th</sup>. Memorial Day parade, Sheriff will have two cars on Sunday 5/27/18 at noon. Rollin stated he has the preacher, band, people wagon and will call the 4H to ask if they wish to march.
