

ploys an industrial machine handed down from his parents' upholstery studio.

His fabric book of some 100 patterns, ranging through botanicals, stripes and checks, enables customers to redesign their patio look.

His vinyl strap samples include 30 colors and three diameters. He encourages customers to mix colors on a chair. He worked with a customer recently to alternate colors in blocks; each chair was of the same two colors, but the patterns differed from one another.

Most of his customers want a new look, he said. "They like the style of the frame. They may not be wanting to save money, but the fact they can save money doing it, it's a good incentive."

For sling or strap replacement, he charges \$59 for a standard chair. "New, you'd pay \$250, but you wouldn't be getting the selection of fabrics or mixed colors," Dixon said.

A redo includes sanding and recoating of the metal frame. Pick-up, delivery and in-home consultations are free.

He also recoats wicker furniture and reupholsters outdoor seat cushions, using foam fill and sun-tolerant Sunbrella-brand fabric.

Dixon offers occasional discounts for work during the winter months, but said there's no off-season for out-door furniture use or its decline due to the local climate.






