**DRYDEN WATER AUTHORITY
BILL JESSEE ROAD AND MURPHY HOBBS ROAD WATERLINE REPLACEMENT**

Separate sealed Bids for the construction of the **Bill Jessee Road and Murphy Hobbs Road Waterline Replacement** project will be received by Roger Gates, Chairman, at the Dryden Water Authority Administrative Office, 745 Dryden Loop (Carrier), P.O. Box 305 (Mail), Dryden, Virginia 24243 until **2:00 p.m.** local time on **Thursday, September 26, 2019**, at which time the Bids received will be **publicly opened and read aloud**.

The Project consists of the replacement of approximately 5,260 linear feet (lf) of 6-inch waterline, 570 lf of 4-inch waterline, 2,301 lf of 2-inch waterline, six (6) fire hydrants, 21 water service reconNECTIONS, and associated appurtenances.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis. The Project is funded through the **Virginia Department of Health**.

Prospective Bidders may also examine copies of the Bidding Documents provided by the Issuing Office at the locations identified below.

MBE/WBE firms are encouraged to submit bids. Bidders must comply with the following: the President's Executive Order # 11246 prohibiting discrimination in employment regarding race, color, creed, sex, or national origin; the President's Executive Orders # 12138 and 11625 regarding utilization of MBE/WBE firms; the Civil Rights Act of 1964, the Davis-Bacon Act; and Section 436 of P.L. 113-76 American Iron and Steel. Bidders must certify that they do not or will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed, or national origin.

The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at **10:00 a.m.** local time on **Thursday, September 12, 2019** at the Dryden Water Authority Administrative Office, 745 Dryden Loop, Dryden, Virginia 24243. Attendance at the pre-bid conference is highly encouraged; however, it is not mandatory.
