- Physical requirements include: must be able to lift 35# repetitively with full range of motion from the floor to above the head, walking and standing and sitting frequently with frequent stooping (bending at the waist), as well as stretching/reaching and hand/finger dexterity required
- Completion of the Application form and Reference Form
- Driver's license required with ability to drive a 15-passenger van
- Food Handler's Permit is required for participants. (To take the food handler's course, please visit <u>www.foodworkercard.wa.gov</u> and have debit card ready for \$10 fee, which can be reimbursed by the food bank.)
- First Aid Certification is recommended but not required
