Announcements

- We'd like to welcome a new neighbor! Brenda Knop just recently moved in at 5130 Forest Hills Court. If you see her please make sure to welcome her to the neighborhood.
- The Board had voted to change the drive thru by Southern Property
 Management to a monthly schedule rather than the current biweekly schedule.
- The Board has been keeping tabs on the development of the Rood property that is adjacent to our community on the northern side. The Forsyth County Commissioners approved the project in their July meeting. There will be a total of 70 homes of which 12 will be in a gated section, having access to a 12 slip dock on the property. Construction is expected to begin around the first of the year with completion in 2023. At the plan presented to the County Commissioners was the recognition of the easement Bay Colony has on the Rood property for emergency access. That will be kept in place for our use in the future for snow events.
- Ryan Bailey is planning on shutting down the community well water system on or about November 13th. Of course, if Mother Nature gets testy with an early freeze this year the shutdown will have to be sooner.

2021 CAPITAL PROJECTS

- Tennis Court Parking Lot Drainage and sealing
- Pond Dam Repair

The pond dam repair project will be the largest capital project the HOA has undertaken. We are taking extra steps to assure that we are good stewards of the HOA capital funds. This requires a lot of due diligence in the selection of engineering companies to perform the work. Once the right company is found often they are in high demand. Getting them to commit to project schedules has been a difficult task. We're sure you have noticed that supply chain issues are affecting many industries so getting solid schedules is a painstaking process.

Once we have firmed up the cost and schedule for this project we will be proceeding with the other capital projects scheduled for this year.

Reminders

- We are receiving complaints about dogs roaming our neighborhood so please remember that dogs must be on leash when not on your property. Stray dogs will be reported to animal control for pickup. Also it is your responsibility to pick up after your dog when in the community. We also want to remind our homeowners that our bylaws do not allow the ownership of pitbulls.
