- Golf Carts, ATVs, UTVs and other similar vehicles---Drivers must meet all Idaho operating license standards. (Children under 18 yrs of age must wear helmets when a driver or passenger in an ATV/UTV.)
- Golf carts, ATVs, UTVs, motorcycles, trail bikes and other similar vehicles---Should not be operated by children under 16 on the roadways and streets in the LTRV Park unless they have a driving permit or drivers license. Having an adult in the vehicle and an unlicensed/unpermitted child driver is NOT ALLOWED. This is a safety issue.

1. Why is a Non-Disclosure Agreement required to serve on the Election Committee?

We want security of election tally & results until after announcement has been made at the Annual Meeting, therefore one must sign a disclosure to not leak out information.

2. Why are we not having a third party administer the election?

We previously had a management company . In last years Recall Complaint case the judge felt processes were followed accurately and he found no concerns with the way ballots were handled. We think if a court of law can support that process then we think this Election Committee will make the same good process choices. It will be done professionally.

Ride-On Lawnmower: Mary

 The <u>green</u> ride-on lawnmower that was parked and abandoned in the shed was taken to Boise Small Engine for evaluation and repair, if it was economical, was repaired and refurbished for about \$700. We were unable to pay for the repairs and bring the mower back to the park when the bank account was frozen. <u>What happened to it?</u>

A <u>red</u> lawnmower was located and has been returned to the park.
