Chuck Mc Call of Delaware Electric Co-Op gave a presentation on power line safety-

"What would you do if..."

There is a range of voltages within the grid, ranging from 400Kv to 120/240V.

Hazards and potential hazards of home electrical connections. When the system is compromised by the weather or an accident, there is an extreme hazard.

## "If it's not tested, it's not a dead line."

Step Potential – the energy value between the "steps" between the hazard and safety. It depends on conductivity, etc.

Shock: At 0.1 amps, one can sense the electricity. At >0.1 amps, one is in the death zone.

Utility Pole I.D.: Coop's pole numbers are vertical on the pole. Delmarva Power's poles are numbered horizontally.

Consider a broken pole to be energized, and don't take a chance.

If the "system" goes down, and there is minimal or no communication, contingency plans and backup communications need to be considered (Hams, etc.). Those partnerships work well.
