Once again this tax season, there's a lot of information to read on your tax bill. Please don't hesitate to call me if you have questions or concerns about any of it, I'll be happy to help you!

You may still pay your summer 2024 taxes (with interest and late fees) at the township until February 28, 2025. Please call me for the new total. Your winter 2024 taxes are due by February 14, 2025. After the 14th, you may still pay them at the township (with interest and late fees) through February 28, 2025. On March 1, 2025, all taxes must be paid to the Newaygo County Treasurer in White Cloud.

Please include a stamped, self-addressed envelope with your tax payment and I'll be glad to send you a paid receipt. Please make your payment check for the exact amount due. If you have more than one bill, it's OK to combine your payments in one check. Please mail your payment to Sherman Township 2168 South Wisner Fremont MI 49412. You may also drop your payments in the blue mail-box at the side of the township hall driveway. I usually check that box daily.

SUPERVISOR NOTES:

Following adoption of the Fiscal Year 24-25 Township Budget this past March, your Township Board reviewed existing road conditions and contracted with the Newaygo County Road Commission to improve the following road:

24th St From Wisner to Parsons.

Several years ago, the Sherman Township Board applied for an received a certification with the Federal Emergency Management Authority (FEMA) to permit property owners, that could be impacted by flooding, to be eligible to purchase flood insurance from their local insurance company. Most recently, the Township has received up dated flood hazard maps of our jurisdiction, which identifies those properties most prone to potential flooding. NEW SHORT TERM RENTAL OR-DINANCE

If you rent your home or cottage, in Sherman Township for less than 30 days, you fall under the short term rental ordinance that goes into effect on **January 1st, 2023**. You must apply for a yearly permit. The ordinance with rules and regulations, can be found on the Township Website.

Township extensions are available for building permits. Demolition permits are required to demolish any building. You must contact the building inspector for these permits.
