

# HUNTINGTON TOWNSHIP TRUSTEES 45955 STATE ROUTE 162 WELLINGTON OHIO 44090

#### Minutes of December 5, 2022

The Huntington Township Trustees met in a regular scheduled meeting at 7:00 PM with the pledge of Allegiance. Attendees: Walter Rollin, Robert Holmes, Jed Lamb, Sheila Lanning, Matt Combs, Nora Klebow and Frances Rollin. *Motion* by Lamb with a second by Holmes to approve the minutes of November 21st as written. Roll call: three yeas. Checks 10143-10160 and payments totaling \$14,769.51 were approved for payment. Lanning presented the interest received from Star Ohio (30 day yield 3.70%) and Farmers Savings Bank (.025% interest rate) and requested a motion to move \$100,000.00 to Star Ohio. *Motion* by Holmes with a second by Lamb to authorize moving \$100,000.00 from Farmer's Savings to STAR Ohio account. Roll call: 3 yeas. Lanning: Appropriations for 2022 will be amended at the next meeting.

#### **COMMITTEE REPORTS:**

**WATER BOARD-** Lamb: meeting is 12/21/2022

**LORCO-** Lamb: cannot make the Thursday Christmas pot luck meeting. Holmes will try to make the meeting.

**AMBULANCE-** Holmes: training meeting 12/6/2022 and Board meeting 12/13/2022.

SHERIFF- 24 incidents in November

FIRE- Rollin: fish fry Wednesday before Thanksgiving went good, Board meeting is Wednesday.

**OPWC & SWAC-** Lanning: still need the MOU for the SWAC ARP grant for the Stewart Road Culvert. Scoring of OPWC projects received from Wesemeyer. Combs: will call on the MOU. Lamb: I have Carl Wesemeyer phone number.

**ZONING-** Lanning: ZBA meeting for Kenny Knapp variance request is 12/6/2022. Klebow: emailed 12/5/2022 Zoning Report. Visited properties with Lorain County Prosecutor Tom Mangan. Asking Trustees to pass three Resolutions to authorize the LC Prosecutor to take additional steps against 3 violation cases. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2022-45* directing the Lorain County Prosecutor's office to take any and all necessary legal action to compel zoning compliance from Twin Valley LLC (Agent: Frank Jaram) on his/their Baker Road property. Roll call: 3 yeas. *Motion* by Lamb with a second by Holmes to authorize Resolution 2022-46 directing the Lorain County Prosecutor's office to take any and all necessary legal action to compel zoning compliance from William & Elizabeth Kozik on their Hawley Road property. Roll call: 3 yeas. Motion by Holmes with a second by Lamb to authorize Resolution 2022-47 directing the Lorain County Prosecutor's office to take any and all necessary legal action to compel zoning compliance from Anthony & April Reveglia on their West Road Property. Roll call: 3 yeas. Klebow: also texted to Mr. Kittel about getting Zoning permits for additions. Did not see a penalty on the fee schedule when an application for a permit is not received. Discussion by Trustees on adding a fee covering noncompliance of permit applications. Holmes & Lamb asked Zoning Secretary Lanning to ask the Zoning Board their opinion. Klebow: visited the Ukrainian Youth Camp on Bursley Road to discuss rezoning the property to Recreational Commercial from Residential Agricultural. Discussion on State Health Department permits, current status of 24 camper spaces and consideration to add 2 "wilderness" type cabins. State health Department visits the Ukrainian Youth Camp a couple times a year because it is a youth camp. There are advantages and disadvantages to changing their zoning. They are contemplating the effects on their nonprofit organization.

**OFFICE ON AGING-** Thrive collaborative survey is due by 12/31/2022.

**CEMETERY**- Lanning: lot 218 burial of Ronald Sprinkle.

**ROADS-** Combs: cutting trees back on Clark Road. Chipper is running, Nora will look at the old computer for any Zoning information.

**EQUIPMENT-** Combs: the Ohio Cooperative Purchasing site is confusing and doesn't work. Lanning: contact the Fire District they just purchased a truck. Rollin: I will put you in touch with the Fire District on using the State bidding.

The contract with natural gas supplier Direct Energy expires on 1/9/2023, several to choose from and will find out more for next meeting. Lamb: suggest holding a special meeting to do performance evaluation on employees. Holmes: Combs should think about what he wants for a raise. Lamb: set the special meeting for 12/16/2022 at 2:00 PM and go into executive session for personnel. Lanning: will post the special meeting.
