- Furthermore, the undersigned agrees that Tip Top Riding Club, arena owners, and District 6 of the NARC&SP members and officers, shall not be liable or responsible for, and shall be indemnified and held harmless by the undersigned from and against any and all suits, action, losses, damages, claims or liability of any character, type or description, including all expenses of litigation, court costs and attorney's fees, for injury or death to an any person or persons, or animal or property arising out of, or occasioned by, directly or indirectly, the use of the premises and entry into the equine events hosted on this day.
