GENERAL TERMS AND CONDITIONS

RETURNS AND CANCELLATIONS POLICY

The cancellation / refund policy below applies to all purchases made at CAT&COW STUDIO. By placing an order with us or making a purchase you agree to accept the following cancellation / refund policy. If you do not agree to the policy below then you should not make a purchase with CAT&COW STUDIO.

ORDER CANCELLATION / REFUND POLICY

You may cancel your order for up to 1 hour after the transaction. If you cancel within this period, any payments made by you will be refunded within 30 days. Please note an admin fee of £5 will be charged for all returns. If you do not cancel within 1 hour, we will confirm your order. Once confirmed, an order is non-refundable. It may be transferable to another product within the same term at the discretion of Cat&Cow Studio, subject to availability and suitability, but a transfer is not guaranteed. Order cancellations must be made by email to info@catandcowstudio.co.uk.

CLASS CANCELLATION / ACCOUNT CREDIT RETURN POLICY

Classes can only be booked using account credits or via one of the Membership options. Once a class or 6 week course is booked, a credit or 6 credits is deducted from your account. Classes may be cancelled at least **24 hours before the start of the class** via the app by phone 01772 813639 or by email catandcowstudio@gmail.com/info@catandcowstudio.co.uk.

6 Week Beginners Courses may cancelled 72 hours before the start date of a 6 week course by phone 01772 813639 or by email catandcowstudio@gmail.com/info@catandcowstudio.co.uk.

Account credits will only be returned to your account for cancellations within policy. In the event CAT&COW STUDIO needs to cancel a class, we will attempt to contact all clients via email & text message who booked prior to cancellation and will return any credits to clients who booked prior to cancellation. Clients and/or members must ensure that they update their account with the correct contact information.

TEACHER SUBSTITUTION

Teachers may be substituted for another suitably qualified teacher at the discretion of CAT&COW STUDIO. As we are still providing a class with the same content and quality, refunds will not be granted for any reason in the event of Teacher Substitution.

OUR COMMITMENT POLICY

CAT&COW STUDIO commits to holding at least 30 classes per calendar month. CAT&COW STUDIO reserves the right to close the studio for up to two weeks over the Christmas/New Year period and for up to two weeks during the summer. Offering you 48 weeks of classes per year. Extensions will only be granted to clients on Class Passes where classes are not held for more than 3 days consecutively. CAT&COW STUDIO reserves the right to review and change these Terms & Conditions at any time. We will give you 7 days written notice of any changes.

COVID-19 POLICY

In the event that CAT&COW STUDIO is required by law to temporarily close or group classes of 8 clients are not permitted due to Covid-19 restrictions, studio group classes will move online. Should clients not wish to attend online group classes the client must notify CAT&COW STUDIO in writing to info@catandcowstudio.co.uk / catandcowstudio@gmail.com, to freeze their membership providing 30 days notice prior to their next payment. Should clients not wish to attend online group classes Class credits will be frozen from the date of studio / group class closure. Any class / course / session credits frozen will be available to re-activate upon the studio re-opening / group classes resuming for a period of 12 months.

In the event that a staff member or teacher is required to isolate, and an alternative staff member or teacher is not available to teach in studio the class will move online. In the event CAT&COW STUDIO needs to move a class to run online only we will attempt to contact all clients via email & text message who booked the studio class prior to cancellation and will return any credits to clients who booked prior to cancellation. Clients and/or members must ensure that they update their account with the correct contact information.
