Dear Governor Scott,

Please see the enclosed extremely important 40 pg document that I submitted via email to the Manatee County Probate Court on 2.27.18 (and via USPS mail to them a few days earlier) as well as via email to Bradenton Police on 3.1.18 (they had also suggested that I send a copy to the Court). I sent a copy to my attorney at the time there (Trevor Quinlan) via email on 3.2.18 (I am in Miami). There is a long-standing history of retaliation and hostility against me by the University of Miami (UM) in response to my Whistleblower reporting over the years of cancer data manipulations and other illegal acts in direct violation of numerous laws including regarding cancer data collection in Florida. This 40 page document outlines many of these more recent concerns. I am also a 2003 FIU graduate and one of the people who secured a grant for me (Richard Flamm, FWS) has apparently been angry with me for years since (?) This is also discussed in the 40pp att. I tend to believe that it is UM, however, that is behind this horrid timeline of retaliation. This horror escalated after the State (HHS OIG) stopped their investigation into UM stating that they could not do anything (in response) because UM employees were not State employees. UM, it appears, and everyone involved, appears to be protected. For example, I am positive that my boss at UM, Stuart Herna, and the supervisor, Susana Arias-Morales, know A LOT of information in this regard. It appears they have never been questioned. (Arias-Morales told me she had a relative in the FBI and I have yet to receive the first call back from them.) Among others, I have reported to Senator Rubio (some of the many emails enclosed), also to no avail and, disconcertingly, to his seeming looking the other way. It seems he knows something, as well as Flamm, and many others (see letter to Florida Bar, 40pp) -- very, very scary, in particular in light of our democracy, laws, and Constitution. As far as suspicious deaths, after I would complain at work (I have since been retaliatorily fired, described herein as well), my boss would be absent from the office and something horrid would occur, oftentimes an unexpected death of someone I knew (see letter enclosed to law enforcement 17pp att). Also, concerning events followed other particular instances, for example, while I have been handing out my pocket US Consituitions, outlined herein (40pp) as well. These tragedies include the Muslim Judge found in the NY Hudson River, as well as the recent downing of the plane in Costa Rica with a number of Jews from NY and the Tampa area. The recent train crashes in South Carolina and Virginia are also of concern in relation to timelines I know about (all discussed in the att). I have also recently been protesting UM, with signs, at the base of their crossover bridge, over US 1 in Coral Gables.

Also very concerning are the deaths subsequent to, within a number of days, my 40 page reporting of very serious concerns enclosed here. (I have also, within past days, filed legal papers regarding the retaliatory firing from UM.)

These concerning events subsequent to my 40 page report submissions are:
Bombs in Texas 3/2, 3/12 (x2), 3/18 - 2 died

Sightseeing helicopter down in NY 3/11 - 4 died
Naval jet down in Key West 3/14 - 2 died
Military helicopter down in Iraq 3/15 - 7 died
Fire Cresson, Texas 3/15 - unk deceased
Walkover Bridge collapse FIU 3/15 - 6 died

You can also see from the smaller att (17 pages), that email conversations preceding some of these horrific events seem out of place -- strangely, familiarly friendly, when I do not even know the people and the circumstances are actually more (quite) serious. For example, the day prior to my cousin's suspicious death at Bethesda Hospital, Senator Rubio's assistant Alyn Fernandez, knowing of my very serious concern about my cousin (also outlined in the letter to President Obama enclosed 17pp), ends her email, "Have a restful weekend! Cheers!". Also, a legal administrator, who I emailed briefly with regarding a referral, at the beginning of last week, seemed enthusiastic beyond normal, stating, "We'll do all we can on our end to ensure you're in great hands. wishing you all the best with this file." (File was a strange choice of words -- more like a Court file (?) Also, I did not know her and had emailed because I saw her name on the firm's website.) She also said, "Have a great rest of the week" which was "off" for reasons mentioned, and reminded me of the sequence of events that had happened at UM: a complaint (the 40 page document/court filing), the attorney I was referred to was no longer there (people off of work) -- see also emails from the Quinlan firm -- three from there were off (3.8, 3.9, 3.12) -- Trevor would have previously NEVER told me he was "out sick" -- I wouldn't know the difference and he was not that personal. You will also read about the severe hacking of both email and phone, at home and work (email and internet). I absolutely believe that my attorneys also have been under undue influence from some outside source (re: the Florida Bar letter 40pp). Today I also got a seeming hacked email from a Private Investigator I haven't spoken with for probably two years (enclosed 17pp). I have attempted to inform him of my concerns.

These are extremely important concerns and I am glad to answer any of your questions and send further documentation. No one is above the law. However, in these situations, it would appear that high-level acquaintances of UM, be they the State, FBI, and/or Miami-Dade County, and/or quite frankly, CIA (UM is one of the largest and longest CIA University locations), are acting horribly illegally to try to intimidate and to try to scare me, and to retaliate -- against any semblance of their mandate, our legal framework, Constitution, or ethics. This antagonism is beyond counter-productive in any society, and not at all what should be allowed to exist in America. This is too complex (of a seeming conspiracy) for any one entity to be acting on their own, and what I have described is most certainly detailed and deliberate efforts by several entities and/or persons.

Will you be able to open an investigation or otherwise look into these extremely serious concerns? Thank you,

The circumstances regarding what occurred with our side at the mediation were extremely unethical -- please see the copy of some of the emails I sent detailing what occurred (below). We

each (me, Pat, Reva) did not know of the obfuscation (and much worse) until we spoke with each other the next day ... I left messages for Erica but only spoke with her today (since the mediation). She (and I guess Ed) are the only ones who have accepted any money. Apparently Brice is mailing/has mailed out something for the rest of us to sign -- Pat, Reva, and I will not. Reva was extremely upset and was hospitalized with high blood pressure the day or so post the mediation after she found out about the lies Brice told to get us to sign. Mr. Hammersley's office today stated that we need to deal with Brice; I asked them, but do not know if Brice called Mr. Hammersley as was requested (see letter to Brice below).

Also, prior to the mediation Brice kept telling us (since day 1) that we would get a conference number to call in on -- but at about 5 days out from the mediation I called Nancy at Mr. Hammersley's office and she was not even aware that she needed to set that up!!! (Brice, with days to go, also initially sent the main office number to everyone saying that was what we were supposed to use!!!) I did voice those complaints and more to Mr. Hammersley's office in other web/emails (some concerns repeated in the letter below). But -- much worse was yet to come ...

Brice,

It was not up to only me to give you the authorization to continue the negotiations, under any circumstance. There were several other people you were also representing, and needed to know that they continued to be "on board" (or not) at all steps of the negotiations. The settlement amount I was referring to was not only for me but in the ballpark of what I was hoping for the group. You and everyone on our side knew very well that I felt the other side should accept the Will as is. I had stated my reasons for that several times verbally and in writing. I would certainly never agreed to the amount you ended up settling for.

Reva has mentioned to me several material falsehoods she stated she was told by you when confirming the terms of the settlement. Included is the fact that when she learned about my larger amount, and her much smaller amount (the amount smaller also in general and compared to what we had under the Will), she mentioned to you her unhappiness with that amount and that I hadn't yet signed the agreement. I had told her I would not sign until she and the group were all in agreement. According to Reva, you replied to her that that my signing did not matter, that the agreement was as good as done, regardless if I signed or not. You also told me before I signed that Reva was fine with the agreement (she received about xxxxxx) after you had explained to her that Ed was free to spend his money how he wanted and that you also helped with my share because I had helped a lot with the case. As you well know, to have any valid settlement agreement, all parties had to agree to the terms. It was material that I hadn't yet signed -- and Reva, contrary to

what you told me, was not fine with settlement, and disagreed with what you told me you had said to her. Had you not misstated Reva's unhappiness with the agreement, I would not have signed, at least until further discussion with her and/or the group.

As more proof of your pressure on me and the entire group, and of your wish to finish up the case that day, you clearly encouraged that I did not need to be on the phone after you said you would do what you could to pursue my wishes for no less than a 65/35 (%) split for our side. Twice I mentioned that I would stay on the line, but you stated that wasn't necessary. We had been on the line hours already and you seemed to want to relieve me of that stress while assuring your best and ethical efforts towards a resolution acceptable to everyone. You had mentioned at the outset of the mediation that the case could be settled today, or not. You would do what your clients wished. However, towards the end of the day you appeared quite determined to get everyone to sign off that same day, regardless of what you had to tell the individuals for them to agree. I certainly knew that we all needed to approve any settlement. Moreover, I told you twice that I was tired and wanted to read the settlement document over more thoroughly again the next day. It now appears that perhaps much of the approximately 3 hours you took to get back to me with an update (while you were "negotiating") were actually spent writing this document up (?) and not working on the best deal for our side. I believe you called me about 6 after I initially got off of the phone. I was also aware that Ed's "bottom line" was a 50/50 split, per his answer to my question at the mediation. How the negotiations arrived at a settlement of xxxxxxx is currently a mystery to those of us who were not on the phone. (Strange, this is the opposite [35/65], of what I had asked for, and clearly below the "50/50" that Ed had mentioned and that you had used an example of with me on the phone previously. At that time you said that is the amount you thought they were looking for.) It is as though you used that lack of our presence and opinion as a tool against us, and an opportunity to settle for much less than Ed or any of the other Petitioners felt we should. (Everyone in our group knew my opinion that the Will should be accepted as is.) Moreover, I had told you that I would speak to others in the group, although in the past you have told me not to speak with the others. (Yet you also stated that we all must be on board for any agreement to proceed.) There are several more recent letters to Ed, you, and Pat with many serious complaints about your behavior and questionable guidance. I also voiced concerns, among other things, about Ed not responding to my email questions and Reva's calls about his opinion on the case and whether he was told not to speak with me or Reva. There were also calls and emails to mediator Hammersley's office previous to the mediation, in these regards.

Pat xxxxx, an even more elderly participant, told me that she was lead by you to believe that the settlement was a done deal. When you called her you told her an agreement had been arrived at and that her share came out to an amount around xxxxxx (I do not recall exactly the amount she told me). As a client of yours, and elderly and dependent on the guidance of her attorney, it was your obligation to remind Pat that everyone had to agree before any settlement, full disclosure including the amount I would be receiving, and that she had the option to think it over, speak with the others, and/or agree or not.

I do not know what your options are for remedying these awful concerns and issues. I am sure Reva, Pat, and Erica would like to hear of something. Reva and Pat are aware of the contents of this letter and will have a copy, as will Erica and Pat. Please contact them asap. Nancy at Mr. Hammersley's office suggests that you call him today, he is going out of town tomorrow.

First email series (1/2) to Judge Economou in c/o Ms. Carla Neal. This information will be sent via ground mail initially and is for review of concerns regarding the death of Beatrice Van Welde (Manatee County probate) and her brother Ed Sampson and related extremely serious matters. Also included with this mailing is two letters to the Florida Bar (6.8.17 via mail and email - letter, list suspicious deaths; 12.30.17 via mail and email - includes two letters dated 12.11.17). Also included, for further perspective, is my complaint regarding UM to the Joint Commission (7.24.16) and regarding my cousin's suspicious death at Bethesda Hospital (8.14.16), time-lined in hacked emails, illegally held in restraints. My recent timeline of complaints and retaliation at the University of Miami submitted to the HHS OIG, Washington, DC (10.5.17) is also enclosed.

Dear Ms. Neal,

I have concerns about nefarious circumstances regarding the deaths of Beatrice Van Welde and her brother Ed Sampson (as well as others). I am also concerned about this in regards to undue influence on the attorneys, guardian Shirley Vermillion, and the notary of Bea's Will, Melissa Flannery in Ohio. Bea's estate is currently in probate in Manatee County and I am named in her Will. These two emails and the attached 6.8.17 and 12.30.17 letters to the Florida Bar (the latter includes 12.11.17 letters) are quite explanatory regarding the etiology of these concerns. (The list of suspicious deaths is not inclusive.) These emails mention the "LINKS" page on my site ourconstitution.info. That page is temporarily off-line, although the others are active. I note in my emails (email 2/2) to the City of Miami Police, conversations of concern at Pinecrest Market while I have been handing out my US Constitutions. Some of the comments related to politics and disparaging the law are extremely disturbing. The fact is that people have died clearly maliciously (someone I knew was a UM [University of Miami] patient whose death was time-lined with hacked, morbid emails to me, she was also held illegally in restraints which I only knew because UM sent me a training on restraints for the first time in 12 years [I didn't have patient contact in my job], etc.). I feel that this was in retaliation for (and occurred soon after) my complaints about UM to the Joint Commission (includes the threat to me and suspicious cancers in younger women mentioned in other complaints against UM. I had worked at UM abstracting cancer cases and I was threatened by my boss Stuart Herna because I had, "complained about a lot of people"). Deaths have also included very healthy people just not waking up, heart attacks time-lined with certain other events, and other awful occurrences (City of Miami Police has these documents). Several of these instances of concerning deaths followed some specific complaint of mine and some have dates I am familiar with, such as birth dates of family members, including Bea's day of death, on the 18th. (My brother Alan's birthday is December 18th. He is a criminal defense lawyer who has contributed to the firing of one or more FBI agents during the course of his work, the details are unknown to me but likely for unethical and/or illegal activities. Susanna Arias Morales, a supervisor at UM told me pointedly, about 2011, during a lawsuit against UM, that she had a relative in the FBI. Despite the highest levels of hacking, threats, suspicious deaths, etc. reported to the FBI, I have not had one call back from them.) I do have concerns that the FBI is involved maliciously as well in my complaints -- this is not uncommon in their history. Moreover, after my EEOC complaint against UM in April 2009, there were two suspicious deaths of long-time family friends, as outlined in the Florida Bar attachment (6.8.17). One was 1.13.10 (my mother's birth date is the 13th) and this woman's son, who was visiting her, a career Navy officer stationed on submarines, on 12/27/09 (my dad, a retired General Master from the Miami-Dade Court system, has his birth date on the 27th). The son supposedly died of a stroke and the mother out of shock from learning about that. You will also see in the attachment that Senator Rubio, as far as I can tell, did not one thing to try to help the restrained patient although I emailed him prior to her demise (as well as President Obama but that letter arrived after her death). The other letter included is my last correspondence with the Florida Bar (12.30.17); it appears they are also helping to cover this up. Please bear in mind

that phone lines and computers, and contacts, mine as well as other family members, were compromised at the highest of levels, at one point emails disappeared in front of my eyes. This also happened at UM and there is much documentation with IT there (I have copies). Our liberty and democracy clearly appear to be in grave danger, from within. People I have mentioned in these enclosed complaints, know the origins of this horror. The perpetrators are obviously being protected and are clearly high-level workers of some type. Are they perpetrating these crimes on their own or someone else's dime? This is illegality of the highest of magnitudes, in my opinion worse than treason. We cannot allow this type of barbarity to continue and I hope someone will investigate, and hold those responsible, accountable.

In fact, there was never any response from the Boynton Beach City Attorney Cherof, State Attorney Aronberg, or Mayor Grant regarding that time-lined death of the restrained UM patient at Bethesda Hospital East. Even the local Boynton Beach Police were evasive and misleading, stating that an investigation was done although there was no documentation when requested via the City portal. Officer Jeanniton, who took my complaint of concern for the patient, never responded to my follow-up requests. It was after I filed my complaint via phone with him that the patient was illegally put in restraints, later that evening. Another concerning death is Snooty the Manatee, on or about the 21st, also a very familiar date. One of the other circumstances of Ed Sampson's death that I can't help but note in light of this situation, was the date, February 22, which is also Washington's birthday. This is concerning in light of the conversations I have had while handing out my US Constitutions, and the vast seeming disregard for the law and desire to bypass the judicial system. Please read below also for what Bea's guardian Shirley Vermillion had told me about the circumstances of Bea's fall as compared to what the nurse/owner at the home had stated. As further information, UM fired me 6.12.17 after 12 years, and a good evaluation and \$10000 raise, about two weeks after I responded to the evaluation honestly about the threat and what has been going on there. The hostility in part is in retaliation for multiple reportings over the years of manipulations of cancer data to overseeing authorities, and for reporting other retaliation, both in direct violation of State law. As stated, this hostility at UM has been going on a number of years and I recently sent a 174 page complaint to the HHS OIG, time-lining the retaliation and my complaints should you wish to have that. I am sure the State is involved (HHS/OIG), as well as an FWS (State Fish and Wildlife) employee, Richard Flamm, and Susan Markley, prior high-level Miami-Dade County DERM employee. One or more of these entities may have been the hackers of phone and computer. The State did not want to hear my further complaints regarding this State mandated cancer data (manipulations) -- referring me back to UM. I had also emailed Florida IG Boyd and ASAC Martens (in Miami) during this time. *I am sure UM was furious at me for reporting these manipulations to the State OIG. The State OIG closed their investigation into UM's cancer data manipulations about the end of 2014, stating that they could do nothing because UM employees are not State employees. However, the retaliation and deaths escalated further after that. I feel that UM pushed the State to contribute to and escalate this horror and unconstitutional retaliation against me. I feel that both entities are responsible for Bea's, Ed's and the multiple other deaths -- and that many other people I have mentioned were aware, and DID NOTHING. I believe the Florida Bar staff knows this truth. As further important background, the State Tumor Registry, Florida Cancer Data System, (FCDS), is located on UM's medical campus and is manged by, including the hiring and firing of employees, by UM. There are millions of dollars in federal (Centers for Disease Control) funding that are distributed to FCDS via the State Department of Health, FDOH. A State employee told me the State does not want to manage any more facilities, despite the clear conflict of interest currently regarding UM and FCDS. Moreover, my ex-UM manager's wife is a high level employee at FCDS. (I certainly would NOT go to FCDS with my data manipulation complaints.) Richard Flamm and all of those mentioned here know something (or more) about this -- but no one will investigate, or say what the truth is. Flamm is a State employee who I do not feel should be working off of my (our) tax dollars while his role in these very serious concerns is not clear -- it is a factor, for sure. Those at the highest levels of Miami-Dade County and UM (two of the most powerful institutions in our area) I am sure are also hiding the truth -- this is beyond unconstitutional and must be investigated and stopped, with punishment meted.*

I feel my concerns as stated here and in the 2nd email should be brought to the attention of the Court. There is much more documentation with the City of Miami Police, the Joint Commission, DOJ, etc. I am glad to forward any further documentation you request. These particular emails have further important information I also sent to the Southern Poverty Law Center.

I feel that this is concerning enough to request that Judge Economou decide what, if any role these circumstances have in regards to the probate, or what other investigation he may mandate. Obviously, my concerns are extremely serious and I

feel it is important that I share these concerns with the Court. I will add that I also find it strange that the notary, who was so quick to get back to me (even though she was off of work that day), regarding the signing of Bea's Will (the Court has those emails between me and that notary), seems to now be avoiding my attorney despite his numerous calls over the past months. Also, certain other aspects of this case, including certain timing and procedural details, raise my concern for outside, nefarious influence with the attorneys. (On Friday 2.16.18 I spoke with Bradenton attorney Trevor Quinlan and he told me of a specific offer [very small, and to be split] from the other side, including a likely very extensive nondisclosure agreement and said that if I did not take it he would withdraw and give me my deposit money back. He had previously told me, within the past few weeks (confirmed via email), what the process would be regarding settlement offers, and he then asked me how much I wanted to ask for. He said he would present that to other counsel and that I had the option to accept whatever they came back with, or not, and if not, I could continue to pursue the case. I believe discovery was the next action he mentioned.) The DAY PRIOR to this, on Thursday the 15th, my HR attorneys regarding the UM case (Gallup, a Broward firm), decided they did not agree with my position on terms for settlement should a letter be sent to UM (I preferred to go straight to a lawsuit as much correspondence has been had with UM already but they were new on this case and wanted to sent a letter), and they wanted to step out and also refund my deposit. In this case I accepted their offer. I have a strong, extremely serious case against UM and I feel those attorneys were only going to try to settle for some small amount, although they said they were open to a lawsuit if an agreeable settlement wasn't reached. They did not want to state anything specific in the letter to UM, the threat to me, the retaliation, the cancer data manipulations, etc. and were, to me, going easy on UM. (More importantly, I mentioned my idea of the amount of money I wanted to settle and I also stated that I would NOT agree to much of a nondisclosure as there were serious other criminal concerns that I wanted to pursue. They disagreed with both stands.) I felt there has been outside, illegal influence on these HR attorneys, (Gallup) and the prior HR attorneys (Saenz and Anderson), who I had for several years before they stepped off the case when UM fired me, when I needed them the most. Both these HR firms deny speaking with anyone outside of their offices regarding my case, but I do not believe that. I feel there is some outside influence in this case related to Bea now as well.

Please note, regarding some information below, that I had called South Carolina Congressman Gowdy's office on 1.23.18 -- I had estimated a different date in my note below but have confirmed the actual date. Nevertheless, that train crash soon thereafter in South Carolina (2.4.18) and the one days prior in Virginia (1.31.18) are both concerning.

Below are condensed letters conveying some of my concerns that I have submitted over the years to the City of Miami Police and other law enforcement and regulatory agencies. It is retaliation of the worst forms involving the University of Miami and likely the State and Miami-Dade County (at least). I have not yet sent the letter immediately below to Ronnie, at FWS (more about that in the letter below). I am not sure I will, because he never responded to the second letter below and likely would not to this one either. This unconstitutional horror is being covered-up at the highest of levels, including the Florida Bar.

I am a big supporter of the SPLC -- and agree with all the work you have done and all of your concerns. However, sometimes we must look in our "own backyard". Although a registered Democrat, I believe the left is much scarier than the alt-right at this point, and I describe my concerns below. Not the least of my concerns are that these individuals seem to be operating under the cover of legitimate organizations, including the highest levels of law enforcement. This actually is probably not new to you -- but I submit it is much more dangerous and scary than most of us want to imagine. At the end of the day, it is the organizations that are most threatening to our liberties and constitution are the most dangerous. Thanks in large part to your diligence, the alt-right, I do not believe, rises to that level of a threat currently. However, I believe these left leaning people (perhaps Deep State is the best term, maybe anarchists) work in our Intelligence, among other professions, and hence are more of a danger to our democracy and constitution than any other threat in the US currently. President Trump has his flaws, and worse, we all admit, but it seems to me he is more concerned than "the other side" about the usurpation of our democracy by those with power and with unconstitutional and unethical methods and beliefs. George Washington did not even believe in political parties and I agree with him -- we could get rid of them but people would fight losing that power and money. (Regardless, we should do that for the sake of the Country.)

I reference my online site ourconstitution.info below. If you read down a bit from the top of that site LINKS page, under Extrajudicial Killings in the US, I have a long narrative with the first few lines highlighted red. What happened to the white UM patient at Boynton Beach's Bethesda Hospital is unspeakable. I will also say that the two younger women I refer to, now with cancer, are both black. (I sent a complaint to the Joint Commission detailing the retaliation I had been subject to, the role those women had played [I am sure just "following orders" at UM/University of Miami], and my concerns for the etiology of their cancers. I am glad to send that report to you upon request.) I was threatened by my UM manager that something malicious happened at a surgery (elective, pathology negative) -- and am still being followed. I am also forwarding a report I made to the City of Miami Police (one of multiple emails to them). In this email (initially to Ronnie at FWS) I describe a concerning conversation on 4.2.17 at Miami's Pinecrest Market regarding Judge Scalia and Judge Thomas. On 4.12.17, the day after I reported that conversation to the Supreme Court Police (4.11.17), the black New York State Appeals Court Judge Sheila Abdus-Salaam was found dead, floating in the Hudson. She was the country's first female Muslim judge and first African-American woman appointed to the state Court of Appeals. (Some accounts state she had not been a practicing Muslim for many years.) She had marks around her neck, although how long they had been there is unknown. She was last seen on video walking near the river the prior evening. Her family and friends insist it was not a suicide. The papers had also falsely stated that other family members had died of suicide. I have not reported my concerns about this elsewhere but maybe you can do so or investigate this and/or some of my other concerns.

See below for more horror -- we are in a rapid descent due to extremely powerful, antagonistic, unconstitutional forces on our own soil. I am sending this out because people must demand reform of our powerful institutions/universities, intelligence apparatus, etc. -- and they must know about these abominable acts. I am glad to answer any further questions and submit any other documentation you request.

Thank you very much for your important work. Let me know how I can further help.

Hi Ronnie,

I did mention some further very disturbing events in my last email to you (below). Do these concerns rise to the level of something you would investigate? I imagine if not your department, someone at the State (Federal Government?) would want to know about and perhaps look into these things? (There have been other very serious concerns since. I have mentioned some in this longer letter.)

You had asked me on the phone initially if I thought Dr. Flamm was mad that I did not get the brief manatee/boater paper to him -- I answered that I guessed so -- Susan Markley (or someone from the MDC [Miami-Dade County] MPPRC [Manatee Protection Plan Review Committee]) had scratched out the "MS" (degree) on my desk name plate for those meetings (in about 2009). This was after I spoke with Jay Gorzelany at one of the MDPARC meetings (Gorzelany knows Flamm from Tampa). Markley was a bit weird to me, somewhat rude actually on a few occasions during the meetings. After the Committee sunsetted, Markley told me that her students had been taken away from her. She left the County (job) in 2011. While the Committee was meeting I did point out that, in violation of the Ethics rules, some of the members who were land owners on the Miami River were in a position to profit by some of the issues we were voting on, in particular regarding boat docks. However, nothing changed and these same members remained and voted on these and other issues. If you will recall, during my FIU MS research (2003) which was quite extensive, Flamm did receive the over 12,000 Excel boat data entries I cataloged (and the many subcategories within them), these same entries were also recorded in real time and then transcribed by me, and he also received the approximately 300 boater survey results (very detailed, extensive phone survey). I had also submitted three reports to the State and completed my thesis. I have offered several times to discuss any reasonable steps towards a resolution, also stating that this situation could have been handled better by everyone involved.

However, respectfully, in regards to your question about Flamm's level of anger, I think a much more important question is, "Is the vile hostility against me and those around me, that I have reported, including the hackings (phone/email home/work) and other extremely serious concerns, an appropriate response (from anyone for anything)?" Particularly concerning also is the fact that someone (or persons) may be on a taxpayer time-clock (or otherwise acting surreptitiously on someone else's dollars) while doing this illegal and unethical activity. Might Flamm be/have been committing some of these acts while on the FWS time-clock, or using FWS equipment? Markley as a County employee? Jeff Borg (ACLU) who I mentioned to you previously? Borg also has very extensive computer skills and I believe was possibly involved with prior phone/email hacking and for other reasons also, I feel was involved with extensive, ongoing purloining of my mail. These concerns have also been reported in detail to the police and USPS investigations. I do not need to belabor that we are dealing with, for the most part, seeming educated, intelligent people, volunteering/working to (ideally) try to better society, in an education, medical, and/or government forum. For whatever reason (I have mentioned this), I wasn't comfortable with that situation with Flamm at some point back then (2003), and it seems I was more than justified to be. It is also my right to have concerns, proven correct or not. There are a number of insightful, thoughtful, and measured responses Dr. Flamm, as someone in authority and a seeming educator and mentor, might have taken, especially regarding a student. For whatever reason, he apparently has simmered and stewed about this for years? I first contacted you a few months ago after Flamm was (strangely) at the Pinecrest Market here in Miami (he's from the Tampa Bay area). Please recall also that UM and likely the State and Miami-Dade County/Markley (she's also a UM grad) and Borg are also involved with this retaliation, perhaps directly more-so than Flamm. In any event, I am sure Flamm knows about it. Please also recall that the UM cancer data manipulations and the threat to me by my UM manager Stuart Herna (for complaining "about a lot of people"), both of which I reported numerous times before being retaliatorily fired by UM, were both illegal actions under Florida law. However, although the State did initially appear to be concerned, in the end they referred me back to UM for any further complaints. (The one UM Compliance Officer, Jennifer McCafferty, who was very concerned about my complaints and those from other UM employees, was run-off of the UM Medical campus several years ago and has since left the Gables campus and UM altogether.) UM Tumor Registry supervisor Susanna Arias Morales had also pointedly told me that she had a relative in the FBI several years ago -- I have yet to receive the first call back from the FBI despite numerous complaints over the years via their website as well as the DOJ and elected officials. These people I have complained about (I will provide all names if requested, you already have several) should be in prison, and certainly not near students, or working in law enforcement/any tax-payer funded job, or in fields that are established for the betterment of human-kind, such as medicine or education. They should not be in

Intelligence either, as little to no ethics and insight combined with high-tech ability and access, leads to unconstitutionality and worse. Moreover, something is very wrong with a person such as Flamm, his seeming passive-aggressiveness the least of concerns. No one in America should be subject to this hell and it should be stopped, and punishment (and counseling) required for whomever is involved. I am sure people of such intelligence and (literal) years of education can be a big help to other prisoners -- that really is the best solution from a number of perspectives.

In looking up Flamm recently I see that he is a geo-spatial analyst. That is particularly eye-opening in light of the horrid retaliation I have been subject to, and other very serious concerns I have had. He no doubt has high level computer skills, and knows others who do as well. Flamm probably also has the ability to track someone (or have them tracked, or worse) via satellite assistance -- and in fact may do this as part of his job? However, the concerns I have would NOT be part of his job description, are indeed beyond unconstitutional, and need to be investigated. Please recall that I did not know Flamm and Markley much more than by name -- nothing of much importance was ever discussed besides manatee/boat related. I do not know how Flamm ended up at that initial meeting in Miami where I met him, probably in 2000. I assumed then that most of his regular work time at FWS was spent on manatee/boater related research and data collections. If his work (or views/personal activities) entailed anything controversial, concerning, and/or unconstitutional, in my opinion, full-disclosure was necessary and warranted from the outset. It may be that he should not be working with students at all. I am also curious, as I have mentioned, why Flamm was briefly at the Pinecrest Market those weeks ago, hours from home (Tampa Bay area), catching my attention from over 20 feet away, walking right past my table where I was handing out US pocket constitutions, looking straight ahead, and leaving -- not saying a word.

Another strange occurrence happened a few years ago. I had reported to the City of Miami Police some years ago that two military members (a man and woman who said they were from Homestead Base) came to Fairchild Gardens while I was volunteering there. They had long lens cameras and were in uniform. (They said they were bird-watching.) They stopped to speak with me and at the time I thought the conversation became somewhat strange -- somehow having them question my loyalty (they thought Obama was not sending enough troops to the middle-east -- I was concerned about that strategy and for increased deaths and maiming of our soldiers -- they questioned whether I was referring to concern for our troops (versus civilians I guess [which I thought I had made clear and quickly reiterated I was referring to deaths and maiming of our troops] -- very strange incident). In hindsight, I do not think those military visitors to Fairchild were "bird-watching" although I believe they did take photos. When I have been handing out my Constitutions I have also had people stand right in front of me and take head shots, not saying a word. Please recall also that Rebecca Butler had shared photos of people I knew from an event that we both were at (I had gotten her the job at that party). I do not know with whom she shared these photos -- was Flamm one of these? Markley? Arias-Morales? Borg (knew of him from my few ACLU meetings)? I reported Butler to the police -- she had worked at Fairchild at that time referred to above (military personnel) and that is where I initially met her (years prior). Several of those she photographed/videoed at the party (or relations to them) subsequently died very suspiciously, within the year or so, all reported in detail to the City of Miami Police as well as the DOJ. Please recall also that the phone and email hacking of my accounts and of other people I know has been extremely severe with contact lists and emails accessed. The time-lined demise and death in Boynton Beach of the UM patient I knew was via morbid, hacked emails from a contact of mine. These hacked emails had been sent to the FBI with again, not one response. It was the Secret Service who, via phone (not even having copies to view), could tell that the email password had been hacked and that the account had been compromised. (I thought they were phished emails.) I was told to have the person immediately change their password. The FBI could have immediately told me this upon viewing the emails, but again, I never heard from them. Please know also that Butler was listed as a reference on a job application I had submitted (via online) to Baptist Hospital not too long before the Fairchild incident described above. I have little doubt that between the (unethical) communications UM has with other people and medical facilities, and the level of hacking of my emails, etc., that Butler was found out by UM (and/or Flamm, Markley, Borg) to be an acquaintance of mine. Butler I knew casually, from volunteering. She appeared to be in an unhappy relationship but was dependent due to her boyfriend owning the home. She had no substantive income herself and after leaving Fairchild was attempting to gain income from her artwork. She has tried to contact me since I have had concerns about her, despite my requests (verbal and email) to her, not to. I have reported her several times to law enforcement. Another extremely concerning event regarding Borg and Fairchild was reported to the City of Miami Police -- Borg was at Fairchild one day a couple of years ago while I was volunteering on a tram-ride with the children. I had recently been at an ACLU meeting (I will never go back), and Borg heard me say that I was a volunteer at Fairchild. I believe it was that next weekend that Borg was in the strangest pose as the tram came around the corner. He was sitting

at a lunch table, turned away from the table, staring up at the morning sun, in a strong, deliberate pose, similar to a pose for a statute. It was a planned position, directly in my line of sight. That was the first and last time I had ever seen him at Fairchild. (I don't recall ever seeing him again since.) He is beyond scary and I have since learned that the ACLU has been known to be a cover for the CIA. That I believe -- I also know, however, that no one is above the law.

Our society is concerning for an evolving "police-state": certain people, not necessarily only law enforcement, but also those with high-level tech skills, feel they are "entitled" to act with impunity against others, as though they (the perpetrators) are above-the-law -- very dangerous in any society and certainly antithetical to our American Constitution and foundation. However, it would also appear that Flamm (and UM, State, MDC, FBI, Markley, Borg, etc.) feel that others (their targets), are beneath the law. Since I entered a bit more information on my website (ourconstitution.info) recently (1.30.17) regarding my concerns specifically about Flamm and Markley, (Borg had already been listed), horrid events have happened. (The next day the plane went down in Costa Rica with two medical doctors and their children from the Tampa Bay area, as well as a New York family, all deceased. They also happened to be Jewish, as Flamm and Markley [and Borg?] are). I consider the activities I am concerned about and have conveyed to you and law enforcement to be the most egregious imaginable, worse than treason. As a Florida resident, US taxpayer and citizen (helping to pay Flamm's salary), I am requesting an investigation into Flamm in these regards, and regarding what he knows.

Flamm also has affiliations with the University of South Florida, another extremely worrisome fact. Because my complaints are so concerning and involve Jews (and non-Jews), being Jewish, I have also reached out to members of the Jewish community within the past few months. Flamm had mentioned he was Jewish those years ago. A recent online link to him states he is now Christian (?) Regardless, I know these vile, hostile, and retaliatory actions are considered despicable by all mainstream religions and even by those who are non-religious. Clearly, this Country has devolved dangerously far from the humanity that our laws dictate and that I am sure most Americans aspire to. Please let me know if you will investigate in light of my further concerns here and below. I am glad to provide more specific details. I am sure Flamm knows much information, if not an instigator or perpetrator himself. As I told you, if I had the research to do over again, I would have stayed with strictly FIU faculty. In hindsight, it seems university professors have a certain level of compassion, insight, and understanding -- I guess they have to where students are concerned. They are also vetted for their particular work and that is very important -- it is not for everyone.

Further concerning, as mentioned previously and below, I believe the deaths of Beatrice Van Welde in Bradenton and her brother, Ed Sampson who passed in February of 2017 in South Carolina, as well as the extremely strange death of Bradenton's Snooty the beloved manatee, should also be investigated further. I am in Bea's will for a small amount but it would seem some entity is trying to circumvent that. Her brother, had he survived her, would likely not have contested the will. However, his children now are (despite the fact that they were estranged from Bea and even left her name off of her brother/their dad Ed's obituary although they mentioned their other brother). Ed was seemingly healthier than Bea but passed 2.22.17, of a heart attack (at 95 years old)? Moreover, the killing of the famous large tusker Satao II (in Kenya) last year in March, shortly after my Florida driver's license renewal in December 2016 (when I wore my Satao shirt and it was in the photo [entire photo is on file]), is also concerning -- that elephant had been around for 50 or more years. The tusks had not been taken. That was also quite a contentious time at UM and involved reporting Arias Morales' friend and recent hire (Monica Olivas), about February 2017 (to Herna), for her extremely poor abstracting skills and likely falsely "held" CTR credential. It is unlikely she would have been able to pass the test. I was fired a few months later.

Last week (2.2.18) I called Congressman Trey Gowdy's office in South Carolina voicing my concerns regarding FBI bias, after seeing his concerns about the same in the media. (Please recall Arias Morales stated she had a relative in the FBI and I have yet to receive the first call from them. There is also a lot of documentation over the years regarding illegal activities of the intel agencies.) I stated to Mr. Gowdy's staff that not only should partisan or biased FBI agents be removed from a particular case, but I feel removed from the FBI entirely. I gave my website link to them. There are very good agents in our law enforcement and intelligence, to be sure. However, those who would participate in a case while having biases that might affect their investigation, should not be in these types of jobs. The next day, 2.3.18, this past Saturday, I protested UM (Whistleblower related) and the need for reform of the CIA, FBI, and NSA with two signs on US 1 across from UM. (UM has a long and active CIA affiliation which frankly, after what I have been through, is no surprise.

The CIA is, however, per their mandate, not supposed to be operating in the US.) Concerningly, the Amtrak train that crashed early Sunday, that next morning (2.4.18), in South Carolina, was diverted to a side track after a railroad switch was locked in the wrong position, sending the train off the main line. That is being investigated. There was another empty train parked on the diverted path, causing the crash. A week or so prior, an Amtrak train carrying GOP lawmakers to their annual retreat in West Virginia hit a garbage truck outside Crozet, Va. People were killed in both accidents.

We should not have to have these types of concerns about retaliation, suspicious deaths, etc. (You have the list of some of the other concerning deaths and the City of Miami Police have even more information.) We have to increase our diligence and investigations to rule out malicious activity; like Herna said when he threatened my life, "you have to prove it" -- and we have to be able to do that. These events I mention, if malicious, are a disgrace on our law enforcement and intelligence community -- these types of malicious acts obviously entail surveillance and a lot of privileged data. That is why, among other reasons, we need reform of these agencies (there are multitudes of other verified examples of retaliation and "stirring things up" by these agencies). I will also note that concerning "theories" I one time would have paid no mind to, are seeming much more real. It appears to me that the people I have mentioned, who I believe have first-hand knowledge about my complaints, are likely all Democrats, including many at UM. (I am a registered Democrat.) Moreover, I do now believe that the multitude of concerning deaths of people who know the Clintons (over 100 it seems), for example, including Seth Rich, were indeed malicious, relatively easy to achieve in terms of getting someone "out of the picture", and vile attempts to void any potential threats against, and uphold power for, those in the Democratic party and their related ideals. Of course, I have reported UM many times and I am sure they take issue with that under some absurd rationality, and do seem to break the law with impunity, not only in my department, but I know this occurs in the hospital (UMH/University of Miami) Compliance department as well. Perhaps Markley was very upset the students were taken from her, although she did not appear upset when she told me. Perhaps Flamm was mad about the paper and possibly the fact that the students were taken away from Markley. I know they all communicated and that UM also knew I was on the MDC MPPRC. UM knows ACLU staff, and perhaps Markley/Flamm knew Borg personally or are even members of the ACLU themselves? This seems to be quite an active group that, over time, has taken it upon themselves to be the "people's judge, jury, and executioner". I think it is time those guilty of such crimes are arrested. There is much concern throughout the nation regarding these suspicious deaths, and that is warranted, and it is time someone took these concerns seriously and found links between contacts, emails, etc. The government knows who its trained killers are (for "sanctioned work"), and if involved in illegal acts need to be stopped and in prison. It would appear that many are using the cover of our legitimate organizations -- FBI, CIA, FWS, ACLU, universities, etc. Clearly, this is not legal and such actions are indeed beyond unconstitutional. Again, I believe Flamm has much more information and am requesting further investigation.

Hi Ronnie,

Sorry about this somewhat lengthy letter, but I have very serious concerns as you know, and some I had failed to mention to you. My concerns also, that I forgot to stress to you previously in light of the serious, more immediate issues, were of very high-level hacking of my home and work computer as well as of my personal "smart" phone and wireless home security camera. You perhaps recall reading about this in the emails to the City of Miami Police I had sent you (enclosed again here). Hacked emails have included those from Dr. Flamm. As a brief history in this regards, in 2011, after discussion with my professors, I had contacted Dr. Flamm via phone about submitting a paper from my boater data (the last time I had spoken with him was about 2003). In emails after that 2011 conversation, Dr. Flamm replied that he was not interested in doing a paper because there were two speed zones at the area of my research (which there had always

been). At some point thereafter, when the high-level hacking was extremely pervasive, I checked those emails and that email response regarding the two speed zones had been altered to show Dr. Flamm agreeing with my writing the paper. I did email my hacking concerns to overseeing organizations, including to UM IT, the State OIG/Attorneys, and the FBI (via their on-line link and email to Senator's Nelson and Rubio). I am glad to forward you any of those complaints. UM was supposedly looking into my UM IT complaints, but in my opinion, that was just to pacify me; it would appear they were allowing this to go on (if not actually perpetrating some/all of these crimes) -- they had much evidence and information available to them for tracking the perpetrators... Moreover, as I have also reported to numerous authorities, the very suspicious death of Joan Myers at Boynton Beach's Bethesda Hospital East, after my reporting UM to the Joint Commission, was time-lined in morbid, hacked emails addressed to me. (Joan was absolutely not at death's door and somehow also apparently developed the blood cancer myeloma while she was in the hospital. People live for years with myeloma.) My UM reporting included the threat to my life by Tumor Registry manager Stuart Herna as well as two younger women mentioned in my related retaliation complaints of deliberately rerouted printing and falsely started abstracting code renewal exam, both having developed cancer. I never received one call from the FBI although I did send them detailed information regarding my complaints. (As I have mentioned, a UM Tumor Registry supervisor, Susana Arias Morales, stated pointedly to me a few years ago that she had a relative in the FBI. One of the UM IT staff, Diane Rubin, had been very helpful to me regarding the hacking, missing emails, etc. After I reported her to the FBI as a contact who could give them more information, along with some of the hacking documentation, Rubin never communicated with me again.)

As was also mentioned in my emails to the City of Miami Police, I am still reporting complaints regarding UM. This includes the data manipulations in direct violation of Florida Law; illegal, hostile retaliation; their attorney who facilitated the firing, Aileen Ugalde; and concerning events including regarding specific people I have complained about. I am still receiving concerning emails as you are aware. I have no doubt that some of the people whose names I have previously mentioned as knowledgeable about this severe retaliation, know the source of this hacking (and of other related malicious acts). Dr. Flamm's acquaintance here when I first met him, Dr. Susan Markley, was also a UM graduate as well as Miami-Dade County DERM employee when I knew her (casually, from occasional meetings -- she told me after the Manatee Protection Plan Review Committee sunsetted [about 2010] that the students had been taken away from her). This retaliation against me has no doubt consumed a lot of time of several people at the least. These people are presumably on the time clock of some business and/or government entity, perpetrating this illegitimate and unconstitutional use of that money and/or taxpayer dollars. Again, I feel that Dr. Flamm has at least knowledge about this, if not direct involvement with perpetrating one or more of these acts I have mentioned. I am requesting that you please investigate these further illegal and extremely serious concerns including phone and email hacking. I have much documentation and will be glad to forward anything you request.

As I have also mentioned previously, I did not feel comfortable with the situation between Dr. Flamm and my major professor and felt there may have been some problem between them. I love to write and was looking forward to getting him his brief paper. Please recall that I had never heard from Dr. Flamm since about 2003 until I called him in 2011 (when he declined a paper due to two speed zones). I have also written that I felt that situation could have been handled better by everyone involved. I also offered to discuss any reasonable resolution. I did do a lot of work, above and beyond the degree requirement, and Dr. Flamm has all of this extensive data. I have expressed that I was glad to help out the State -- and am still paying back my school loan. I also stated that I did not know how Dr. Flamm came attend that Miami meeting (where I met him), and I do not know how well he knew Dr. Markley. I know them both casually from a few encounters; I do not know their politics, prejudices, philosophies on anything, view of the law, the US Constitution, etc. I mentioned that Dr. Markley had crossed out the MS [degree] on my desktop name-placard for the Miami-Dade County Manatee Protection Plan Review Committee. I had spoken with Jay Gorzelany at one of those meetings -- he knew Dr. Flamm and lived in that same (Tampa) area I believe. I hope the State appreciated my hard work. I was the person who began tape recording the boater observations -- Dr. Flamm initially said I had to stick with the two-person, student assisted verbal collection methodology. Unfortunately, these high school students would often not show up on the weekend and I had to figure out a way to enter the data on my own. After I showed Dr. Flamm what I was doing, this methodology (also using a transcription machine) was continued in other studies throughout the State. As you know, I supplied the State with over 12,000 boater entries including numerous categories within each, and a comprehensive phone survey of about 300 of these boaters on manatee related issues. I also submitted three reports to the State during this process as well as wrote a thesis (besides required classwork). I was told this extensive work was actually applicable



towards a PhD, however, FIU did not offer this degree in my department at the time.

You had mentioned to me that you had not spoken with Dr. Flamm about my concerns (the hacking, suspicious deaths, my sighting of Dr. Flamm at Pinecrest Market, etc.). It would appear to me that he does know something about my concerns, at the least. No one is above the law, an especially important ethic for those charged with enforcing it and overseeing civil liberties, and/or having any kind of power over another. No one is beneath the law either. Respectfully, I think it is important that you find out from Dr. Flamm what, if anything, he knows regarding my concerns. I think it is not possible, in light of his "visit" to Miami, that he knows nothing. If he is indeed involved in or has knowledge of this horrid retaliation, he is operating outside the bounds of Our Constitution and laws. He should, in this case, not be working for the government or taxpayer funded agency, let alone in any law enforcement or teaching capacity. It may be that he should be in jail. That is no doubt the case for several UM employees. I am appreciative for Dr. Flamm's efforts in the environmental field and his assistance to me, but if my concerns regarding him are true, the rest does not matter.

Please recall also my concerns regarding the strange death of Snooty the Manatee in Bradenton, and the concerning death of a long-time family friend, Beatrice Van Welde, also in Bradenton. Her representative, Shirley (Ricky) Vermillion, had said Bea was found on the floor in the middle of the night, in the dark, yelling out, while her caretaker (nurse) at the home Bea was recently moved to said she fell off of her chair (next to her bed) while waiting to be brought to breakfast, about 8am. The nurse fully expected her to return to the facility (which she never did, dying in the hospital). Bea's brother Ed Sampson (South Carolina) had predeceased her in February 2017, which was unexpected. Although elderly, he was in good health, probably better than Bea, but had a heart attack at 95? HE was found on the floor about 6am in the morning ... Now his children are going after his part of Bea's will, although she had been estranged from them for years (Bea was not even mentioned in her brother's obituary, although the other brother was mentioned). I was down for a small part of her will, as were her closest friends in life -- but now the brother's heirs are contesting the whole thing ... Very concerning to me (the circumstances, regardless of whether I was in the will or not). ... As you know, my email and phone as well as other family member's email and phones have been hacked, and contacts and emails seen and maliciously used (as well as other types of hacking of my phone and emails home/work). There was also another concerning death on the day I first spoke with you, November 14, 2017.

Again, I hope you will look into this further. Please let me know of any other documentation or information you would like.

Dear Ronnie (as you requested me to address you),

Thank you for your phone response last week. You had mentioned reaching me today and I just wanted to let you know that my phone (786-585-4769) had not been working for some reason today, but seems ok now. My other number, in case, is 305-674-1645.

I had made a few notes about our initial conversation, listed below.

--How I met Richard Flamm -- a meeting at the Miami-Dade County MAG group as I recall (Manatee Action Group) -- I believe he knew Susan Markley, a (now former) DERM employee. I do not know exactly how he came to know about and attend that meeting. I guess it was about 2001.

--Met with Flamm during a few subsequent visits for boat data collection (three times I am sure probably 2001-02), other than boat data/related conversation, nothing of substance discussed

--I knew Flamm collected boat data, don't know much else about him

--I saw Flamm recently at the Pinecrest Market in Miami as I had written, he didn't say anything to me. I had not seen him since about 2002, during the boat data collection. Larry Schokman had a "heart attack" that same day, at lunch.

--The State didn't want to hear more of my complaints about UM cancer data manipulations, which, besides unethical, were also in direct violation of Florida Statutes, and referred me back to UM (which also didn't want to know about the manipulations). UM also denied the 2016 threat to me by manager Stuart Herna [because I had "complained about a lot of people", this threat also in violation of Florida law. Dr. Jennifer McCafferty, the UM Compliance Chair in 2012, was concerned about my and other UM employee complaints but was run off (in duress) of the UM Medical campus, went to UM Gables, and then left there. Her investigation of my complaints found "irregularities" and she was going to show me the report but then she was not allowed to. Besides the falsified follow-up, I have subsequently reported cancer cases deliberately left undone. (The State requires ALL cancer cases and treatments to be reported within 6 months.)

--Hacked emails time-lining Joan Myers' Boynton Beach/Bethesda Hospital East death in August 2016 after I had reported UM and Memorial Sloan Kettering Hospitals to the Joint Commission (re: threat to me and concerning cases of cancer in two younger female co-workers mentioned in my reporting) -- I have the source documents of those morbid, hacked emails. Her main nurse was "Amy", Officer Jeanniton (Boynton Beach) took my report about concern for her safety, but my attempts to follow-up have been to no avail. Joan was also illegally held in restraints. I know this because UM, earlier this year (2017), sent me, for the first time, a training on restraints, although I have no patient contact (dealing only with charts and the computer). More horrid harassment on the part of UM -- I do not know how much Flamm knows of this but I am positive he has some (or more) information on the horror that has transpired and that I have written you and the police about. (I will be glad to forward any other emails, documentation, etc.)

--I believe Flamm has **information about and/or involvement in** the horrific concerns as attached (you had read) including high-level hacking home/work phones, emails; suspicious deaths of people [as in my letter, not an inclusive listing]; and/or the demise of Snooty the Bradenton beloved manatee (and concerning circumstances surrounding the death of Beatrice Van Welde from Bradenton), etc.

Also:

--On my renewal license for my Florida Driver's license, I had to retake my photo this year and had my Satao shirt on (and a lot of sunscreen--was going to the Zoo from there and didn't realize I had to renew my photo) -- It was very weird to me that not long thereafter, the beloved African elephant Satao II was killed ... That can be read on Google ... That may indeed be one of the strangest "coincidences" -- the elephant had been around for years -- but the timing of my many other serious concerns, I am sure, are not coincidences.

--As mentioned, the people I have mentioned (see att -- includes but NOT limited to: Flamm, Markley, Herna, Arias Morlaes, Jeff Borg [ACLU], Kristin Wipier [Democrats of South Dade], Rebecca Butler [artist/prior acquaintance], UM doctors/admin, etc.) would be able to tell you much more information, especially if they were scared of being charged as an accessory/accomplice. To the best of my knowledge, no one has cross-checked those people's work/home/cell phones and emails for communications.

Thank you again. You told me yesterday that you would update me, and that everything is confidential at this point.

When I was handing out the pocket Constitutions at the Miami Book Fair on 5th Street and 2nd Avenue (on the sidewalk) there was a white woman with dark, shoulder length hair, there on Sunday, 11.19.17, standing behind me near the pole by 5th St. She was there for quite a while, with a Smart phone in her hand. When I would look back she would stare at me with a scowl on her face. Sometimes she was looking at her phone. The City police officer was parked a few feet away and was inside the car. I do not think that she realized he was in there -- he could not be seen as it was very sunny and the windows dark. After a while, I guess this woman had been standing there an hour or more, the officer (who I had chatted with briefly Saturday and Sunday), got out of his car and went around to the other side (by the passenger door, probably lateral to her) and seemed to give her a "look", and she left almost immediately. She crossed 2nd Ave (going to the Bay) and seemed to stop on that other corner briefly. When I looked again for her, she was gone. I put my Smart phone around my neck and wished I had thought to take her photo. I didn't say anything to the officer about that at the time. Before I left I decided to mention that to him but there was a different officer there at closing.

I also spoke with FWS Ronnie Austin maybe an hour or so ago (today), and he is not going to investigate Flamm with the information he has. He said Flamm was not under investigation by the Police. I did not expect that that would be the case since Schokman was cremated and it seems his death was not deemed suspicious by those around him. I told Ronnie that most concerning, regarding what I KNEW, was the fact that Flamm was at the Pinecrest market, briefly, hours from home, not saying a word (discussed below) -- I hope Schokman's death was natural but the timing again, and cause

of death, are concerning. I also reiterated to Ronnie (he asked that I call him by that name), that although I know UM (manager Stuart Herna) threatened me, among many other hostile acts, and did not like my reporting of their cancer data manipulations/cases deliberately left undone/nurse copying unique tumor board patient data from one patient to the next/falsification of follow-up, etc, as well as the State also showing disinterest, referring me back to UM -- I cannot say that Flamm has had no role (or a large role) in this retaliation. Also, the retaliation further increased AFTER the State OIG closed the UM investigation (saying they couldn't do anything against the employees because they were not State employees). There was a State plan to audit UM as well, but that was cancelled for reasons unknown to me. I reiterated to Ronnie that the MS (degree) was crossed out on my name plate at the Manatee Protection Plan Review Committee (MPPRC) in 2009, six years after I graduated from FIU. Susan Markley (DERM) did not do that on her own -- she wanted me on the Committee initially. However, at some point after I saw and spoke with Jay Gorzelany (from Tampa - knows Flamm - Gorzelany was a speaker at a MPPRC meeting), the MS was crossed out on my name desk marker and Markley seemed to be going after me with digs/comments at the meetings. (See/hear this on tapes of the meetings.) Markley conveyed to me after the Committee had sunsetted that the students were taken away from her. I had asked her during the meetings if there were any problems and she denied this. Please recall that I also had voiced my concern at one of the meetings that many on the Committee could profit by some of our rulings. For example, we voted on issues related to boat docks and there were several owners of property along the Miami River on that Committee (who remained on the Committee and voted). This seemed to me in violation of the Committee ethics requirements.

Again, I have offered any reasonable compensation for not getting Flamm his brief paper. However, he did get the massive amounts of data I had collected (over 12,000 boater entries and several data items about each, recorded in real time) and then entered in Excel as well as the phone survey results of about 300 of these boaters. There were three reports submitted to the State and a thesis as well as my required classes. I conveyed to Ronnie that I hope the State is using this important data. Ronnie suggested that I could sue UM for the firing and retaliation, which I can. However, I told him that I think it is important, as a taxpayer, that someone working for the State be "above board" when it comes to matters such as this. Moreover, there should be no question as to Flamm's role, if any, in all of this. I have said that as far as I know, no one has cross-checked phone calls and emails of the people that I have mentioned, whom I know have information about and/or have participated in this vile retaliation. I told Ronnie that even the Florida Bar was trying to obfuscate UM Attorney Aileen Ugalde's role in facilitating this retaliation (a reason they gave for firing me was false); I never got one email or call back from her. The Bar is doing all it can to evade taking action on any of my complaints against Ugalde and other attorneys. (City Attorney Cherof never gave me the first call back re: Joan Myer's demise at Bethesda Hospital East. I was told there had been an investigation but no documents were provided via channels told to me.) So, there seems to be a massive cover-up regarding this hell, with agencies that could assist in getting to the bottom of this -- short of further tying up our over-burdened Court system, clearly the least efficient way to learn more about this -- refusing to help in the most basic of ways. UM deserves to be sued for the retaliatory firing, but that also does not necessarily help answer the questions I have detailed here and in other documentation.

Please see more concerning events below. My reporting, including this email, is NOT inclusive of all my concerns including for suspicious deaths.

Thank you for your concern Ronnie. I do however feel that Dr. Flamm has knowledge (at least) of the severe hostility I have been subject to and my other concerns as written to you and other law enforcement. (Even the work/home phone/email hacking is illegal. There was much documentation presented to UM and law enforcement for that as well.) In actuality, it would probably be difficult for law enforcement alone to know if a death was "high-level" lethality --

meant to be disguised as natural. Someone committing murder in this way would likely be aware of any cameras as well. Of course, if the body was cremated, as in the case of Mr. Schokman, even the medical examiner could make no further assessment. Joan Myers, deceased at Boynton Beach, Bethesda Hospital East, who I have previously mentioned, also apparently was cremated. There are, however, several other factors regarding Joan's death, beyond the morbid, hacked emails time-lining her demise, that point to homicide. Like the people who died of heat exposure at the Hollywood nursing home during Hurricane Irma, now ruled as murders, Joan was meant to live longer.

The fact that Dr. Flamm was at Pinecrest Market in Miami for the briefest amount of time, as I have described, (I am very sure it was him), hours away from his home, deliberately standing in my line of sight, not saying a word, is beyond suspicious and concerning behavior. I am quite sure an audit of email/phone contacts of those I have previously mentioned would show some patterns/connections. I have requested this of law enforcement several times. Did you or your office communicate with Dr. Flamm?

I am requesting as well that you please advise me if you learn of any other information regarding my complaints. No one is above the law or Our Constitution, (or beneath it), and such blatant defilement of our laws, here on our soil, is the highest of crimes, and, most dangerous to our republic. I will say that I have talked with people, while handing out the Constitutions, who seemingly feel the laws don't apply to them, that justice is slow and/or unfair, and hence, they feel justified in taking "justice" into their own hands. I have had related scenarios told to me, including the strong implication that in at least one instance, lethal, extrajudicial revenge had been taken against a defendant. In this case (conveyed to me at Pinecrest), this was in response to disagreement with a court judgement regarding the release of a person accused of murder. Clearly, some would argue that due process is the most important of our rights. There are innumerable legal findings, including judgements of guilt overturned, etc., that would support that stature. I know I do not need to elaborate to you how scary and unsafe society becomes -- for everyone, all ages, and in all walks and professions, when people act as though they are above the law, and that others are beneath it. Realizing more recently that Dr. Flamm might think differently is of extreme concern, especially in light of his work related to law enforcement, his authority over others, and in my case, contact with and authority over students. As I told you, I knew Dr. Flamm collected and analyzed boater, manatee, speed zone, and related data. I do not even know if he had law enforcement authority but imagine so. I do not know that he did anything else more controversial than that, and the idea didn't cross my mind at the time. You may be aware of my fairly recent website that warns of the dangers of the rise of the "military-industrial complex" versus our liberty, as stated by President Eisenhower. Today it is likely that President Eisenhower would have added the term "technological" to that "complex". There is also increasing concern that intelligence related agencies are infused in our colleges, in some cases covertly. This is all the more concerning because of the, at a minimum, questionable, but often illegal, practices of these agencies. I, I am sure, along with Eisenhower and many others, would not and do not agree with the level and type of intelligence related efforts in academia (and elsewhere). I am a firm believer in the full rights and humanity Our Constitution conveys and strives for. A strong military is different than concerns for an evolving police state.

I was speaking briefly with another person at Pinecrest while handing out the Constitutions on April 2, 2017. I mentioned my concern that Justice Scalia's death was not natural. This person immediately responded, "Maybe the same thing will happen to Clarence Thomas. He's big and fat also." She then got a phone call and walked away. I don't think I ever saw her before or since that incident (same as with Flamm--I last saw him probably in 2002, regarding the boat data collection). I did report her comment on April 11, 2017 via phone (786-585-4769) about 11:15am to the Secret Service (Miami) who referred me to police at the US Supreme Court, whom I also called shortly thereafter. When I reported this to police at the Supreme Court offices, the woman who answered the phone then asked me, "Did [the person I was speaking with at Pinecrest] say [Scalia] died of a heart attack?" ... I said "no" and repeated what the person had said to me (quoted above). Quite the strange response from her any way you look at it ... I called the Supreme Court Police back right after that call and requested and spoke with a police supervisor (a male). I repeated my concerns about the Pinecrest conversation, also mentioning the woman's response in the initial phone call to that office immediately prior. After this complaint of mine there were further very concerning events, soon thereafter, that I have notated elsewhere. Please recall that UM Tumor Registry Manager Stuart Herna threatened my life, stating that I had, "complained about a lot of people".

I will also add that subsequent to my reporting to you, my parents, on 11.21.17, received a very concerning phone call

from a number in Philadelphia, 215-523-6756. Also alarming is the fact that on an online search, this number appears to be inactive. On calling it numerous times, it has rung as busy. Details have been reported to authorities. I am glad to give you further information should you request it -- that timing is more than curious as well.

Thank you again. I hope you reconsider further investigating my concerns. I am greatly appreciative of your interest and time.

Documents re: Whistleblower Protection for retaliatory firing

Retaliatory firing by the University of Miami in direct violation of Florida Statute 448.102 for reporting cancer data manipulations in direct violation of Florida Statute 385.202 and for reporting manager Stuart Herna's threat to my life in direct violation of Florida Statute 448.045.

Our State overseeing Tumor Registry, the Florida Cancer Data System (FCDS), is managed by UM and is located at UM's Medical Campus. UM hires and fires those employees. Manager Herna's wife, Megsys, is a high-level data manager at FCDS. Hence, UM oversees its own data and I did not feel comfortable voicing my concerns with FCDS. The State is not interested in making FCDS a stand-alone facility, which I had suggested to them. FCDS is largely funded with grants from the Centers for Disease Control (CDC). The National Program for Cancer Registries (NPCR) and American Cancer Society (ACS) help manage the National Cancer Data Base (NCDB), where this cancer data is housed. UM also receives millions in federal dollars otherwise.

Brief overview:

I have made numerous complaints to authorities over the years regarding cancer data manipulations I was either told to do, told about by someone else, or discovered myself. I refused to take part in any practices other than as mandated per our credentialing guidelines. Our credential is the Certified Tumor Registrar (CTR), which I earned by exam in 2009. More recent complaints include cancer data manipulation and severe retaliation reported (to the DOJ) days before I was threatened last year (2016). I also reported again to the DOJ and other overseeing organizations days before I was fired (6.12.17). Moreover, this firing was within two weeks of my responding truthfully to a good evaluation that I signed off on dated 5.31.17 (for 2016) and a \$10,000 raise. My evaluation response, submitted to UM HR, UM Equity/Compliance, and Manager Herna, detailed the threat to my life, by Mr. Herna, because I had (his words), "complained about a lot of people". I have also specifically been told by Mr. Herna in the past that, at UM, "we do not mention people's names" (exactly this phrase or very similar). The evaluation response also included excerpts from my Joint Commission complaint regarding that threat as well as my complaints of cancer data manipulations, both actions in direct violation of State law. All of these documents as well as many others are enclosed. The seeming substantive reason UM gave for the firing, that I hadn't attended a meeting, was proved false by emails (enclosed) stating

that the meeting was recommended, not mandatory. Recently hired UM President Frenk had also been notified of Mr. Herna's threat and the cancer data manipulations last year (letters enclosed). Many of these complaints have more documents associated with them should you want more information. There is much more information available than I have enclosed here; my reporting in this complaint is not inclusive of all my reporting or documentation, including of cancer data manipulations and retaliation.

My name is Judith Futerfas. I am a Senior Tumor Registrar at the University of Miami (UM). I am, timewise, the most senior CTR (Certified Tumor Registrar) at UM. I began working in that department, at UM, about early 2006. In February 2016 I was threatened that I was not as healthy as I thought and that something malicious had occurred to me. This was during a conversation with my boss, UM Tumor Registry Manager Stuart Herna. This was at his office in UM's Dominion Towers on or about February 19, 2016. When we spoke on the phone earlier that day he mentioned for me to stop by his office. (We are all UMHC employees but a few of us are housed at the University of Miami Hospital [UMH] building.)

I went by the office at Dominion Towers about lunch time that day, February 19, 2016. I stopped by the 7-11 convenience store nearby and purchased a pizza to share with the staff. I went to Mr. Herna's separate internal office after leaving the pizza at the entrance offices with staff. Mr. Herna mentioned that Melissa Williams, a worker at UM's medical campus, at the Florida Cancer Data System (FCDS), was "very sick". (FCDS is a State facility. However, UM manages this entity and hires, fires, etc., those employees.) I stated something to the effect that I was sorry to hear that and hoped she was better soon. Mr. Herna then stated that he couldn't speak more about her. Mr. Herna, also knowing about my recent surgery, immediately then asked how I was doing. I said "fine". (This was a prophylactic surgery and the pathology and pre-surgery tumor markers were negative.) Mr. Herna responded, "Are you sure? You have complained about a lot of people." I immediately knew this was an extremely serious threat and responded to him, "That is attempted murder." He replied, "You have to prove it." I had been severely retaliated against for years at UM because of my refusal to falsify Sylvester Cancer Center (SCCC) data information and for my reporting of the instances of falsified patient "follow-up" along with those omitted related cancer cases and treatments (that I knew about). This retaliation included falsified evaluations, false write-ups, suppressed salary for years, vandalism and money taken from my office, "set-up" confrontations with other staff, rerouted printing, a falsely started yearly recertification exam (via FCDS) last year, high level computer hacking at work and home (all documented with emails to and from UM IT Security and local police documentation) including moved and disappearing emails, personal phone hacking, home wireless security camera hacking, etc.

In April 2012 I reported to the OIG what I knew about from 2008 and 2010. (I had reported this to UM legal in 2011 but got no response.) In 2008 the entire staff was asked to falsify patient "follow-up" by doing no patient research however we were instructed to enter that we had called the patient. These instructions were given by Susana Arias (Morales). Manager Stuart Herna was in the room. As I stated, there were no patients called or any other research. We were given pages of lists (as we usually work from daily for abstracting cancer cases and patient follow-up), of 35-40 patient names per page.

By not completing any actual patient follow-up, all patients appear alive, thus falsely skewing survival statistics. This also takes much less time than valid follow-up, thereby saving time and money on staff. Falsifying follow-up also causes cancer cases and their treatments to be missed. State law mandates all cancer cases and treatments be reported within six months of the patient's visit. I refused to do this in 2008. In late 2010 a volunteer, Marla Swaye, gave me 23 pages of "follow-up" she was told to do by Ms. Arias (Morales). Ms. Swaye showed me what she was doing – it was exactly as we were told in 2008. Ms. Swaye left after only a few months but gave me 23 pages of patient lists she was working from. On the day I found out about this 2010 falsification, I had stopped by Ms. Swaye's office across the hall to say hi and ask how things were going. Ms. Swaye responded, "Judy, you don't want to know." I entered the room and she then showed me and explained to me what she had been instructed to do by Ms. Arias (Morales). A bit later she also told me that when she (Ms. Swaye) first began volunteering there, Ms. Arias (Morales) said to her (Ms. Swaye), about me, "Be careful what you say to her, I don't trust her." My other submitted complaints about UM also included reportable cancer cases deliberately left undone (reported to the OIG in September 2014) and in September 2015 I reported to the State a nurse copying over unique tumor board patient data from one patient data sheet to the next patient's.

As further background, I had been working mainly on UMH cases since 2008. However, in late 2012 I was assigned to work on SCCC cases and quickly saw a case initially abstracted at UM in 2009. The patient had three cancers in 2009 but only one cancer was entered when I saw the case in late 2012. This was despite five "follow-ups" between 2010-2012. Ms. Arias (Morales) had entered four of these "follow-ups" and her "best friend" Francis Moore had entered one of these. (Follow-up is actually supposed to be completed only once per year or so.) (After UM was aware of my April 2012 OIG complaint regarding these instances in 2008 and 2010, Mr. Moore never came back to UM. He never spoke much with me when he was there.)

I completed these 2009 cases and reported these cancer cases and treatments missed for four years to Dr. McCafferty, then head of UM Compliance. She has since left UM, it would seem under duress. During this time of the compliance investigation, Mr. Herna was somehow given a copy of my OIG complaint. Dr. McCafferty did not know how he got the complaint copy. However, she told him not to show it to the staff as they were to be questioned. However, Mr. Herna did show this complaint to the staff, disparaging me, and I have no doubt scaring them from telling the truth.

I was immediately moved back to UMH cases after this 2012 reporting. In about March 2014 UM rehired Ms. Arias (Morales). I was told not to speak with her and was again moved back to SCCC cases. I began seeing cases falsely marked as non-reportable and in September 2014 reported about 15 of these to the OIG. I completed these cases when I saw them in 2014. Many were years late, one dated back to 2005. I currently have other documentation (perhaps 25+ cases) that were also falsely marked as non-reportable. These were indeed reportable to the State and I had seen and completed them since that September 2014 reporting. In late 2015, after I reported to Mr. Herna a nurse copying over tumor board data from patient to patient, I was taken off of that assignment.

I have recently learned (on or about 6/22/16) that what Mr. Herna told me about Melissa Williams, that she was "very sick", is indeed true. I had not spoken with anyone about her since he made that threat

to me (discussed above) in February 2016. However, her case was on my abstract list recently. Also, another young woman in our office, Nicola Jones Mattis, is now also ill. I am concerned about the circumstances of their illnesses. Not only because they are fairly young, but also because they were mentioned in my complaints about UM. Ms. Williams is the contact person for my yearly credentialing exam, and likely knows who falsely started that. Ms. Jones was the person my printing was maliciously rerouted to. This rerouting occurred after I reported the cases deliberately left undone and had printed out the 15 or more screenshots showing the false, non-reportable documentation. Both these instances are fully documented with emails. The complaints were also referred to UM IT Security as well as outside law enforcement. In light of Mr. Herna's threat to me and other related circumstances, I am writing you now regarding this concern for malicious activity that may have caused their illnesses.

I am still following my health because of his threat. I do not know if these women had any type of surgery or other procedures whereby these agents could have been introduced. I feel that they may have been able to be introduced possibly in other ways as well.

The note below is a copy from my email sent to the Boynton Beach Police Department 8.10.16 outlining my very serious concerns regarding my cousin Joan Myers. I have reported to you before regarding a threat to my life and I am sure those around me are being made very ill and dying as retaliation for my complaints against the University of Miami related to cancer data manipulations we have been told to do. My latest complaints went to ACHA and several other organizations within the past two weeks regarding two fairly young co-workers named in past complaints against UM who now have cancer. When my boss, Stuart Herna, threatened my health in February 2016, he told me about one of these workers, Melissa Williams, and that she was "very sick". I recently found out she indeed was when I was given her case to abstract. Another worker, Nicola Jones Mattis, also now has cancer and was mentioned in my complaints. When Herna threatened me he asked how I was, to which I replied "fine" - my pathology was negative in my prophylactic surgery a few months prior. He then said "Are you sure? You have complained about a lot of people". I stated to him that "That is attempted murder" and he replied, "You have to prove it". I am being followed for my health due to this threat. There is more information and concerns in the note to the police below regarding Joan's time in the hospital. I never got a call or email reply from the officer. My cousin sounded even better when I spoke to her Thursday 8.11.16. She had apparently recently been diagnosed with myeloma and was doing well when I went to visit her last Sunday. She immediately recognized me and was glad to speak with me and others at that time via phone. She was hoping to leave soon. Joan had made a number of visits to UM for another health issue that was under control. She was more recently at a nearby rehabilitation center when she was admitted to the hospital. She suddenly died this past Friday 8.12.16 (I was told yesterday/Sat. am she passed "yesterday" so I assume Friday) and I am sure neither illness would have caused this directly or indirectly, had she been getting proper treatment. Dear Officer Jeanniton,

I have tried to reach you to touch base about my complaint from this past Saturday 8/6. When will you be available to speak with? I had complained about someone calling as me to Bethesda East Hospital that Saturday morning. This person had spoken with Amy, one of the nurses there who had overseen my cousin Joan. I had mentioned other concerns to you as well. My cousin has a friend Debbie at 561-302-1128. This I am sure is her cell phone but she also gave it as her home specifically for some reason. I don't know much about her.

As mentioned, because of concerns at my work (University of Miami [UM] medical facility), including severe retaliation against me targeted also at those around me, I am very concerned about my cousin's safety. (I have reported cancer data manipulations we were told to do and other concerns over the past

several years.) My cousin lives by herself although she has known this person Debbie for some years apparently. I was up to see Joan late in the day Sunday 8/7 and they had put restraints on her stating that she had tried to take her catheter out early in the morning Sunday (8/7). My cousin did not recall that she had tried to take the catheter out and is not sure what happened. The nurse Amy stated that my cousin was "confused". However, Joan knew me right away, knew the hospital she was at, spoke of family, and conversed with me and another person on the phone. I do not know what drugs she is being given. My cousin is a kind, quiet person and tries to take care of her health, not injure herself.

i also mentioned that two co-workers of mine mentioned in my UM complaints, young women comparatively, now have cancer. My life has been threatened at work (that something malicious occurred at a surgery), and now there is concern that my cousin Joan has cancer? She has been down to UM for medical care on a number of occasions for another health issue. I have also been subjected to severe hacking of my work and home computer and home phone -- many instances documented with UM, local police, and other law enforcement. My contact lists have been compromised and call logs hacked. An ex-friend (Rebecca Butler) took family pictures and taped comments at a gathering in January and has passed them to some unknown source. A son of one of those men (family friend) she interviewed suspiciously died a few weeks later. Details are with law enforcement. There is probably about 150+ pages of documentation on my concerns sent to a number of entities, Senator Rubio most recently. So, there are many very serious issues, including other suspicious deaths, should you wish to know more.



Thank you very much. I had also sent in some other complaints which I am sure you can search by my name. Please investigate why this particular response is months after I sent it in initially? I noted how urgent it was ...

I had also filed a police report (Boynton Beach PD) up there because Amy, a nurse, told me someone had called saying they were me earlier that same day I had called. I am the only Judy in the family and who Joan knew. After I filed the police report (Saturday) my cousin was put in restraints early the next morning (Sunday). I went there that Sunday and Joan did not remember pulling her catheter out (hence the restraints) as Amy told me Joan did (pulled her own catheter out). Amy said Joan was "confused" -- However, Joan knew me right away, knew where she was at, and certainly would have remembered had she pulled her catheter out and caused to go blood everywhere (as I was told). While I was there Joan also spoke with other family members via the phone and we chatted for some of the approximately 2 hours I was there. She also got a treatment then. I also spoke with her the following Thursday on the phone, I believe that was the day before she passed and she sounded great -- absolutely wonderful and we were all relieved. She sounded lucid, strong, and spoke clearly ... She was NOT at death's door -- Was she also diagnosed with Myeloma that week? I have also submitted complaints about UM (University of Miami) which I told of the threat to my life (still being followed) and the cancers of two women I work in association with involved with my complaints regarding falsification of cancer data. They are fairly young and the circumstances, including my boss' threat to me that something malicious happened at a surgery I had recently had, are beyond suspicious. I am glad to provide any further information requested. I believe you already have this information I am writing now but just wanted to convey the seriousness of these issues. I have submitted all these concerns in detail in my other complaints. it is of note as well that Joan used to go to UM for treatments for a liver disorder -- taking the train and often visiting overnight with the family. the last time was not that long ago. It is also of note that Joan took a "turn for the worse" and was hospitalized not long after I reported the University of Miami to you (Joint Commission). When my boss had threatened that malicious activity (referenced above), he had stated that I had "complained about a lot of people". I told him that was "attempted murder". He said, "You have to prove it". This is all in my complaint with you re: UM from July I believe.

Yes, you may share my information I sent in as needed regarding this extremely concerning situation.

To Florida Bar Staff:

These three enclosed extremely concerning complaints are regarding the retaliation at the University of Miami (UM) where I work. Most recently I responded to the recent evaluation and documented (again) the horrific abuse and retaliation I have been subject to for reporting cancer data fraud to the OIG and to other regulatory authorities. (That response and other information enclosed.) In one of the emails I again write (within past days) to UM Attorney Jessica Pacheco (over Equity for our department) complaining that even the NEW salary is inequitable and retaliatory -- they have not considered my relevant experience although they have for others in the department. Jessica again avoids the issue and refers me to a lower level HR (new employee Amie Choy) staffperson who has no authority to make this equitable OR to compensate me for back wages unpaid, also inequitable, for years. I have emails over the past years to Pacheco regarding the same thing as well as the abuse and horrific retaliation (also to her boss Beverly Pruitt, and to her boss Rudolph Green [all attorneys]). Much information also went to past UM President Donna Shalala and to current UM President Dr. Frenk. Also enclosed is my complaints to the City Attorney of Boynton Beach James Cherof where my cousin, Joan Myers, died beyond suspiciously (Bethesda Hospital). She had also been a patient at UM. I believe her death was retaliation for my recent complaints regarding UM to the Joint Commission (enclosed). I called the Boynton Beach Police with my concerns but he (Officer Jeanniton) never got back to me after writing the initial complaint to which I had emailed some corrections back. (I became concerned when someone stating they were me called for my cousin. I am the only Judy that Joan knew. Amy, her nurse, told me about this call from a person named Judy. Jeanniton made a police report of this call -- I had also voiced to him my concern my cousin was not going to leave the hospital alive. Jeanniton never returned any further calls or emails.) My cousin was unlawfully and illegally put in and held in restraints since late Saturday/early Sunday after my police call that same Saturday (details/dates enclosed). She was in restraints when I went to see her Sunday and was never taken off of them except when she went to the restroom. She was nonviolent, very calm and would never have done anything to harm herself. She "coincidentally" developed a cancer multiple myeloma, around this time, it seems within the week or so. More details are enclosed. I have much more documentation, letters and emails, that I would be glad to send to you. I know this mailing is close to or perhaps a bit over the 75 pages (for three complaints). You can see that there were attachments sent out called "Josiah" (34 and 17pp) -- these went to Senator Nelson's office. These complaints and more information also went to Senator Rubio and other representatives, as well as to other overseeing governmental organizations. I never got one call back from the FBI; a supervisor at UM, in my department (Susana Arias Morales) had made a point of telling me that she had a relative in the FBI (some years ago during a lawsuit/EEOC complaint against UM). There were two suspicious deaths at that time that I have

only realized were likely deliberate and suspicious (-- they were devastating at the time) in retaliation for the UM EEOC complaint (April 2009) -- they were family friends Charlotte Lobb (deceased 1/13/10 in Kentucky) and her son, career navy officer David John Pell (visiting her in Kentucky, deceased 12/27/09). There has been severe hacking of home and work emails/computer (since the time of EEOC complaints/lawsuit (April 2011) and severe personal phone hacking for years. It was my mother's hacked email that appeared to be the "sender" of the morbid emails to me time-lining my cousin Joan's death that same week she died. Again the FBI had these emails (as forwards) but never made the first phone call to me (see Senator Rubio emails). I have never heard back from Senator Rubio's office either about an appointment or in regards to my extremely serious concerns. It was the Secret Service who told me (via phone) the time-lined morbid emails were hacked and that my mother should change her email log-in. (I thought they were "phished".) I have those emails and their source documents. They had in the subject lines (seperate emails): Commanded, Initiated, Launched, immediately (the latter was all lower case). See forwards to Rubio (enclosed). I have the source documents.



Dear Mr. Vanstrum,

You have appeared to be very attentive and concerned, when we have spoken, about my complaints to the Florida Bar. Thank you for that. You appeared to concur with me that due diligence is always important, and particularly regarding such concerning situations as I have submitted, including pertaining to the University of Miami (UM). I am recapping my extremely serious concerns again here, as condensed as I can, for new Executive Director Mr. Doyle's review. As I had mentioned to you, I was fired after working at UM for about 12 years. Of that there is no doubt. Moreover, I am not specifically complaining to the Bar regarding retaliation involving an unjust (illegal) "warning" letter (I have received those in the past as well), or even the illegal threat to my life -- but rather, the recent, retaliatory, illegal firing. This firing (on 6.12.17) occurred after I reported this threat and related serious complaints to UM (HR/Equity/Compliance) as well as to the City of Miami and the DOJ on 5.31.17, and on subsequent days prior to the firing. In my 2016 evaluation response and sign-off on 5.31.17, I wrote of my concerns including illegal activities occurring at the Tumor Registry as well as manager Stuart Herna's threat to my life (that timing regarding my response and subsequent firing is not in question -- the Bar has this documentation). Besides the good 2016 evaluation, I had also recently been given a \$10,000 raise. My very serious complaint to the Bar in these regards, about high-level UM Attorney Aileen Ugalde (whom I have never met), was that it would appear she facilitated this firing and retaliation. I did complain to her via email and phone messages several times after I was fired (you have these emails), but never received the first response back from her. *Again, despite what some of the initial Bar reviewers stated, I am not and was not asking the Bar to determine if these activities were retaliation or even illegal -- I know that the threat and the activities I have reported are indeed both retaliatory and illegal. Moreover, the one substantive reason given for the firing, that I had missed a meeting, was blatantly false, and emails (you have) show that the meeting was recommended. Florida Bar reviewers, including Ms. Schuyler, did not even mention this false rationale in their responses to me.* Much more detail in the email below and in prior documents sent to the Bar ... I am sure I do not need to belabor to you that at a minimum, it is unethical according to Florida Bar guidelines, for any attorney to facilitate (or ignore) (possible) retaliation for reporting (a possible) crime, threat, or a firing based upon false premises. (Again, I feel that the threat is retaliation, and know that that, and the cancer data manipulations, are illegal. I am sure that the firing is also illegal retaliation.)

It is concerning to me that the Bar is, at the least, misinterpreting my complaints, and not even initiating the most basic of inquiries or demonstrating due diligence regarding these extremely serious issues. *Multiple times it was confirmed to me that not one communication, of any kind, was made by/to the Florida Bar, to/from anyone (other than to/from me), by any means, regarding any of my complaints. More recently my complaint regarding Mr. Cherof was sent to [Mr. Cherof], but even he was not asked to respond.* I am sure I do not have to stress to you all how concerning this is ... If Bar personnel are/have been intimidated, threatened, and/or otherwise politically motivated to any path other than due diligence, we all need to take a hard look at the direction Our Great Country is headed, and the unconstitutional crises we have now and have had for the more recent decades. One would hope that the attorney complaint process would always be just and fair, but even that appears to be, scarily, not always the case.

If you will please recall, a few years ago one of the UM Tumor Registry supervisors I had reported (for giving orders to falsify cancer data follow-up, among other egregious acts), Susana Arias

Morales, stated pointedly to me that she had a relative in the FBI; I have never received the first call back from the FBI despite much documentation submitted to them and yet available upon request. This reporting the FBI received from me included documentation of high-level hacking at home and work, including names of UM IT who knew the specifics of what was transpiring there. (Strangely, after this reporting to the FBI, one of the UM IT techs, Diane Rubin, who had been extremely helpful, stopped communicating with me.) Also, as you are aware, UM Tumor Registry manager, Stuart Herna, threatened my life in 2016 because I had, "complained about a lot of people". He had begun the conversation (with me only, in his office), stating that a co-worker in our field, at another UM location, was "very ill", and then asked me how I was. He knew from a prior conversation about my recent surgical procedure and that all was well (I had thought). I replied to him that I was "fine", and he replied, "Are you sure, you have complained about a lot of people." I took that response the only way I could, in light of his unusual call for this private meeting, the high-level hostility and retaliation I had been subject to at UM for years, as well as the extremely inappropriate and unusual opening discussion (about a very ill co-worker). I stated that, "That is attempted murder" and he replied, "You have to prove it". (This threat was reported to several overseeing agencies.) I subsequently, months later, found out that this co-worker was indeed extremely ill with cancer, when I was given her case to abstract. I had also detailed this threat by Herna in several email complaints, before I definitively knew (beyond Herna's words) that this co-worker was indeed very ill. This co-worker was also named in my complaint about my falsely started, yearly, abstracting code exam, in 2015. She knew I was taking the test that day and had helped to reset my password earlier in the day. Somehow this exam via computer was started while I was at lunch -- of this there is no doubt. There are emails of my correspondence with her showing my hour-long exam had five minutes left, after I had just logged in. Moreover, I usually went to lunch about 1:00, the cameras and my log-out show I did that day as well. The exam "started" shortly after I left for lunch, as the times on those test related emails show. *Ms. Schuyler (Florida Bar) stated that she did not mention in her emails to me, or consider, while analyzing my Ugalde complaint, this threat stated to me by Herna, because [Herna] was "not an attorney". Clearly, that was not the point of mentioning Herna's threat in my Ugalde complaint, and such a threat is an unethical act at the least, in any workplace, including at UM (I know it is also illegal). Ugalde knew about my complaint of this threat because I had specifically mentioned it to her in emails and it was in my evaluation response, which she had also received (and the Bar has). I also brought this "misguided" rationale (Herna as a non-attorney) to Ms. Schuyler's attention, as well as to many of you addressed here -- still, as of now, to no avail.*

Another, also younger, female co-worker, was also diagnosed with cancer in 2016. My printer had been maliciously rerouted to this worker within the prior year or so, in efforts to prevent me from printing out screenshots of the cancer cases I was reporting, including those required by State law, but that had been deliberately left undone. UM IT was notified about this rerouting and came to my office to reset my system-wide code in their laptop. The tech said this was very strange and that he had never seen anything like it. I also reported this to other overseeing organizations.

Thank you all again for your time and concern. I am requesting that my Ugalde complaint (17-17711) be reviewed diligently in light of the clarifications enclosed here. I will be mailing the Bar a copy of this specific email so please refer to the thread below, contained with this email (a total of 4 emails besides this one, the last email prior to this sent Wednesday, 11.29.17, 12:38pm to Mr. Doyle). Attached with this email is Mr. Vanstrum's response per Mr. Doyle, dated 12.6.17.

Dear Mr. Vanstrum,

As a brief addendum to my email sent a bit earlier tonight (just below), please note that subsequent to my reporting twice to the Joint Commission, once regarding UM for the threat to my life by Herna (for complaining "about a lot of people") as well as for concern regarding the cancer in the two younger women, and once regarding Memorial Sloan Kettering, the hospital involved with the threat to me at a surgery (see email directly below for more detail on these complaints), my cousin, Joan Myers, from Delray Beach, took a "turn for the worse" and was sent to a rehab center, then shortly thereafter to Bethesda Hospital East. She was absolutely NOT at death's door, but deceased within a week or so of her hospital admittance. She was retaliatorily and illegally put in restraints into her second day in the hospital; this was after I called the Boynton Beach Police Department and Officer Jeanniton took my incident complaint and concern for Joan's safety after someone saying they were me had called the hospital asking for Joan (per her "nurse" Amy, via phone). The next morning (Sunday) per phone "nurse" Amy said Joan had tried to pull her catheter out, as the reason for the restraints, but Joan denied that after I arrived to visit her that same day. It also would have been out of character for Joan as she took very good care of herself, never harming herself, or drinking or smoking. Her entire illness was in fact a mystery, as it was a BENIGN liver ailment, quite unusual for someone with no risk factors. (Joan had been a UM patient, traveling down about once every few months...) The "nurse" Amy also tried to portray Joan as confused when I was there that Sunday, but Joan recognized me immediately and spoke with relatives, she knew where she was, and sounded even stronger via phone that week Thursday, dying within a couple more days. I never heard back from Jeanniton, Cherof, or Aronberg (State Attorney). It is important to note also that UM sent me a web training this year (2017) on restraints, although I have never had that in the 12 years prior, and had no need for such per UM guidelines: I have NO DIRECT PATIENT CONTACT. My Chernof 17-16654 and Rubio 17-17110 complaints to the Bar further detail this horror. This note is also included with the mailed letter that has the first email directly below. Judith Futerfas
