What is SC EDGE?

In partnership with select high schools, Schoolcraft College offers the **SC** *EDGE*, *Earn a Degree*, *Graduate Early*, Early College Program to provide high school students the opportunity to earn college credit and credentials while still in high school.

This unique program combines the flexibility of online learning in a structured and facilitated format. Students will "attend" their Schoolcraft class during the school day, in their high school computer lab, facilitated by a high school instructor. The instructor will act as the student's coach and provide support and structure during the class period.

Who is eligible for SC *EDGE*?

All students must be in good academic and behavioral standing at their school. A grade point average of 2.5 is preferred. The students must exhibit a level of self-discipline and maturity as assessed by the high school counselor and/or the principal.

Interested students must meet with their high school counselor to discuss their interest and expectations of the program.

Steps to participate in SC EDGE



Meet with Your High School Counselor

Meet with your high school counselor to develop an educational plan and determine your eligibility under the public Postsecondary Enrollment Act. Ask about your enrollment eligibility, course selection, and any available funding for tuition, fees, and materials including books. Counselor signature and recommendation is required.



Complete the SC *EDGE* Application

Complete the SC *EDGE* Application and obtain all of the required signatures (parent, counselors, and principal). Social security number is required.

Attach Essav

Attach a one-page typed essay to your completed application answering the following question: Why do you feel you would be a good candidate for the SC *EDGE* Early College Program?



Return the Completed Application

Return the completed SC *EDGE* Application, current transcripts, and most current assessment scores (ACT PLAN or PSAT) to the Admissions and Welcome Center or fax documents to 734-462-4552. Additional testing may be required.

An acceptance letter will be mailed to you with your Schoolcraft student number. You will need a form of photo identification for verification if you would like to obtain your Schoolcraft student number in person.
