

Hamilton-Madison House Post-Doctoral Fellowship Opportunity

Hamilton-Madison House is a non-profit settlement house whose overall mission is to provide social, educational and mental health services to improve the clients' daily quality of life while providing a foundation for future personal and professional success. Since 1974, Hamilton-Madison House has been the leading provider of mental health services to New York City's Asian community. These services align with the House's mission by providing services that ease the burdens of daily life, while finding solutions that allow residents to succeed. Hamilton-Madison House's Post-Doctoral Fellowship opportunity is in our Behavioral Health programs. This Fellowship opportunity is for a period of one year and carries an annual stipend of \$35,000. The one-year Fellowship will begin September 2018.

The Fellowship offers supervised experience, under the direction of Dr. Yu-Kang Chen, Ph.D. and training in the outpatient Behavioral Health programs, primarily providing services to low income populations. The Post-Doctoral fellow will have the opportunity to gain intensive experience and training in short and longer term psychotherapy, couple/family therapy, follow-up case management, new referral screening, intake assessment, psychological testing, community consultation and outreach. The Post-Doctoral fellow will also have the opportunity to provide training activities such as seminars and facilitating case conference to the Psychology and Mental Health Counselor Interns at Hamilton-Madison House. The fellow is encouraged to create and implement groups depending on the clinic needs. The Post-Doctoral fellow will participate in weekly individual and group supervision.

Fellows are required to commit to a minimum of 37.50 hours per week and will be provided with supervision by experienced licensed psychologists. By the end of the Fellowship year, fellows will have completed 2,000 training hours. Professional experience hours may be utilized toward licensure as a psychologist in New York State.

An APA approved internship and a Ph.D./Psy.D. in Clinical/Counseling Psychology from an APA-approved program is strongly preferred. Training and experiences of working with children/adolescents is required. Candidates who speak a Chinese dialect, such as Cantonese, Mandarin, and Fujianese, will be given preference.
