Special Meeting ----- November 23, 1988

The meeting was called to order by the Chairman, D. L. Taylor at the District Office at 7:00 A.M. Other Grand County Water Conservancy District members present were Stan Baker, Gary Wilson, John Groo and James Walker.

ATTENDANCE

Grand County Special Service District members present were D. L. Taylor, Gary Wilson, Bill McDougald and Dan Holyoak.

Others present were Dale Pierson and Roberta Highland.

LAKE REPAIRS

D.L. announced the meeting was to discuss the repairs at the lake. Dale reported Doug Bedke has been out, and dug out the leaks. Bedke feels the problem is that in the old creek bed under the leaks there has been fill along a cliff and the weight of water is compressing that loose Yesterday they dug nine test holes and Bedke took samples to test. Bedke cannot find any indication in the specifications for compaction of the fill, and the test holes indicate the fill is settling, causing buckling of the He plans to strip the blanket in an area of about 100 feet by 200 feet, removing about 15 feet of the blanket, using two scrapers, one dozer and possibly a patrol. there is no one in town with two scrapers, Dale and have contacted Crowley in Monticello. Boulden has a small scraper. Crowley has all the equipment needed and can start on Monday. Gary asked if local men could put together their equipment and keep local people working. Local contractors and equipment was discussed. D. L. asked if Boulden could the job, whether he could rent any equipment needed. Dale stated he talked to Boulden and he said he could start any time. Bill stated he would feel more comfortable if Boulden did the work. Bill asked if the County had some equipment we could use for the compaction. By consensus, the Board agreed to contact Jim Boulden, and put him in charge of the repairs if he can start immediately, using as much County equipment as they will let us have. D. L. asked if we could save the clay, and Dale told him Bedke planned on saving as much as he could. Bedke will have to supervise the compaction as he is the only one who can test the density. Gary stated he had talked with Bedke about checking on the progress, and Bedke will be down a few times. D.L. asked about costs, and Dale reported he felt the project would cost about \$40,000.00. Dale will contact Boulden and get in touch with Tim Pogue about using County Equipment today.

Gary stated that he had been contacted by Jim Walker and the Moab Irrigation Co. about fixing their diversion dam, and although we had talked of a 50/50 basis, since the irrigation district has already hauled the clay, if they provide a man, we should pick up the backhoe bill. The

timing was discussed, and it was agreed all the water in the Creek will have to be diverted into the reservoir before they could repair that diversion dam.
