### NOTICE OF CONFIRMATION (NOC)

#### Acknowledgement of STWEC Membership Requirements

The California Regional Water Quality Control Board Central Valley Region has new Waste Discharge Requirements (WDRs) under General Order R5-2014-0030 (Order) for growers within the Sacramento River Watershed that are Members of a Third-party Group. The new WDRs were adopted on March 12, 2014 for discharges from irrigated lands to protect both surface water and groundwater throughout the Central Valley. In order to obtain the new WDRs regulatory coverage offered by the Third-party Group, Sacramento Valley Water Quality Coalition (SVWQC), as a member of the Sub-watershed Shasta Tehama Watershed Education Coalition (STWEC) this NOC must be understood, signed and returned to STWEC.

- ☒ As a member of STWEC I understand that my indicated irrigated lands are in compliance with the ILRP regulations as long as I the owner/operator abide by the order requirements.
