Department Officers Election: To be eligible to hold an elected office, a person must be an auxiliary member in good standing for at least two (2) years. To be considered a member in good standing of the Department of Florida, a member must attend at least one-third (1/3) of local meetings per year unless an excuse is given.

All nominations shall be made from the floor of the Department Convention and all candidates must be on the floor for nominations and election.

The annual Convention shall elect a President, First Vice President, Second Vice President, Third Vice President, Sergeant-at-Arms, Treasurer, Chaplain, Scholarship Officer, Hospital Officer, Americanism Officer, National Executive Committeewoman, and an Alternate National Executive Committeewoman. The NEC woman and the Alternate NEC woman shall be elected to serve a two-year term, and this election takes place in the odd years.

If you are elected, the Department Officers Training will be held on July 7 - 9, 2023. We look forward to all officers attending! I will share training information on Sunday at the close of the convention.


