Stuttering and Cluttering: Evaluation and Treatment

Barry Guitar, Ph.D., CCC-SLP

This workshop will teach participants how to evaluate and treat stuttering and cluttering in pre-school and school age children. The approaches will be based on a different theoretical approach to stuttering, and the treatments that derive from that. Approaches to cluttering are based on our clinical experiences in treating children with this disorder, as well as new research on the basis of cluttering. The evaluations and treatments will be illustrated by videos that will show evaluation and therapy being carried out.

Participants will:

- Gain an understanding of recent theoretical views of stuttering that explain why children are treated with the therapies suggested.
- Learn what to do and what to look for during evaluations so that each child will be given a treatment appropriated for him/her.
- Learn to how to carry out both indirect and direct therapy approaches with preschool children.
- Learn how to work with behaviors, attitudes, and emotions of school age children who stutter.
- Learn how to incorporate both parents and teachers into treatment of school age children.
- Learn the hows and whys of working with children in groups.
