## **DESCRIPTION OF PROGRAMS**

### **Emergency Medical Technician – Basic (EMT-B) Classroom Version**

Course offers instruction in a classroom setting for national curriculum EMT-B course required for national registry and county certification. Successful completion of this course will allow students to register and take the National Registry Emergency Medical Technician (NREMT) Exam.

**Prerequisites:** Students must be 18 years of age or older at the time of registration, have a high school diploma, GED or passage of the California high school proficiency and have a valid BLS CPR card. Proof of high school diploma, GED or passage of the California high school proficiency exam must be provided at time of enrollment. BLS CPR card must be provided prior to taking the final exam.

**Classroom Training:** Fulfills 146 hours of required classroom training consisting of lecture, quizzes and skills training. Skills evaluation and final exam are within this time period. To successfully complete the classroom training students must receive 80% or better on all quizzes and final exam.

**Internship:** 24 hours ambulance ride-along for skills evaluation. Students must have 10 patient contacts at a minimum. Instructors will coordinate with students to setup ride-alongs with one of our providers. Students are responsible for completing a minimum 24 clinical hours and 10 patient

contacts. Students who turn in falsified clinical hour forms will be failed from the course **WITHOUT** refund and will not be able to enroll in our future courses.

Students must successfully complete both classroom training and ride-along before a course completion certificate is issued.

### **Emergency Medical Technician – Basic (EMT-B) Hybrid Online Version**

Course offers online instruction for national curriculum EMT-B course required for national registry and county certification. Successful completion of this course will allow students to register and take the National Registry Emergency Medical Technician (NREMT) Exam.

Course is 146 hours online presentations and quizzes, 24 hours field training and in person skills practice session, final exam and skills evaluation. Course is open registration, students may start online portion on any day. Entire program (online portion, skills evaluation, final exam and ride-along) must be completed by student within 364 days of purchase.

**Prerequisites:** Students must be 18 years of age or older at the time of registration, have a high school diploma, GED or passage of the California high school proficiency and have a valid BLS CPR card. Proof of high school diploma, GED or passage of the California high school proficiency exam must be provided at time of enrollment. BLS CPR card must be provided prior to taking the final exam.

**Online Portion:** Students have full access, within 24 hours of receipt of payment, signed enrollment agreement and signed School Performance Fact Sheet, to the latest course material that is divided into 39 chapters. Each chapter contains quizzes designed to help students gain a full understanding of course material.

This latest version of the online course has fully customized features that interact with each student individually. The study plan feature creates Chapter Homework based on how each individual student scores on quizzes. At the end of each chapter students take a Chapter Test, students must receive an 80% or better to move to the next Chapter. If a student does not receive a passing grade on a chapter test the study plan feature located at the bottom of the test will customize a study plan for that chapter that students use to study before retaking the Chapter Test.

**Skills Practice/Evaluation and Final Exam:** Skills and Final Exam sessions are held on the 1<sup>st</sup> and 3<sup>rd</sup> Saturday of every month. Final Exam/Skills Practice is 8:00 am to 12:00 pm, Skills Evaluation 1:00 pm to 5:00 pm. Students must register with their instructor in advance to be placed in a Skills Practice/Evaluation and/or Final exam session.

Students enrolled in the Hybrid Online Version may attend any skills practice session. One 4-hour skills practice session is mandatory. Please register with your instructor as space is limited.

**Internship:** 24 hours ambulance ride-along for skills evaluation. Students must have 10 patient contacts at a minimum. Instructors will coordinate with students to setup ride-alongs with one of our

providers. Students are responsible for completing a minimum 24 clinical hours and 10 patient contacts. Students who turn in falsified clinical hour forms will be failed from the course **WITHOUT** refund and will not be able to enroll in our future courses.

Students must successfully complete online training, final and ride-along before a course completion certificate is issued.

### **Emergency Medical Technician – Refresher**

Course offers continuing education credits/hours in a classroom setting for national curriculum EMT-B course required for county and National Registry Emergency Medical Technician (NREMT) re-certification.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT License. Proof of EMT License must be provided to at time of enrollment.

**Classroom Training:** 3 days (8:00 am to 5:00 pm, with 1 hour lunch break) which includes classroom and skills training and final exam. Students must receive 80% or better on the final exam before course completion certificate is issued.

### **Psychomotor Exam Only**

This exam satisfies all state and National Registry Emergency Medical Technician (NREMT) skills requirements. Exam session will take approximately one hour to complete.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT License or letter to test from NREMT. Proof of EMT License or letter to test from NREMT must be provided at time of enrollment.

**Classroom Training:** Psychomotor exams are held on the 1st and 3rd Saturday of every month. Students must register with their instructor in advance to be placed in a psychomotor exam session.

Students must successfully perform all items on skills sheet.

### **24 Hours of EMT Continuing Education**

Course is designed to be a comprehensive and active review of the new Education Standards, providing both an overview of new information contained within the Education Standards at the EMT level and a source of continuing education.

24 hour course includes the following topics: preparatory – 1 hour, airway – 2 hours, OB/infants/children – 2 hours, patient assessment – 3 hours, medical/behavioral – 4 hours, trauma – 4 hours, elective – 8 hours and elective – 8 hours.

24 hour course **DOES NOT** include skills, it is designed for additional continuing education hours only.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT License. Proof of EMT License must be provided at time of enrollment.

**Classroom Training:** 3 days (8:00 am to 5:00 pm, with 1 hour lunch break) which includes classroom and skills training and final exam. Students must receive 80% or better on the final exam before course completion certificate is issued.

### **48 Hours of EMT Continuing Education**

Course is designed to be a comprehensive and active review of the new Education Standards, providing both an overview of new information contained within the Education Standards at the EMT level and a source of continuing education.

48 hour course includes the following topics: preparatory – 3 hours, airway – 8 hours, OB/infants/children – 5 hours, medical/behavioral – 15 hours, trauma – 11 hours, and elective 6 hours.

48 hour course **DOES NOT** include skills, it is designed for additional continuing education hours only.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT License. Proof of EMT License must be provided at time of enrollment.

**Classroom Training:** 6 days (8:00 am to 5:00 pm, with 1 hour lunch break) which includes classroom and skills training and final exam. Students must receive 80% or better on the final exam before course completion certificate is issued.

### **72 Hours of EMT Continuing Education**

Course is designed to be a comprehensive and active review of the new Education Standards, providing both an overview of new information contained within the Education Standards at the EMT level and a source of continuing education.

72 hour course includes the following topics: preparatory – 4 hours, airway – 10 hours, OB/infants/children – 7 hours, patient assessment – 3 hours, medical/behavioral – 19 hours, trauma – 15 hours, and elective – 14 hours.

72 hour course **DOES NOT** include skills, it is designed for additional continuing education hours only.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT License. Proof of EMT License must be provided at time of enrollment.

**Classroom Training:** 9 days (8:00 am to 5:00 pm, with 1 hour lunch break) which includes classroom and skills training and final exam. Students must receive 80% or better on the final exam before course completion certificate is issued.

### **Basic Life Support CPR (BLS CPR)**

This course is designed to certify students in basic life support CPR based on American Heart Association 2015 protocols.

**Prerequisites:** Students must be 18 years of age or older at the time of registration.

**Classroom Training:** 4 hours which includes classroom and skills training and final exam. Students must receive 84% or better on written exam and pass skills testing.

### **Medical Unit Leader S-359 (MEDL)**

Course provides skills and knowledge needed to perform in the role of Medical Unit Leader (MEDL) on an incident or in an EOC.

Topics include gathering information, organizing the medical unit, supervising the unit, evaluation, documentation, and demobilization.

**Prerequisites:** Students must be 18 years of age or older at the time of registration and have a valid EMT or Paramedic License. A copy of students EMT or Paramedic License must be provided at time of enrollment.

**Classroom Training:** 3 days (8:00 am to 5:00 pm, with 1 hour lunch break) which includes classroom training and final exam. Students must receive 80% or better on the final exam before course completion certificate is issued.

### **ADMISSION REQUIREMENTS**

Student must be at least 18 years of age or older at the time of registration for all courses.

Student must provide proof of high school diploma, GED or passage of the California high school proficiency exam for Emergency Medical Technician – Basic (EMT-B) Classroom and Hybrid Online Version courses.

Student must provide a copy Basic Life Support CPR card for Emergency Medical Technician – Basic (EMT-B) Classroom and Hybrid Online Version courses.

Student must provide a copy of EMT License or letter to test from NREMT for Emergency Medical Technician – Refresher, Psychomotor Exam Only, 24 Hours of EMT Continuing Education, 48 Hours of EMT Continuing Education, and 72 Hours of EMT Continuing Education courses.

Student must provide a copy of EMT or Paramedic License for Medical Unit Leader S-359 (MEDL) course.

## STUDENT TUITION RECOVERY FUND

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.

7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

**Emergency Medical Technician - Refresher:** Student MUST attend ALL classroom times to complete this course. No absence is permitted.
