BRIEF HISTORY

Barry Gordon Campbell: Was born in New York City, to Mr. Edward Albert Campbell and Audrey Arnetta Campbell, on August 14, 1952. All early schooling was in New York City. He graduated from DeWitt Clinton High School in June 1970. He worked at the Lowlud Sewage Plant in Yonkers, New York from 1970 to 1973. He also attended the New York School of Mechanical Dentistry earning two certificates for Dental Laboratory Technology and Dental Steel Technology, 1979 to 1983.

He joined the United States Army in 1973 and was honorably discharged in 1979 (Vietnam War Era Veteran). On April 8, 1978 he married his sweetheart, Ms. Patricia Warrington. He has three children, one son, Nikon Asheen Campbell, and two daughters, Nidra Ann Campbell and Tameka Audrey Campbell.

He started working at the Veterans Administration in 1983. He was Compensation, Pension and Agent Orange Coordinator at the Department of Veterans Affairs in Manhattan, New York, from 1989 to 2011.

Medical Administration Services: Compensation and Pension Examination Unit

Program Support Assistant, Major Duties: Incumbent in the Medical Administration Service is assigned to the Compensation & Pension Examination Unit. In this capacity, reviews all requests for physical examinations received from the N.Y. Regional Office, other VA stations, VA Insurance Center, Civil Service Commission, Railroad Retirement Board, State Department, Peace Corps, allied governments and other federal agencies.

Incumbent is a technical authority on all phases of the Medical Fee Program. Acts as a source of information and advice to other concerned parties acting on behalf of veterans, such as congresspersons, attorneys, representatives from the health field in general, veterans' service organizations and the families of veterans.

In addition, incumbent assists in interpreting VACO guidelines and standards for the staff. Incumbent suggests changes in work distribution and assignments when indicated. Incumbent shares work and responsibility for work dissemination and review.

In reviewing work, incumbent recognizes and recommends the need for staff training and assumes an active role in effecting such training. Develops, recommends and assists in the development and formulation of operating policies and procedures for the unit. Incumbent is also responsible for all training.

Incumbent reviews all requests and from this review indicates the type of examination to be rendered, depending on the disability involved and the purpose of the examination. In some instances, must be able to determine when a special type of examination must be assigned to a particular physician. When multiple disabilities are involved, the incumbent must be able to determine when to assign more than one clinic or physician to accomplish the requested examinations.

The incumbent gives final authorization for fee basis examinations to private physicians based upon the nature of the disabilities and the fitness and ability of the veteran to report to this clinic.

In authorizing these examinations, the incumbent determines the type of examination and any other additional special instructions for the examining physician. Is responsible for maintaining all examinations. Is responsible for maintaining liaison with the Section Chief of the Adjudication Division at the V.A. Regional Office when there are changes in procedures or when clarification is necessary on a particular request for examination. Contacts the professional chiefs of services when changes arise in scheduling, reassignments of physicians and new procedures. This is necessary for better coordination of the activities involved.

Is responsible for the processing of requests for physical examinations, including receipt of and review of forms and correspondence for veterans of allied governments, the Civil Service Commission and other federal agencies.

In issuing the authorization for fee basis physicians, maintains necessary and administrative controls, handles cases to completion, including action leading to payment. Is responsible for receiving and answering or initiating correspondence pertaining to examinations with veterans, relatives of veterans, fee physicians, service organizations, etc.

The incumbent is AMIE Coordinator for C&P examinations in the Medical Center. The incumbent must be knowledgeable concerning the established Automated Medical Information Exchange System. The system requires knowledge of all ten programs/options.

This system requires the supervisor to regulate the flow of exams to the transcribers. Incumbent has sole responsibility for re-opening cases and is the technical authority on all phases for the C&P Exam Program. Compiles statistical data for submission to the VA Central Office. These reports spell out detailed information regarding workload and fee basis activities. Is responsible for all segments of the AMIS report for the unit. Incumbent is responsible for arranging scheduling for C&P cases for audiology services and reviews hearing examinations for this station as well as Brooklyn and other areas of New York State and Connecticut.

Incumbent is personally responsible for this program from the time the examination is received until its completion. All New York examinations, when completed, must be forwarded to the audiology consultant in Baltimore, Maryland for certification.

Incumbent maintains final responsibility for the meeting of the unit's central office directed timeliness standards which call for the completion of 65% of all examinations within one month; 90% of all examinations completed within two months, and 100% completion within six months.

The incumbent attends monthly and quarterly conferences, presided over by the Chief of the Medical Administration Service or by the Adjudication Division of the Regional Office.

At these meetings, incumbent presents ideas for methods of improving operations within the Examination Unit and other units within the Medical Administration Service as they affect the Examination Unit.

Periodically the incumbent is required to lecture or make presentations to the professional staff and other interested staff regarding changing regulations or procedures which are pertinent to the function of the Examination Unit and may result in procedural changes affecting existing policy.

With my interaction, there wasn't enough time in my daily working schedule to handle all the problems of the veterans that I saw each day. I found myself taking work home.

By working on claims at home, trying to help all those veterans I saw during the days or weeks before, this is an expression of one individuals' dedication. I came to understand that I needed help in order to help them. My private life was put on hold as I worked toward one goal "Helping Veterans."

ORGANIZATION AND MISSION

Barry stated: "By the grace of God, I am what I am." It took time for me to create an inside and outside network to help me in my main job as a Compensation and Pension Coordinator. This enabled me to help so many of our veterans that I was unable to help due to lack of time on the job.

To me it started out as a part-time job with no money. My wife didn't mind. In providing this for years, I realized that I needed additional help. Starting out small with a group of 30 motivated veterans, today my membership stands at 3,165 and still growing. I created this organization to secure the rights of all veterans for just that need (Veterans Quality of Life Access Network).

I started my organization in 1999 at my home-base on 95th Street in New York City (because of the overflow of veterans I was unable to help on the job). We spearheaded my organization to be dedicated to improving the lives of all veterans and be a voice for the voiceless.

In 2002 my organization was housed at Salem Methodist Church in Harlem, New York City under Rev. Charles Washington.

In 2004 we moved my organization to the American Legion Post in Harlem, New York City, under Commander Randy Dupree. In 2006 we moved again to my present address, St. Ambrose Church on 130th Street in Harlem, New York City under Rev. Dodson.

Tonight millions of our veterans and their children are going to bed hungry. I am here to stress the importance of this with the encouragement and love for those who made the supreme sacrifice and for those who fought against the most hideous of crimes. He truly believes God puts people in our lives for a reason. It is not their fault for being down, but it would be their fault if they did not fight rather than die fighting to get up. This is a gross injustice.

In the faces of those veterans that I tried to help, I saw turmoil, heartache, pain and suffering that should not be there. They all needed just a little help for them to stand and be counted again. So my battle was set to go forward with the idea of an organization to help them.

In war death has no prospective for today or tomorrow. Our soldiers who are coming home must fight the past for the future. This has increased at an alarming rate and it is up to all of us to help. For the poor veterans, even air is expensive. We must examine our priorities.

He had regular communication with veterans by conducting group discussions with veterans pertaining to developmental, behavioral and medical issues. Diagnosed and evaluated the treated veterans. Provided clinical services, family counseling and referrals to veterans and their families for help on a daily basis.

He provided direct services to veterans by implementing and monitoring the effectiveness of services rendered. Experience creating and implementing treatment plans for veterans with psychosocial, behavioral, Agent Orange and other health related disorders. Served as a liaison between counselors and veterans.

He maintains accurate and thorough documentation via case records and recruits leading professionals for his own outside organization, Veterans Quality of Life Access Network (VQLAN).

Barry has shown, with awesome power, which characterizes one man's personality, an extraordinary blend of inspired directions. With a high water mark, being an American, we all should have a sense of obligation for those men and women in order to give them all a sense of dependence. His behavior pattern, with his determination, persistence and work, has led to prevention and treatment advances that have helped millions of veterans (honest criticism and peer reviewed).

Barry stated "The ideals these veterans fought for are being trampled." Advancement was denied to those who did not know how to fight. That is our reality and we have to deal with it. With the underlined facts under the existing system, serious harm has been done (failure to comply with policies.)

To handle my work with these veterans, I had to take courses on the job and study books on my own. Some of the books I read and courses I undertook were: The Bible, Psychology, "The Study of the Mind and the Scientific Study of Behavior by Sigmund Freud. Some of the on job courses were researching, writing, project management, debates, and political systems. Summarized findings and developed detailed listings. Applied data analysis, organized records for depositions in specialized formats, procured clients and shared information with colleagues and supervisors to determine appropriate next steps.

All veterans have flashbacks. It's how they deal with it and some cannot. Kill or be killed for some of them. There will come a time when our veterans will say; enough is enough if they cannot be helped and I promised that I would never turn away from them, with my words and deeds.

We can better understand, in keeping in contact with friends out of the Armed Forces, that it is a very important thing in helping the ones that can come home. War is hell! To bond with someone that has gone through it, helps most veterans adjust to the outside world again. That is what all parents need to know (an old aspect to their relationship, brotherhood).

For those veterans on the street fighting to just live, they have a fighting battle to receive the benefits due to them. Why? Many of them have hope that our government will do right by them, but our streets tell us different.

I like this anonymous quotation: The Promise: "When we have gone into the furnace of affliction, His hand is on the thermostat and His eye is on the clock." I am aware of the dream of Dr. Martin Luther King, Jr. promoting a modern civil rights agenda, of the Reverend Al Sharpton and his work in Harlem on issues like social and criminal justice, education, anti-violence and voter protection laws to inspire people to become active participants in today's issues.

The Reverend Jesse Louis Jackson, Sr., Founder and President of the Rainbow PUSH Coalition, is one of America's foremost civil rights, religious and political figures. Over the past forty years, he has played a pivotal role in virtually every movement for empowerment, peace, civil rights, gender equality and economic and social justice. On August 9, 2000, President William Clinton awarded Reverend Jackson the Presidential Medal of Freedom, the nation's highest civilian honor.
