

The Ralston City Council met in a regular session on Tuesday, May 19, 2015 at 7:00 P.M. at Ralston City Hall. McDonald and Frasier presented Officer Jeremy Leifeld with an award for the Area of Adult DUI Enforcement for Individual Officers. Frasier thanked Officer Leifeld and the other law enforcement present for their dedication and hard work. Canfield said the Food Bank of the Heartland will return with Kids Cruising Kitchen beginning on June 1st and will serve through August 7th. Amy Roeder, Event Coordinator for Ralston Arena, reported on the upcoming events. Groesser stated there were 8 resumes received for the position of Economic Development Manager & Ralston Community Foundation Fund Administrator. Groesser said they have selected the top candidate, John Yokum, for the position. Groesser said he has a very impressive resume and a lot of experience. Groesser said if none of the Council has any objections, he would like have him start on June 1st, pending all of the applicant tests being done.
