Heath Insurance Premium Deductions

Good Afternoon,

As you may have noticed, or will notice, your Health Insurance Deduction on your Sept 1, 2020 pay warrant has gone down from last month. Due to the timing of negotiations and settlement with AVUTA for the increase to your Health and Welfare CAP, we were unable to change your August 1, 2020 to reflect the decreased rates.

Prior to this, your deduction for you insurance was to be as follows:

Kaiser 12 - month - \$253.07	10- month - \$303.69
Aetna 12 – month - \$1096.69	10 – month - \$1316.03

Your **NEW** deductions, with the increased CAP, will be as follows:

Kaiser 12 - month - \$162.24	10- month - \$194.69
Aetna 12 – month - \$1005.86	10 – month - \$1207.03

You will see these updated out of pocket premium deductions reflected on your October 1, 2020 pay warrant and through the remainder of the school year.

What you are seeing on your current, September 1, 2020 warrant, is a premium deduction that has been credited with the difference between what you paid on August 1 and what the new out of pocket premiums are.

For Kaiser Employees, you will see \$71.41 (\$85.69 for 10 pay) & \$915.03 (\$1098.03 for 10 pay) for Aetna employees deducted from your September pay warrants. This is a **one- time** reduction, to make you whole for the year.

We apologize for any confusion this may have caused. As always, please feel free to contact Celeste Kimball in payroll at Ext 20123.
