I am Mr. Lin Yi Chung, Manager Asset Management Department for the Shenzhen Bank in Hong Kong China. I have asked a friend coming to The United States to send this letter on my behalf for security reasons as I want to be sure my letter is not intercepted here in Hong Kong. I am getting in touch with you regarding the estate of a deceased client with similar last name and an investment placed under our banks management.

I would respectfully request that you keep the contents of this mail confidential and respect the integrity of the information you come by as a result of this mail. I also hope I have not embarrassed you as I got your name from our Chamber of Commerce Directory. I contact you independently and no one is informed of this communication. In 2006, the subject matter; Mr. Albert Grunke came to our bank to engage in business discussions with our private banking division. He informed us that he had a financial portfolio of \$10.5 million which he wished to have us invest on his behalf. 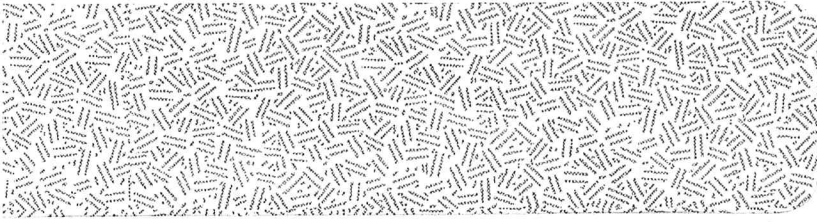
