The Chairman received an email from Athletic Facilities Caretaker, with a bid he had received from John Carr for the parking lot/ball field light replacement. Budget:

The Fair Grove District Park received \$84,293.19 from sales taxes and \$42,569.76 from Greene County Park taxes, for a total amount of \$126,862.95. The Board is projected to receive \$10,000.00 from all sports concessions, \$24,000.00 roughly from all sports programs, \$1,665.11 from interest and \$2,000.00 from miscellaneous income (donations, etc.) Projected income is \$164.528.06
