Releaser understands and acknowledges that Cimarron Bad Boy Wrestling Club sanctioned activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. **RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR ECONOMIC OR DEATH**, sustained while participating in, attending, preparing for or traveling to and from any Cimarron Bad Boy Wrestling Club sanctioned event(s), meet(s), practice(s) or activity, including the risk of **PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES**, or hidden, latent or obvious defects in the facilities or equipment used. Releaser acknowledges and fully understands that each participant in any Cimarron Bad Boy Wrestling Club sanctioned event, meet, practice or activity, including Releaser, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releaser's own actions, inaction's or negligence, but also from the actions, inaction's or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further Releaser acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at this time. Releaser understands that they are responsible for their child's transportation to and from Cimarron Bad Boy Wrestling Club sanctioned events or activities which include meets, duals, tournaments and practices
