RESTRICTED ITEMS

Fireworks, explosives (including Pop-caps) or any items that may be considered profane, etc. Items are subject to approval by Festival Committee.

REQUIREMENTS

South Carolina Retail Tax License - A current South Carolina Retail Tax License must be available at your booth on Festival Day. Each vendor must collect and pay South Carolina Sales Tax.

South Carolina Department of Health – All food vendors are subject to inspection by SCDHEC. A food inspection form must be filled out and mailed with your application; a copy must also be at your booth on Festival Day. Food vendors with fryers are also required to have a K Fire Extinguisher. No exceptions.

Every booth needs to be covered. (Trailer, tent, etc.)

Certificate of Insurance.

REMINDER

All applications must include:

1. Applicable entry fees (Booth Fee, Electrical Fee If Needed, Late Fee If Applicable)
2. Completed Application (Provide All Requested Information. Applications Will Be Reviewed!)
3. SC Retail Tax License Number
4. Food Inspection Form (Food Vendors Only)
5. Photo of Booth & Contents (**Required for Review**)
6. Certificate of Insurance (Contact the chamber for more details)
