Release from Liability

This **RELEASE OF LIABILITY** is made this _____ day of _____ (month/year) by _____ (rider) and if Rider is a minor, Rider's parent or guardian in favor of Oxford Farm, located at 1900 S. Berkey-Southern Rd, Swanton, OH, its owners and employees. In return and in consideration for the use today and in the future of property, facilities, equipment, and services of Oxford Farm and Signature, the Rider and Rider's parent or guardian expressly agree to the following:

1. The Rider is responsible for full and complete coverage on his/her horse, personal property, and himself/herself. 2. Under the Ohio Revised Code Section 2305.321 an equine and/or property owner is **NOT LIABLE** for any damages suffered during an equine activity. The Rider understands and acknowledges that there are "*inherent risks*" associated with equine activities. The inherent risks include, but are not limited to, the propensity of equine to behave in ways such as running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in injury, harm or death to persons on or around the equine; the unpredictability of equine's reaction to such things as sound, sudden movement and unfamiliar objects, person or other equine, another animal, a person, or object; the limited availability of emergency medical care, and the potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant. Rider understands that Oxford Farm as equine activity sponsors, equine professionals, trainer/instructor or stable manager is NOT LIABLE for an injury to, or the death of, a rider, or a participant in equine activities resulting for the inherent risks of equine activities.
3. The Rider **AGREES TO ASSUME ANY AND ALL RISKS INVOLVED IN OR ARISING FROM RIDER'S USE OF OR PRESENCE IN AND UPON OXFORD FARM'S FACILITIES AND PROPERTY** including, but not limited to: the risk of death, injury and property damages from falls, kicks, bites, collisions with vehicles, equipment, other horses, fences or stationary objects, from fire, explosion, the unavailability of emergency medical care and the negligence or deliberate act of another person.
4. The Rider agrees to hold Oxford Farm harmless and not liable and releases it from all liability and **AGREES NOT TO SUE** Oxford Farm, its owners and employees for any claim, injury, or property damage (including consequential damage).
5. The Rider agrees to abide by all of Oxford Farm's rules and regulation, and the Rider must use protective riding apparel and protective gear (i.e. hunt cap, paddock boots, chaps or breeches) whenever Rider is participating in an equine activity.
6. This RELEASE FROM LIABILITY is given for good and valuable consideration. This RELEASE FROM LIABILITY shall be enforced and interpreted under the law of Ohio. If any provision of this RELEASE FROM LIABILITY shall remain valid and enforceable.
7. If Rider is a minor, Rider's parent agrees to indemnify and hold Oxford Farm and Signature harmless for and against any claims that may arise from any injury or loss of Rider, or caused by Rider, including reasonable attorney fees.
