CMS recently announced results of the 2023 Performance Year. Silver State ACO is delighted and proud to announce that Silver State ACO *earned Shared Savings* for an

astounding <u>NINTH</u>
consecutive year!

Final reconciliation

shows that, for the 2023 performance year, Silver State ACO saved CMS over \$29,167,000. Cumulatively over the last nine years, SSACO has saved CMS more than \$261,758,000! Of the savings generated for CMS in 2023, Silver State ACO has earned more than \$21,437,000.

Of the 453 ACOs that participated in the program in 2023, Silver State ACO ranked in the top 8% of ACOs for Shared Savings Earned. Keep in mind that this <u>disregards</u> the number of beneficiaries served by the ACOs, of which there are many ACOs that are much larger than Silver State ACO.

Silver State ACO was the **#1 ACO** in Nevada for both generated savings and shared savings!

# **2025 Medicare CQMs**

As we approach the beginning of the 2025 performance year, we would like to inform you of key quality reporting changes that will impact our practices. Starting in 2025, the Centers for Medicare & Medicaid Services (CMS) will be



sunsetting the CMS Web Interface Measures. This means that Silver State ACO will no longer be able to report those measures on behalf of our participating practices. Instead, we will be required to report quality via Medicare Clinical Quality Measures (CQMs).

Medicare CQMs are electronic-based measures populated and pulled directly from your Electronic Health Record (EHR) system. These will be uploaded via a QRDA Category 1 file. Over the past few years, your Quality Coordinators have been working closely with you to ensure that you, your providers, and your staff are familiar with the specifications for these measures and understand how to document them correctly within your EHR.

However, with the release of the 2025 Medicare Physician Fee Schedule Final Rule, CMS has added one new CQM to

the requirements—Breast Cancer Screenings. This brings the total number of required CQMs for 2025 to the following:

- <u>Diabetes: Hemoglobin A1c Poor Control:</u> For patients aged 18–75 with diabetes, an HbA1c must be completed in 2025. Medicare considers an HbA1c "controlled" if it is less than or equal to 9.0%. The last HbA1c completed in 2025 is the reading Medicare requires the ACO to report.
- Screening for Depression and Follow-Up Plan: All patients aged 12 and older must be screened for depression using an age-appropriate standardized depression screening tool. If the screening is positive, a follow-up plan must be documented within the patient chart either on the date of the screening or within two days. The follow-up plan must include one or more of the following:
  - Referral to a provider for additional evaluation and assessment
  - Pharmacological interventions
  - Other interventions or follow-up for the diagnosis or treatment of depression
- Controlling High Blood Pressure: This measure applies
  to patients aged 18–85 with a diagnosis of hypertension
  and whose blood pressure was adequately controlled.
  Medicare defines "adequately controlled" as less than or
  equal to 139/89 mmHg. The last blood pressure reading
  documented in 2025 is the reading Medicare requires
  the ACO to report.
- <u>Breast Cancer Screening:</u> While CMS has not yet released full specifications for this measure, it is expected to follow similar guidelines to the previous CMS Web Interface Measure. Women should be

screened for breast cancer at least once every 24 months, with a 3-month grace period.

Each EHR system has its own way of documenting these measures in <u>designated fields</u> to ensure they meet the intent of the measure. We strongly recommend that practices contact their EHR company liaison to fully understand the necessary workflows, particularly for the newly added breast cancer screening measure.

# Tis the Season... to Reinforce Security



Silver State ACO reminds all practices that, although we may be busy planning holiday festivities and time off, the "bad guys" do not celebrate holidays by slowing down. We strongly recommend that NOW is the time to review all access and require that staff reset passwords for all systems, programs or websites which contain patient information.
