Foster City Police Captain Jon Froomin Selected to be Police Chief in Coronado, CA



ongtime member of the Foster City Police Department and our community, Jon Froomin has been hired as the Chief of Police for the Coronado Police Department in San Diego County. Jon began his career in Foster City as a Police Explorer in 1983. After serving as a part time Community Service Officer for two years, in 1988 he was hired as a full time police officer. He served as a motorcycle officer and detective before being promoted to Corporal in January, 1997. In November 1998, Jon was promoted to Sergeant where he

served in the Patrol Division. In July, 2000, Jon was promoted to Lieutenant during which time he facilitated the re-writing and certification of the Field Training Program, used to train all new officers. In July 2004, Jon was promoted to Captain. During his nearly nine years as a Captain, he served both the Patrol and Administrative Divisions. Jon learned about all aspects of the Police Department operations and also worked with other City Departments, learning much about their operations as well. He became known for his

ur innocence is lost, however our faith in the people of these United States is unwavering.

I watched with all of you as the horror unfolded in Boston until the conclusion on Friday night. As I watched the residents of Watertown waving, thanking and cheering law enforcement and public safety forces leave, I just pictured the streets of Foster City and how sure I am we would have handled this crisis the same. They embraced the dedication of those that ran toward instead of away from the danger.

When I wake during the night I think of the mother waking in the night to realize her son has died and her daughter has lost her leg. It's such a shock when those thoughts come back. I remember 36 years ago when my husband died in an accident, it was hard to close my eyes to sleep because I knew I would awake to that reality. My heart just aches for her and her family and the families of those we lost.

Those maimed and in need of therapy, both mentally and physically for a very long time, will remain in our hearts. Families are shattered and parents are struggling to explain these events to their young children. As if Sandy Hook wasn't bad enough. I remember having to explain the Challenger disaster in the 80's to my young sons. Even though that was an accident it was very difficult to explain.

Those of us old enough to have grandchildren are saddened by the direction the world seems to be going. While we cannot protect our loved ones or control what they encounter along the path of life, I just hope we can lead by example and make that



commitment to each other. We cannot hide from life but try to enjoy each breath and know we are doing the best we can to make this little part of the world a better place.

This is another example of how being trained in CERT, our Community Emergency Response Team, is so important. Places like San Francisco call them NERTs with the word Neighborhood instead. If there hadn't been all those volunteers at the finish line I think we would have been looking at a far different outcome. To learn more about how to be trained, please email me or go to www.fostercitycert.org. We have well over 300 residents trained for just such disasters. Unfortunately, we say not IF a disaster strikes but WHEN. So please prepare yourself and your family.

I don't want to live in fear and refuse to be terrorized. The qualities we need the most now is resilience, adherence

budget knowledge and management. Jon was a "go to" person within the Police Department.

Jon grew up in Foster City, attending Foster City schools and graduating from San Mateo High School. He attained the rank of Eagle Scout in Foster City Boy Scout Troop 175, before joining the Police Explorer Program as their Charter Captain. As an adult, Jon has devoted many hours to community service through his membership in the Foster City Lions Club since 2000, where he served as President in 2007-08, and his affiliation with the Special Olympics for the last several years. In 2012, Jon was recognized by Special Olympics Northern California as their Sports Volunteer of the Year, by the San Mateo-Foster City School District for his involvement and support of their District, and Samaritan House named Jon their Holiday Program Volunteer of the Year for 2012.

In his effort to earn the Police Chief position in Coronado, Jon had to compete against over 150 other applicants. The City of Coronado is a small beach community with an island feel and home to the famous Hotel Del Coronado. With a population of 25,000 and an estimated 2 million visitors per year, the Police Department has a staff of 44 sworn officers, 23 professional staff, and a large group of dedicated senior volunteers.

FCPD is saddened by the departure of a friend, a colleague and dedicated police professional, but we are also elated that Jon has been selected to serve as Coronado's Police Chief. We know that Jon's years of service here in Foster City will serve him well and we wish him the very best as he heads south to start the next phase of his career as CHIEF Jon Froomin!

PG&E to Start Gas Pipeline Construction Project in Foster City & Installing Smart Meters

PG&E will be upgrading portions of their natural gas pipelines in Neighborhood Number 9. The project will start along Polaris Avenue, Altair Avenue, Saturn Court, Regulus Street, and parts of Leo Drive. PG&E will be replacing older pipes with new modern pipes. The new pipes will be resistant to corrosion and earthquakes. They will also be installing

conduit pipe for future use as the utility company is planning to install new electric conductors. The project will last until late in the summer.

PG&E warns that residents will smell gas as the work is being performed. The utility says that this is normal, but if you have

concerns, call 800-743-5000. They will answer your call anytime during the day or night.

PG&E will be using equipment to bore holes underground where they will place the pipes. So expect to see PG&E and other construction trucks in the area over the next few months. PG&E says that residents should expect noise and dust during the project. After the construction is complete, residents should expect a temporary disruption in their service as PG&E connects homes to the new lines.

 $Smart\,meters\,will\,also\,be\,installed\,when$

the new service is being connected. If you do not want a Smart Meter, you need to call PG&E at 1-866-743-0263 as soon as possible. PG&E says that it will call its customers 7 to 10 days before construction starts in your area. They say that they will need unobstructed access to your meter. If you would like them to relight your furnace, stove or



other gas appliance, an adult must be present between the hours of 1:00pm and 8:00 pm, otherwise, you need to call their customer service center at 800-743-5000 to set up an appointment.

During the project, there will be both parking restrictions and traffic diversions. PG&E plans to place signs warning residents of the restrictions 72 hours before they the impact. Please be on the look out for traffic flaggers around work areas. If you have any questions about the work, call Travis Neff at PG&E at 415-973-3089.

Boat Show at Edgewater Marine



dgewater Marine recently held their boat show at the dock near the Foster City Recreation Center. They showed three Duffy boats, all with the Patented Power Rudder Feature the 22 "Bay Island", 22 "Cuddy Cabin", and the 18 "Snug Harbor" (numbers also denote overall length)

The wind was not a problem with the clear all-around window enclosures. Many people from Foster City and Redwood Shores came by. They took the boats out for a "Spin" literally. since the power rudder allows the boat to spin (turn) in its own length. The windy afternoon showed off the control and maneuverability of the Power Rudder. When asked about the design of the rudder, Michael Terner described the rudder and prop (propeller) as one unit, turning together.

"The prop is mounted on the back of the rudder itself and the electric motor is mounted vertically on top of the rudder post. With both the rudder and prop turning together the effect is similar to the control you get with a gasoline powered outboard motor."

Elia Kahvedjian: The Invisible Photographer

PJCC art exhibit provides rare images of Pre-State Israel

The Peninsula Jewish Community Center (PJCC) in Foster City is proud to present the personal collection of Armenian photographer Elia Kahvedjian (1910 – 1999) providing a rare and unique glimpse of pre-State Israel. Elia Kahvedjian: The Invisible Photographer is on display in the Center's award-winning art gallery through June 30, 2013.

On loan from the Kahvedjian family, the photos capture Pre-State Israel and date back to Kahvedjian's earliest professional pictures taken in 1924. Some of his sessions were planned, but many of these scenes were stumbled upon chance with a camera at his side. Kahvedjian was nicknamed The Invisible Photographer because of his ability to overcome both his shyness and cultural barriers and restrictions in accessing his highly diverse subjects and landmarks.

Kahvedjian's personal story is as compelling as his art. Born in 1910 Ourfa (formerly Armenia, now modern day Turkey), his entire family was captured and killed during the Armenian Genocide. The young boy was marched alongside his mother who, moments before her execution, saved her son by giving him to a Kurdish man. Kahvedjian was then sold to a Syrian blacksmith for five gold pieces and was later homeless for three years until rescued by the American Near East Relief Foundation. He was sent to an orphanage in Nazareth where one of the orphanage teachers was an avid photographer who employed Kahvedjian, then 14, to help carry equipment. This simple chore instilled his lifetime passion for photography.

When Kahvedjian moved Jerusalem in his teens he began working at the photo shop that he would later own. Today his shop, Elio Photo Service, is operated by his son and grandson in the Armenian Quarter of Jerusalem.

SFO Runway Closures may Impact Noise in Foster City



SFO announced that there will be partial runway closures this coming weekend. The closures will run from 10:00 pm on Friday night, May 3rd, and end on Monday morning, May 6th, at 8:00 am. During this time, runway 28R will be closed. According to SFO, the runway would normally be used only for incoming flights during this closure, the arrival rate may be reduced from 60 arrivals per hour to only 30 arrivals per

hour. The reduction could delay flights scheduled for two hours before and after the hours of the reduction. The reduced service is needed to perform construction to comply with federally mandated runway safety programs. The airport wants people to know that the closures could potentially cause temporary changes in noise impacts in the area.
