Fire Chief's Report

Statistics. For the month of November 2011, Rye Fire responded to 34 calls for service of which 29 were EMS related and 5 were fire related. In comparison with previous years this is a 67% decrease from 2010 (57) and a 47% decrease from the five year average of 50. Year to date calls for service are 492 (368 EMS, 124 Fires) which is a decrease of 186 or 27% from 2010. In comparison to the past five years we are showing a decrease of 226 calls for service or 31%.

Holiday Door Judging. On December 13, Steve Bennett, Larry Archuleta and Joe Valdez judged the decorated doors at the Elementary School. This year's theme was "Christmas Around the World."

Vehicle Sale. On December 13, Steve Apgar, CEO of Apgar Ambulance purchased our former Med 22 for the price of \$7,500.

Old Business

Public Hearing - West Hatchet Ranch Inclusion

The public hearing was opened by Mr. Gunny Pagnotta for comments and questions for the potential inclusion of West Hatchet Ranch Phase 1 Inclusion into the Rye Fire Protection District. Chief Daniels noted that Ms. Cathy Ridell has provided updates, via E-Mail, to him for updates to the Board. They include a plot map of the area with possible cistern locations.

Provided a listing of all Phase 1 property owners. Six (6) property Owners have offered locations for cisterns and Chief hasn't reviewed the locations for appropriateness of the sites. A search of the submitted petitions revealed that there were 28 valid signatures on 20 petitions. There are 60 lot Owners or 33%. State Law requires 20%. Chief Daniels noted 1 returned petition and based upon the address the owner lives overseas. The only exclusion request came from Mr. Michael Young requesting that he be excluded. Debra Eiland noted that all deadlines are being met and should be on the ballot. Mr. Gunny Pagnotta opened the floor to Public Comments or Questions. None were presented.

Establishing Sick Leave Bank

Chief Daniels will consult with Debra Eiland to ensure compliance.

Mr. Gunny Pagnotta noted that he received electronically a letter from Mr. Dallas Adair with his resignation effective immediately. No hard copy was present and the exact date of the E-Mail was noted. Chief Daniels, as the Designated Election Official, recommended that the vacant seat

of Mr. Adair be seated as soon as possible because of the upcoming elections. The Board has 60 days from the date of the E-Mail to fill the position.

Mr. Bill Dye has submitted information clarifying the mill levy that was approved last board meeting. DOLA will possibly need to be notified.
