Send it to your local board of elections: Baltimore County 11112 Gilroy Road, Suite 104 Hunt Valley, MD 21031 If you have a criminal record, you can still vote if you have served your prison sentence.



Our branch teamed up with residents at Turner Station to assist in the Census Canvassing efforts in Dundalk on September 19th. Great job to Turner Station team, they canvassed 60 homes in the neighborhood!

# **COMMUNITY VOICES**





On Thursday July 9th, the NAACP attended the Police Reform Rally in Towson. The Baltimore County Council hosted the rally and invited community leaders to speak. Roland Patterson, NAACP Legal Redress Chair was a featured speaker that spoke about the necessity of changing the system, procedures and the use of force in the police department.

## Police Reform Bill 96-20

The Baltimore County Council had a virtual Legislative Work Session on September 30th. There were over 30 people that testified in support of the Police Reform Bill 96-20. NAACP Baltimore County and sixteen other community organizations were in attendance.



On Monday, October 6th, the Council reconvened to vote on Bill 96-20. It passed 6 to 1!! Bill 96-20, is called the Strengthening Modernization, Accountability, Reform, and Transparency (SMART) Policing Act. The SMART Policing Act bans the use of chokeholds, prohibits the hiring of a police officer fired for using excessive force in another precinct. The Act mandates that officers take annual training in de-escalation and requires officers to intervene when others use excessive force. We thank Councilman Julian Jones for introducing the bill, his hard work and tireless efforts in conjunction with the Baltimore County Council and the community for bringing the SMART Policing Act into fruition. This is a victorious step for Baltimore County!

## **NAACP** Annual Convention

The NAACP held it's Annual Convention from September 13th-26th. The virtual Convention featured the nation's leading activists, policymakers and speakers for justice such as Angela Rye (Attorney, CNN Commentator), Stacy Abrams (Fair Right), and Lee Saunders (CEO, AFL-CIO).

The first week topics of discussion included the future of the labor and workforce, a new agenda for the black health and wealth of America, mass incarcerations, the Millennials and Generation Z campaign to vote, and the ACT-SO Competition.

The second week focused on Youth Regional meetings. September 25th featured the signature event of the week, a conversation with Vice Presidential candidate, Kamala Harris.
