#### **Home Equity Loan & Home Equity Line of Credit (HELOC)**

• Home Equity Loans allow you to access funds by using your home's equity. Your home's equity is the current market home value minus the outstanding balance of all liens on the property and can build over time as you make payments towards your mortgage balance or add value to your home. This type of loan is usually a "closed-end" loan term where we provide you the funds upfront and you repay the loan for the specific term. When applying for a HELOC, you get a credit limit, and you can borrow up to that amount. As you pay your balance down, you can borrow again, similar to a credit card. These types of loans are often used for home renovations, debt consolidation, and any major ticket item.

#### **Come Home Purchase Loan**

• This type of loan is a first mortgage loan and is the primary or initial loan that is obtained for a property and is usually a fixed rate. You can also use these types of loans to re-finance or if you're wanting to renovate your home.

# **Fixer Upper Loan**

Fixer Upper Loans are commonly used for a "Fix & Flip" home. This loan will offer you
enough money to buy a new home and fix it up, based on how much it's expected to be


