OUR YEAR IN REVIEW

We are part of a 90,000-member strong national organization that gives us influence, recognition and support. Our members matter – our voices are heard. We partner with other organizations to help strengthen reproductive rights and encourage gun safety. We advocate effectively locally, in Tallahassee and in Washington, DC.

By The Numbers:

We have over 700 members in our section.

We had 80 members join just this year.

We opened and/or stocked 4 Kids Community Closets in local elementary schools that have a total of almost 3,000 students

We tested over 225 preschoolers for vision issues in 3 pre schools.

We tutored elementary students as part of the Hagen Ranch School and Literacy Volunteers.

For anti sex trafficking outreach (our chapstick program)- we made a total of 110 outreach visits that helped identify 2 runaways and several trafficked teens.

Our Holiday on Wheels program visited at 6-7 senior facilities for Rosh Hashanah, Chanukah and Passover to share the holidays with residents, who number a total of about 500 people

Food Insecurity – answered by NCJW SE Atlantic section with donations of food, gift cards and cash that allowed us to donate 60 bags of food to needy families over the summer when they can't take advantage of school meals.

Our Speaker's Bureau informed the community on how to recognize and take action to stop sex trafficking 6 times at venues from church to synagogues to men's clubs and political clubs.

We awarded a \$1,000 Scholarship to a high school senior to encourage her leadership potential.

We helped people register to vote before the mid-term elections. We worked hard to get Amendment #4 passed which restored the right to vote for 1.4 Million former felons.

All of these successful actions took many volunteers- most of whom volunteer for multiple activities. We have over 100 active volunteers, including 40 who serve on our Board of Directors. We need all of you!

Want to Help Register Amendment 4 Voters?

Last November, Florida voters approved Amendment 4, restoring voting rights to potentially 1.5 million citizens who had been convicted of felonies, but had served their sentences. During this year's legislative session, however, a bill was passed that required ex-felons to pay fines, court costs and restitution before they could vote.

There are several court challenges to the law, especially because of its impact on poorer citizens. In the meantime, several groups are registering eligible voters, when possible.

NCJW-SE Atlantic member Debra Sacks is coordinating our involvement. End Child Detention Now!



This Father's Day, many of us will be with our families and friends. Meanwhile, south of Miami, approximately 3,000 migrant children are being held in a detention center by U.S. Immigration officials, apart from their families and unable to leave.

The **Homestead Children's Detention Center** is run by a for-profit company that receives \$775 per child per day – giving it little incentive to reunite children with their families. In Homestead, children are living in inhumane conditions. They are not allowed to hug each other. They sleep in rooms with hundreds of beds. The Florida state services do not reach the facility because it's on federal land. Normal standards for housing detained children do not apply because Homestead is classified as a "temporary shelter" and therefore exempt from standard regulations.

The **Religious Action Center of Reform Judaism** joins the **American Friends Service Committee, United We Dream, Bend The Arc, NCJW, Truah**, and other organizations in calling for the closure of Homestead, the ending of using influx facilities for detention, the reuniting of the children with their sponsors, the ending of a collaboration between Health and Human Services and the Department of Homeland Security, and an end to detention and separation of families. **If you can attend any of the events described in the link below please let us know**
