2 parishioners were present.

- 1) **To receive and consider apologies for absence.** Apologies received from Cllrs Humber and Merritt. In Cllr Humber's absence, Cllr Dan Blake chaired this meeting.
- 2) **To receive Declarations of Interest on items on the Agenda. (Localism Act 2011).** Cllr Alvis declared a personal interest on agenda item 4b (planning) as his nephew owned the land cited in the application.
- 3) **To receive comments and concerns from the public for any items on the agenda:** The public were invited to speak at the relevant points in the agenda, if they so wished.
- 4) **To consider and note planning applications and agree responses:**
For consideration
 - I. **Planning Consultation: 19/00192/FUL | Retention of an agricultural barn and associated works (Revised scheme Ref: 18/00449/FUL) | Land On The East Side Of Broadway Road Stanway Cheltenham Gloucestershire):** The Council were not quorate to consider this application. However, it was to be noted that **Councillors agreed with the objections raised by Stanway Parish Council**
 - II. **Planning Consultation: 19/00151/FUL - Culls Meadow Evesham Road Toddington Cheltenham:** Retention of hand car wash (retrospective application): Following brief discussion, **Council agreed there was NO OBJECTION to this application.**
 - III. **19/00241/CLP | Installation of four roof lights on rear elevation and conversion of loft space. | 2 Church Meadows Toddington Cheltenham Gloucestershire GL54 5DB:** It was unclear if this was actually a new application or an amendment to a previous one. **Council agreed there was NO OBJECTION to this application.**
