RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

Central Florida Rodeo Association 2018

I/WE HEREBY RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter, participants, rodeo association, sanctioning organization or any subdivision thereof, arena operator, arena owner, officials, other participants, any persons in restricted area, promoters, sponsors, advertisers, owners, lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose therein referred to as "Releases", from all liability to the undersigned, my/our personal representatives, assigns, heirs, and next of kin for any and all loss or damage and any claim or any demand on account of any injury to the participant included, but not limited to death whether caused by the negligence of the "Releases", or otherwise while the minor is in or upon the restricted area and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

The Restricted Area is defined as the arena, chutes, staging area, approaches thereto and all walkways, concessions and other areas appurtenant to any such area where any activity related to the event shall take place.

I/WE will inform and instruct the said minor participant that upon entering any restricted area the minor must continuously thereafter inspect such restricted area and all portions thereof which the minor enters and with which he comes in contact and I/WE further warrant that the minor's entry upon such restricted area or areas and his participation, if any in the event constitutes an acknowledgement that he (minor), has inspected such restricted area and that he finds and accepts the same as being safe and reasonable suited for the purpose of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and if he feel anything unsafe, he will immediately advise the officials of such and will leave the restricted area.

The undersigned expressly acknowledge and agree that the activities of the event are very dangerous and involve the risk of serious injury and/or death and /or property damage. Each of the undersigned parents or legal guardians for the minor participant agrees to indemnify and save and hold harmless the "Releases", and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in or upon the restricted area or in any way competing, officiating, observing or working for any purpose participating in the event and caused by the negligence of the "Releases" other wise.

THE UNDERSIGNED PARENTS OR LEGAL GUARDIANS HAVE READ AND VOLUNTARILY SIGN THE MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT AND FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE. **If participant is under 18 parent or legal guardian must sign**

Central Florida Rodeo Ground Rules

- 1 You must be a member and come to at least 5 rodeos and compete at finals to be eligible for banquet and prizes. unless you have doctors excuse. You must be in each event 5 times.**
- 2 In order to go to finals in your event. You must be in event at least 5 rodeos to be eligible for banquet and prizes.**
- 3 60.00 membership fee You can run as a non member, you run for money only, no points no banquet no prizes.**
- 4 Raffle of \$200.00 per family mandatory. Money due at March Rodeo.**
- 5 Please no alcoholic beverages at rodeo.**
- 6 In breakaway events, Tots no time limit 2 throws, Junior 1 minute, Sr. 1 min**
- 7 Team roping Tot no time limit 3 throws, Junior, SR,1 minute Goat Tying Tot no time limit, Jr, SR 1 minute,**
- 8 Western attire (Please) Hat, Boots, Long sleeve shirt. If you are not dressed in western attire and enter arena you will receive a \$20.00 fine.**
- 9 If you have an issue with your event. Go to judge immediately to settle issue as soon as possible.**
- 10 If you do not here your name called in an event see judge immediately.**
- 11 (Call in), We have a (one time) call in which is Monday before 1st rodeo. If you are not coming to a rodeo you MUST call out and call back in to next rodeo you are coming too. If you do not do this it will be a \$20.00 late fee. Which will go to prizes for end of year.(You must attend at least 5 rodeos to be eligible for banquet and prizes) Must call in for finals too. Monday after last rodeo 4:00 to 9:00 863-581-9654**
- 12 You must be signed in 30 minutes before rodeo starts. Must call 863-581-9654 if running late.**
- 13 Call in is mandatory!!!! Call out is mandatory!!!!**
- 14 If you are drawing out or entering an event you must call this in the Monday before rodeo. If you are coming Friday night YOU MUST CALL IN.**
- 15 The finals is not counted as a rodeo**
- 16 NON-MEMBERS MUST CALL IN EACH MONTH**
