Lee County Yard Waste Regulations

- Do not place out for pickup more than 24 hours early
- Yard waste must be containerized (50 pounds or less), or securely tied into bundles not heavier than 50 pounds and no longer than 6 feet in length.
- Up to 50 pounds of unbundled palm fronds may be placed at the curb. Any excess palm fronds must be tied into bundles, each weighing 50 pounds or less.
- When using plastic bags, make sure that the contents can be easily identified by the refuse truck driver (leave a twig or small branch sticking out).
- Call 239-337-0800 for a cost estimate for large-scale yard waste disposal projects when containerizing or bundling is difficult.

Deed of Restrictions Section A-15: Pets must be on a leash at all times when being walked outside of the owner's property boundaries. The pet owner is responsible for picking up all animal waste from their pet at all times. This includes the common areas! Subject to fining.

Tips From South Trail Fire And Rescue

Hurricane Fire Safety. Practicing fire safety is a yearround concern; however, hurricane season in Southwest Florida brings additional fire safety considerations. During a hurricane, you may be on your own

to protect your family from fire. When sustained winds reach approximately 40 mph, it is unsafe for fire trucks to be on the road. Immediately after a hurricane, downed trees and wires may also delay emergency response. As you make your hurricane preparations, keep in mind the following safety tips.

• In case of a power outage, use battery-operated lanterns, flashlights, or glow sticks instead of candles. The National Fire Protection Association found that in one-third of fatal home candle fires in 2005 through 2010, candles were used for light in the absence of electrical power. When candles are used during a power outage, people are more likely to leave candles burning unattended and to leave candles burning in multiple rooms.

- Check your home for working, battery-powered smoke alarms. If the smoke alarm is wired into your home's electrical system, check that the alarm has a working backup battery. The battery ensures that the alarm will work even in a power outage. If a hard-wired smoke alarm does not have battery backup power, install a new hard-wired smoke alarm with a backup battery or install a separate battery-powered alarm. Backup batteries that last for 10 years are available.
- Equip your home with a fire extinguisher. All adults in your household should know how and when to use a fire extinguisher. Fire extinguishers can be used on small, contained fires, following the PASS acronym: Pull the pin, Aim at the base of the fire, Squeeze the handle, and while spraying, Sweep the hose from side to side.
- Make and practice a special fire escape plan if you install hurricane shutters on your windows. Remove the shutters as

soon as possible following the storm. Shutters that keep you safe during the storm can trap you inside your home in a fire.

• Use portable generators safely. The Consumer Product Safety Commission reports that between 1999 and 2012, 800 persons died from carbon monoxide (CO) poisoning attributed to portable generator use. Place generators outside, at least 20 feet away from any window, door, or vent openings to your home or to your neighbor's home. Never use a generator in any enclosed or partially enclosed area such as a garage, shed, or lanai – opening doors and windows will not prevent CO buildup. Install CO detectors in your home.

For generator safety information, free smoke alarms, batteries, or for fire extinguisher training, call 936-5281. Fraud Alert

Unsuspecting Seniors Take A Chance, Lose Cash

Scammers pretending to be with the "Jamaican Lottery," "Mega Million Lottery" and "Publisher's Clearinghouse" have been busy preying on the elderly in Southwest Florida over the last several months, hoping to take advantage of vulnerable seniors by convincing them they've won a large jackpot. Smooth talking con artists promise "supposed winners" big bucks and a new car after they pay the taxes and shipping fees via a wire transfer. Once the money has been sent to the thief, it is impossible to recover. As the scam grows, it becomes a vicious cycle of relentless phone calls, threats, harassment and possibly the loss of the victim's life

This scam and others like it are taking a large toll on our

seniors not only financially, but emotionally and physically as well. These brazen con artists are raking in millions and millions of dollars from our neighbors, friends and family members. Here is what you must know:

- If you did not enter a lottery you will not win one.
- There is no legitimate sweepstakes or lottery that will ever ask you to pay in advance before receiving your
- Participating in foreign lotteries while in the United States is illegal.
 - Never ever send money via wire transfer to someone

you do not know.

• Beware of the 876 phone exchange unless you have a friend or relative who lives in Jamaica. This area is known for targeting aging U.S. citizens.

If you are the caregiver or loved one of an older adult it is imperative you talk to them about this scam and let them know the dangers of getting involved. It's important to remember that victims are groomed by these predators and you may have to intervene.



Blood Donation Benefits Donors

At any given time approximately 38 percent of the American public is eligible to donate blood but less than 10 percent actually roll up their sleeves and give the gift of life.

The American Red Cross notes that every two seconds someone in the United States

needs blood. "That's why donation is so important," says Susie Nystrom, Blood Center director. "Lee Memorial Health System needs 800 units of blood on any given week to sustain the supply for the number of patients we serve. That number can be significantly higher during the winter months when we have an influx of residents and tourists."

Lee Memorial Health System relies on local donors, and if supplies drop, must purchase blood from other areas throughout the state. The goal is to draw from the local blood supply as much as possible.

"It doesn't matter what blood type you have," Susie says. "We need it. We especially need O-, A- and AB- because those are rare compared to A or O, but we appreciate any donation." O- is a universal donor, with anyone of any blood type able to receive a donation.

Donating doesn't benefit only the recipient. Donors also see rewards from each donation. "Donors receive a mini physical," Susie says. "They receive information about their blood pressure, cholesterol levels and heart rate. In addition, donating blood helps keep iron levels in check. Each donation depletes the iron supply by about a quarter of a gram, which donors make up from the food they eat following the donation. Research shows that decreasing the amount of iron in otherwise healthy individuals is beneficial to blood vessels and diseases related to abnormalities in blood vessels."

Blood Donation Includes:

- Filling out a short questionnaire
- Receiving a "mini physical"
- Donating blood (three to 10 minutes)

"The entire process takes 40 to 50 minutes and is painless," Susie says. "Best of all, donors get a sweet treat at the end of the donation and the feeling of knowing they helped save a life."

Real Estate Market Update

How's the real estate market?** When people ask about the real estate market, they usually are asking, "What is my property worth?" Every house is different, but "the market" is the most influential factor. Even if you have no plans to move, I suspect your mind does a new calculation each time a home in the neighborhood goes on the market or closes.

So what is happening in the market? According to data from Florida Realtors, which comes through the multiple listing services used by Realtors, the outlook is mixed; however, the Eagle Ridge data is positive.

Here Are Some Facts From Lee County For The Past 12 Months As Of March 2016:

- Closed residential single-family sales are down 13.2 percent. Closed condo sales are down 18.6 percent.
- Number of single-family homes on the market is up 8.4 percent. Condo homes are up 20.2 percent.
- Median days on the market for single-family are down 5.7 percent. Condo days are down 7 percent.
- Median sales price for single-family is up 4.2 percent. Median sales price for condos is down 4.2 percent.
- Pending sales for single-family are down 12.4 percent. Pending sales for condos are down 17.1 percent.

Listing a property is one thing, selling it is another. The truest story comes from those homes that have sold. In the same 12-month period in Lee County, the sale of singlefamily homes in various ranges changed as follows:

- \$250,000 to \$299,999 down 13.2 percent
- \$300,000 to \$399,999 down 5.3 percent
- \$400,000 to \$599,999 down 4.8 percent

Condo sales in the \$100,000 to \$250,000 price range increased an average of 24 percent with the highest change in the \$200,000 to \$249,999 range.

So what does this mean for us in Eagle Ridge? As of today, there is limited inventory:

• Four active single-family listings with prices ranging from \$319,000 to \$362,000.



June is a warm month in Florida. It is the kind of month that you just want to have a glass of wine and a salad for dinner. I have just the salad for you. It can be made ahead and served outside on the lanai. Enjoy.

Feta Cheese Pasta Salad

3 cups uncooked pasta (your choice of size and shape)* 2 tablespoons lemon juice

½ cup olive oil

Salt and pepper to taste

1/4 teaspoon dried oregano

1 clove garlic, crushed

2 tomatoes cut in wedges 1 cucumber, peeled and sliced thin or chunky

1 green pepper sliced in thin strips

15 black olives (can be cut in half)

1¹/₄ cup crumbled feta cheese

8 to 10 radishes, sliced thin or chunky

1/4 cup green onions, sliced

2 tablespoons fresh parsley, chopped

Directions:

Cook pasta as per direction on package. Drain well and cool.

Combine dressing - oil, salt, pepper, oregano, lemon



juice and garlic in small bowl. Wire whisk until blended.

Combine pasta, tomato wedges, cucumbers, olives, green peppers, feta cheese, radishes, onions and parsley in large bowl. Pour dressing over salad and gently coat pasta. Serves four to six.

This Agreement was received on April 15, 2016. I will place it in the official file books for Eagle Ridge property Owners Association. The piping and inlets in the 3 Condominiums are not included.

2. I request a motion on the Proposal and Agreement from Eric M. Cole of Converged Services, Inc. (C.S.I.) to provide consulting services to develop bid specifications and receive quotes related to Broadband, Cable/Satellite, TV, Telecom and Security Alarm Monitoring. (Discussion and vote on the motion.)

Ed Schuler: I want to make a motion to approve giving the president authority to enter into an agreement with CSI to develop bid specs and receive quotes on fiber optic cable/Internet packages from four or five qualified bidders. He would have our approval to enter into this agreement after completing due diligence he feels necessary before signing. It is our understanding that we are under no obligation to CSI if we later choose not to proceed with any of the bids that they develop on our behalf.

After the bids are received, the committee would select a bid that appears most beneficial to the majority of the residents. The selected bidder package would be submitted to the residents by mail for a vote. Then as previously stated, if we don't go with the project, we have no financial obligation to CSI.

From the audience: Are we obligated to use any of their bidders, if we don't feel their bids are good?

Ed Schuler: No we don't have to use any, if we don't feel the bids are good. We are under no obligations to either CSI or the bidders.

Peggy Watts: I am upset. I don't like someone telling me what cable company I must sign up with. I don't like to be told I have to use this particular cable company. I will consider legal action if this occurs.

Hewitt: Do I have a second for this motion?

Hewitt: There are no seconds to this motion. It does not carry.

Susan Stark: Why don't we set up a committee to look into this matter? Ed Schuler: There are three people on the committee at present.

Luther Ward: We will lose our freedom of choice in this matter if we have to take what is offered.

Ed Schuler: It will be voted on by all residents.

3. Ed Schuler requested a motion to pay Seabreeze Communications, who prints our monthly newsletter \$50 per issue for a PDF file from the newspaper. We can then place the file on our website so that the residents can get the newspaper anywhere they happen to be. The cost would be \$600 per year or \$1 per door per year. An additional benefit would be an archive of past issues that are available to the residents.

Vice President's Report: John Spiegel

1. The Second District Court of Appeal ruled unanimously on April 11th that the trial court decision in ERPOA v. Mouracade, was correct. ERPOA won the case at the trial court. An additional motion for an award of appellate attorney fees will be filed and the amount to be awarded will be determined by the trial court. Once the appellate attorney fee award is reduced to a final judgment, ERPOA will undertake to collect the owed attorney fees.

Man from audience: What is the total amount that we have spent on this

John Spiegel: The first and second litigation has cost somewhere around \$36,000. The fees we incurred for the Second District Court of Appeals will also be recovered.

2. The "Condos v. ERPOA" case remains pending. Counsel for ERPOA filed a motion to dismiss the action. That motion is presently scheduled to be heard on June 7, 2016. I will keep all updated after the scheduled hearing.

Six Ways To Prepare Now For Hurricanes

The worst thing that people who live along coastlines can do is not to prepare for tropical storms and hurricanes.

According to the National Hurricane Center, the two key factors contributing to weather safety during hurricanes are preparing in advance for the risks and to act on those preparations when alerted by emergency officials.

The director of the National Hurricane Center Rick Knabb and AccuWeather Hurricane expert Dan Kottlowski outlined certain precautionary steps that people in areas impacted by hurricanes and tropical storms should take.

1. Evacuation Planning

The main reason people have to evacuate during hurricanes is from a storm surge, which is an abnormal rise of water generated by a storm's winds that can reach heights well over 20 feet and can span hundreds of miles of coastlines, according to the National Hurricane Center.

"Evacuation planning is number one on the list," Knabb said.

Knabb urged that people find out today if they live in a hurricane evacuation area, which is an area in which residents must leave their homes in the event of a hurricane.

Local governments provide the public with information about evacuation areas and the evacuation plans and Knabb recommended that people review this information in advance.

"Some people will actually test the evacuation route in good weather," Kottlowski said. "Waiting until the day of the hurricane isn't a smart idea since everyone will be in a heightened state of anxiety."

While people who live in storm surge areas fall within areas that are urged to evacuate during a hurricane, people who live outside of these zones should still look into safety precautions during a hurricane.

Those who live in mobile homes and high rises may also have to evacuate even if they do not live in an evacuation area, Knabb said.

"It's not just a beachfront problem," he added.

Pet owners should also have an evacuation plan for their pets. Many shelters offer places to keep pets.

2. Buy Supplies.

The most important thing that both Knabb and Kottlowski stressed was buying supplies well in advance and keeping those supplies on hand should evacuation be required.

"If you wait until the hurricane is on your doorsteps, you are going to be waiting in long lines and they could even be out of the stuff you need," Knabb said.

Those living in evacuation areas should keep a hurricane kit handy that is stored in a way that is easy to grab and bring to an evacuation shelter.

While evacuation shelters do provide supplies, Kottlowski

said, "Shelters can get overrun and may not have enough supplies." These kits should include water, food, blankets and clothing.

Ready, a campaign that provides emergency preparedness guidance for the U.S. Department of Homeland Security, includes a number of other items in their hurricane kit:

- First-aid kit
- 2. Battery-powered or hand-crank radio
- Flashlight and batteries
- Whistle to signal for help 4.
- Local maps

3. Check Insurance Coverage.

Property owners and renters should be sure to insure their homes against flooding; something that Knabb said many people do not realize is not a part of standard home and renters insurance.

Tenants and homeowners can contact their renters or home insurance provider to buy flood insurance, and they should do so even if they do not live right along the coastline.

"People might think that if they don't live on the coast, then they won't have a flooding problem," Knabb said. "But if it can rain, it can flood."

Car owners should also contact auto insurance companies and move their cars into an off-site location or secured building.

"You won't be able to take every vehicle you own to the shelter, but if you leave the vehicle outside, it could be seriously damaged," Kottlowski said.

4. Make Copies Of Important Documents.

Those living in or near hurricane areas should make copies of proof of ownership documents of any property not limited to their homes, cars and boats.

These documents can be stored in the hurricane kit or in any safe location that does not risk being damaged during the hurricane.

"If a hurricane levels your house, you have to prove that it is your house," Kottlowski said.

5. Protect Your Home.

Residents and tenants should inspect their homes to confirm that there is no damage that a hurricane could increase.

Any issues with the overall structure should be repaired, including loose shingles or damaged roofs.

"Any possible compromises to the roof or house will become an open avenue for strong and gusty winds," Kottlowski said

Residents with yards should also make a list of anything

lying on the ground outside that could get tossed into the air and become debris during high winds.

Kottlowski also said residents should purchase supplies, including plywood to cover windows and extra security to keep doors from blowing open, in advance, to secure their homes from damaging winds.

6. Back Up Your Electronics.

Aside from keeping extra batteries and chargers around during a hurricane, people are also encouraged to back up any electronic devices.

Knabb said data should be stored at an off-site location so that data can be recovered if something were to happen to the physical computer or device during a hurricane.

Businesses should take particular caution in backing up information and sending that information to a remote site.
