the Water Safety co-chairmen, our guards' maintenace practices, and volunteers for their fine efforts this year.

- 9. <u>Security</u>. We expanded our program of employing uniformed security guards to reduce trespassing on our beaches, in fishing activities and prevent vandalism. This had very good results. We will maintain the service and expand our co-operative effort with the Village police activity.
- 10. Activities. We had very good participation in the Christmas Decoration, Water Carnival, Summerfest and Venetian Night activities. Attendance at all the affairs was the largest in years, aided by good weather. Our thanks to all who supported these programs.
- 11. <u>Community</u>. Our working relationships with Village and County officials continues to expand. The Fire Department conducted a water safety exercise with our life-guard staff during the summer to increase coordination. The Public Works department has expanded its program to improve storm water drainage systems in our area.
- 12. <u>Volunteer Contributions</u>. We are indebted to the many members who served as directors, chairmen and officers, and who accomplished repair, cleaning, activity planning and support. Our use of contractors has increased as a result of the reduction in time available for volunteer support. However, as you reflect on the list in our minutes of neighbors who have given substantial amounts of time, add your personal thanks to them for their efforts. Our Lake, beaches and community are all better this year thanks to you.
