Here's the scoop on our move

Welcome to the Trustees corner! In this edition, your Board of Trustees want to give you some very important information regarding the new location and the upcoming move.

WE MUST VACATE SOON

In last month's Trustees Corner, we talked about the funding process for the move and how the Aerie is reliant upon money coming from Sound Transit to help us pay for move-related expenses and construction. It's a fairly slow process. We have been extending our lease with Sound Transit on a month by month basis as we wait for the monies to trickle in.

As of this writing, Sound Transit has given The Puyallup Eagles Aerie #2308 a must vacate date of Jan-

uary 10, 2020. It is very likely that the new location will not be ready for occupancy by then and the Aerie may have to **TEMPORARILY** stop operations for a month or two. Accommodations will be made for necessary meetings.

CITY COUNCIL MEETING

There is an open-to-the-public, Puyallup City Council meeting on Tuesday, December 10. Meetings typically begin at 6:30 p.m. and are held at the William S. Stoner Council Chambers located on the fifth floor of Puyallup City Hall, 333 S Meridian. In this meeting the council will hear Sound Transit's request for the street vacation of 3rd Avenue NW. Sound Transit has not yet submitted for demo, building or site development permits. Anyone that has an interest in the process is encouraged to attend.

While the prospect of being without an Aerie for a short time is disappointing, the result of a new, modern beginning to Aerie #2308 is exciting. Until we are fully moved in to the new building, we ask all members to remain positive. If there are any questions or concerns, please direct them to a Trustee. We will make it through this!




