## IV. CORRESPONDENCE:

- A. Kent League of Women Voters Bill received a letter from them asking for information on the Edinburg Township Fire Department levy. He will fill in the financial part but asked if the Trustees would like to state the reason for the levy. Mr. Swauger of the fire department stated it was for staff wages only. All agreed that the response should say that it is for fire equipment and staffing in summary, and not need to be the full verbatim resolution.(response was limited to 50 words or less).
- B. Election Board They have informed Bill that the information for the levy has been posted.

# V. OLD BUSINESS

- A. Zoning Rules for Township Mowing —Sandy said a certified letter would first need to be sent to the owners of the property informing them of the violation. They would then be given a set amount of time to mow and if they did not comply the Township would mow it --up to two times per year—she thinks, and assess the owners' taxes to pay for it.
- B. Turnout Gear Replacement for State Route 76 Spill Bill asked Mike if anything has been sent to the Prosecutor. Mike said, per the Prosecutor, they need to finish the itemized billing before he can forward the rest to the Prosecutor.
- C. Comp Time Bill talked to the UAN representative and they said that the system can accommodate a comp time accrual. The Trustees would have to set a maximum of carryover of comp time for employees and any use restrictions. Bill will write up a brief description and email it to the Trustees to consider for approval at the next meeting. Diane suggested starting this at the beginning of the new year. Bill agreed it would be easier waiting until then.
- D. Nathan and Zoning Volunteer Follow-up There was no action taken at this time.
- E. Bids on Road Repair John said that he has presented the two bids received so far and the pictures, etc. to the Assistant Prosecutor and he has not heard back from him. Diane said that the Trustees would need to instruct Chris Meduri to send the

### VIII. DEPARTMENT REPORTS

- A. Kevin Biltz Roads / Buildings / Cemetery / Park
  - -- They have been patching roads.
  - --The State has been fixing the guard rail on Porter Road at the State Route 76 bridge -- there was a bad wash out on the southeast section.
  - --The dry hydrant has been put in at the Scott Simmons house. He thanked Wade Pol for bringing his excavator machine and an operator to help with this and doing a real nice job. This was a donation to the Township.
  - -- They have been mowing at the Cemetery and Park.
  - --John announced that the security camera is now in operation at the recycling center. One person has been served a \$100 citation so far for dumping trash by the recycling bins. The Trustees would like to know if the Township will receive the money from this citation which would help offset the extra cost of the trash removal. Bill or Kevin will talk to the Sheriff.
- B. Mike Pittinger Fire Department
  - -- Unit 1513 Packing

Resolution: 2016-0086. A motion was made by Diane Austin to <u>accept the estimate</u> <u>not to exceed \$1,303.80 and repair the packing on unit 1513</u>; this was seconded by John Hayes. Roll call shows: John Hayes, yes; Diane Austin, yes; Jeff Bixler, absent.

- C. Sandy Templeton Zoning
  - --She made/received four phone calls.
- --She issued three zoning permits: a storage building, an agriculture building and a garage.
  - D. Bill McCluskey Fiscal Officer
    - --He presented the financial reports.
    - --He reported that additional funds are needed to pay for dispatch collection fees for the remainder of the year. Based on the fire department report the Township is averaging 33.7 calls per month and the current budgeted amount will not cover it.
