Engineers Report:

As Discussed:

- 1. Replacement Upgrades of Controls at WWTP
 - Installation is complete and grant funding was received.
 - ➤ Holding 10% retainage from Kappe until the software update is completed.

- Software update is expected to occur around the end of the year.
- Commonwealth Financing Authority requires cancelled checks.
- 2. Rotary Press Update
 - Scheduled to have a mobile press demonstration at the WWTP Spring 2023 by Tim Tomasko.
 - Project requires a Part II Permit, which can take 6-10 months.
 - Lead time for the press is an additional 8-10 months.
 - Construction would start in summer of 2024.
- 3. Grant Information
 - A. COVID-19 ARPA H2O Grant
 - ➤ \$100.00 application fee, Early December deadline, Grant must be between \$500,00-\$20,000,000.00
 - > 50% match- matching can be from other funding sources.
 - B. COVID-19 ARPA Small Sewer and Water Grant
 - > \$100.00 application fee, early December deadline
 - Frant amount must be between \$30,000.00 \$500,000.00
 - ➤ 15% match- match can be from other funding sources
 - Letter of support was issued by the Cambria County Planning Commission.
 - > Grants to be submitted prior to the December meeting.
- 4. Resolutions 2-2022 and 3-2022
 - ➤ Resolution 2-2022 CMSA request an PA Small Water and Sewer Program Grant in the amount of \$425,000 from the Commonwealth Financing Authority to be used for Sludge Press Upgrade.
 - Resolution 3-2022 CMSA request an H2O PA Grant in the amount of \$435,992.00 from the Commonwealth Financing Authority to be utilized to upgrade the sludge press.

Motion made by Dennis Beck 2nd Scott Selip to accept Resolution 2-2022 for \$425,000.00 and Resolution 3-2022 for \$435,992.00 and to authorize the Engineer apply for both grants. Roll call, all in favor, Motion passed.

Motion made by Edward Myers 2nd Rita Butterbaugh to authorize the secretary to write a letter(s) of Funds Commitment for \$223, 608.00 for the H2O Grant and a Letter of Commitment for \$252,600.00 for the PA Small Water and Sewage Grant. Roll call, all in favor, Motion passed.

➤ The Engineer to submit Form 43 to the Department of Environmental Protection, using Mostoller Landfill for sludge disposal.

WWTP Report:

- Flow meters downloaded, DMR's submitted.
- ➤ Replace batteries in flow meters.
- Annual flow meter calibration was preform by Meter Guy.
- The flow meter in MMH008 (coming out of Lilly) was recalibrated also, while recalibrating the technician notice a fair amount of grit in the sewer main. The sewer main needs to be jetted out staring one or two manholes above the MMH008. Dave Eckenrode can jet the sewer main, the roadway to the metered manhole is overgrown and difficult to navigate.

Motion made by Edward Myers 2nd Scott Selip to authorize the Plant Manager to contact Weber Property Services to clear the access road to the Metered Manhole 008. Roll call, all in favor, Motion Passed.

Comparison between Kappe and Uveon for pricing on ultraviolet light bulbs for the disinfection system.

Motion made by Dennis Beck 2nd Edward Myers to authorize the plant manager to purchase the ultraviolet bulbs from Uveon. Roll call, all in favor, Motion Passed.
