Minutes of April 5, 2021

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Jed Lamb. Also present were Walter Rollin, Dennis Finkel, Dimitri Szynal, Matt Combs, Alexis Honoshofsky, Tyler Honoshofsky and Sheila Lanning.

Motion by Rollin with a second by Lamb to approve the minutes of the regular scheduled meeting March 15, 2021 meeting as written. Roll call: two yeas. Checks 9450-9470 and payments totaling \$20,798.68 approved for payment. *Motion* by Rollin with a second by Lamb to approve the March 2021 financial report with year to date revenue of \$208,803.31, expenditures of \$76,916.82 and bank balances of \$439,455.46. Roll call: two yeas. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2021-34* for Mercy as our TPA for the Federal CDL Clearinghouse. Roll call: two yeas.

COMMITTEE REPORTS:

WATER BOARD- Lamb: meeting coming up 4/14/2021

LORCO- Lamb: meeting coming up but unable to attend, if Holmes or Rollin would like to attend that would be ok. Will try to zoom in for few minutes.

AMBULANCE- Holmes: none

SHERIFF- 57 calls in March. Szynal stated the Sherriff thanks Rollin for the receipt of masks.

FIRE- Rollin: The new addition will soon be turned over to the Fire District.

OPWC- nothing

SWAC- Finkel: Engineer estimates for two culvert replacements on Stewart Road. One at \$3,100.00 for repair and the other at \$10,500.00 for a replacement. Finkel: the repair should be estimated at \$3,500.00.

ZONING BUSINESS/NEWS- Finkel: things in progress at the moment for C&J Motorsports. Discussion on the business re-applying at zero cost. Also discussed sending out certified letters to annual conditional renewal parties. Noticed the web site has old information as it relates to the Zoning Board. Lanning: need a way to continually update the website so it stays current. Will send the roster so the Zoning Boards can be updated.

THRIVE & OFFICE ON AGING- Lamb: attended the Lorain Community Health Board Advisory Board annual meeting. Passed out the annual report, budget and minutes. The board voted on officers.

CEMETERY- Lanning: attended the 3/25/2021 zoom meeting on appling for a CDBG grant for sidewalks. Received an estimate from the Lorain County Engineer for the sidewalk. Sold one double lot.

ROADS and EQUIPMENT: Finkel: The original Gradall is leaking at torque seal, the new Gradall has some minor things that need repaired. Called Southeastern to get estimate on new Gradall repair costs. The rest of the equipment is up to snuff.

RECYCLING- First quarter 14.95 tons were recycled in Huntington according to Rumpke. Pride Day zoom meeting is Thursday 4/8/2021. Need to get the list of volunteers and activities remitted. *Motion* by Rollin with a second by Lamb to authorize up to \$225.00 for flowers to be planted at the Township Hall by the local 4H group. Roll call: 2 yeas.

TRASH CONSORTIUM- nothing

EMPLOYEES- Lamb: Trustees held work sessions to go over the resumes received for road position. There were interviews with potential candidates and the decision is to extend the offer to Matthew Combs. *Motion* by Lamb with a second by Rollin to offer Matthew Combs a full-time position at \$17.00 per hour, after 60 days probation he will be eligible for health care coverage. Start date is set at April 12, 2021. This is pending his drug/alcohol and federal clearinghouse checks as well as a background check as requested by Robert Holmes. Mr. Combs will be entitled to 11 paid Holidays and will have work days of Monday through

CHIP & SEAL PROGRAM- Lamb: the Lorain County Engineer recommended Melway for the Chip and Seal bid they submitted. *Motion* by Lamb with a second by Rollin to authorize *Resolution 2021-35* awarding the chip and seal contract to Melway Paving Co., Inc at a cost of \$53,857.50 or \$56,324.90. Lanning to send letters to all bidders including Sarver to inform them that the Township will award the project per the Lorain County Engineers review and recommendation.

LAND USE PLAN- still in progress.

OTHER- Salt resolution filed with request for 100 ton for the 2021-2022 season.

NEW BUSINESS: Candy Brown called asking about setting up a food trailer in the Park. Lamb: no problem with her setting up a food trailer for games or practices. Lanning to call her and tell her to talk with Szynal about when the ball teams are playing. Szynal: will contact Nikki McConnell and Jennifer Worchester to answer their questions on using the park.

CORRESPONDENCE/ANNOUNCEMENTS: Virginia Haynes email asked if there is anything to post in the Senior Living newspaper. Rollin: received an email from Tom Kelly that he is retiring from Emergency Management.

PUBLIC PARTICIPATION: Tyler and Alexis Honoshofsky asking about a permit and discussed the option of installing a culvert pipe along the road to make it easier to mow the bank. Lamb: Finkel will talk over the culvert pipe and what permits might be needed.

Motion by Rollin with a second by Lamb to adjourn. All favorable, meeting adjourned at 7:39 PM.
