Mayor Pro Temp Edwardes called the meeting to order at 6:00 p m, he then led the invocation and Pledge of Allegiance.

Staff Reports:

Town Clerk, Veronica Brown announced the following events were coming up: 1) Farmers Market starting June 5th in the town park, 8am until noon each Saturday through August 28th (vendor spots are \$5 each Saturday) 2) LMA District Meeting to be held on June 21st in Springhill 3) LCDBG Grantee Workshop to be held on May 26th 4) Balloon Glow to be held on July 3rd 5) Former Chief of Police David Searcy will be returning to Greenwood to help enforce Property Standards

Police Chief, Shayne Gibson stated that there was one use of force incident in the month of April. 2) Encouraged the Public to lock the doors on their cars and light up your yard in order to help prevent burglaries 3) Announced National Night Out will be held on Tuesday, October 5th (more details to follow) 4) Responded to an inquiry made by Alderman Robinson about the 18 wheeler accident on I-20

1. Ordinance No. 3 of 2021

TITLE: AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE TOWN OF GREENWOOD, BY REZONING PROPERTY IN THE VACINITY OF 7300 BLOCK OF HWY 169 SOUTH, MORE PARTICULARTLY DESCRIBED IN EXHIBIT "A" TO THE ORDINANCE, FROM R-A, RESIDENCE/AGRICULTURE DISTRICT TO B-3, BUSINESS DISTRICT; AND OTHERWISE PROVIDING WITH RESPECT THERETO

Town Clerk, Veronica Brown read the Ordinance by Title and Mr Harold Goff (P & Z Commissioner) gave information from the P & Z meeting and advised the Board voted a favorable recommendation. Mr. David Cox, Greenwood Resident, spoke in favor of the proposed change in zoning and touched on the added benefits that the business would bring to Greenwood.

Alderman Robinson proposed that the town provide larger zoning signs, it was also recommended that the town place re-zoning signs in other parts of the town and not just on the proposed property. At this time, Town Attorney Charles Grubb advised that Municode was in the process of reviewing and modifying the current Codes for the town and now is the time to make recommendations.

2. Ordinance No. 5 of 2021

TITLE: AN ORDINANCE ADOPTING THE BUDGET FOR THE TOWN OF GREEN WOOD, PARISH OF CADDO, STATE OF LOUISIANA, FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022. (To introduce and set for Public Hearing June 22, 2021)

Town Clerk, Veronica Brown read the Ordinance by Title and went over each fund and advised where the increases/decreases would be found in each fund. Alderman Davis advised that he would like to propose Merit raises versus Cost of Living, Town Clerk Veronica Brown replied that she would put it on the June agenda.

3. Ordinance No. 6 of 2021

TITLE: AN ORDINANCE TO ADOPT THE MILLAGE RATE FOR THE TAX YEAR 2021 FOR AD VALOREM TAX TO BE USED FOR GENERAL OPERATING PURPOSES (To introduce and set for public Hearing June 22, 2021)

Town Clerk, Veronica Brown read the Ordinance by Title and advised that the proposed Millage Rate would remain the same at 9.95 Mills. There were no questions or concerns from the Board.
