

*Old King Coal
Teen Princess Flame Pageant
Rules and Regulations*

- *Contestant must be female, single, never married, divorced or had a marriage annulled. She must be of good moral character and never borne a child, must never have performed any act or engaged in any activity or employment that is or could be characterized as immoral or indecent. Attests that any and all online depictions associated with the contestant's name or likeness including but not limited to social networking sites (ie: Facebook, Instagram, Snapchat, Twitter) are consistent with the standards and dignity of the Princess Flame Pageant (Pageant). Contestant must not use or consume any illegal controlled substances or abuse the use of alcohol or other dangerous substances.*
- *Teen Princess Flame Contestant shall not be less than 13 years of age or more than 16 at the time of the pageant.*
- *Contestant agrees to have her photograph taken at the discretion of the Pageant's Committee. It is understood that this photograph may be used in any manner in connection with publicity for Old King Coal Festival and Princess Flame Pageant.*
- *The contestants chosen as the 2018 Teen Princess Flame agree to be available to reign over the 2018 Old King Coal Festival. They will be required to attend the Old King Coal Festival and be available to ride in the Old King Coal Parade. Contestants will furnish a driver of at least 21 years of age, with a valid driver's license, and proof of insurance to drive a vehicle in the Old King Coal Parade and any optional events which might require a rented or loaned vehicle. If the driver or contestants cause any damage to rented or loaned vehicle while representing Old King Coal and Princess Flame Committees, contestants shall hold harmless said Committees from any and all liability to said vehicle or any damage caused to another individual or vehicle.*
- *Teen Princess Flame will be expected to make personal appearances during her reigning year as arranged for by the Pageant Committee.*
- *If for any reason the winning contestant becomes incapable of performing her duties as Teen Princess Flame, in the opinion of the Pageant Committee, she will automatically relinquish her title.*
- *Contestants will be judged in these areas of competition: private interview; "anything goes" wear; formal wear and on-stage speaking. "Opening number" will not be judged.*
- *The decision of the judges shall be final.*
- *Contestant entry received on or before the deadline will be guaranteed their picture is in the official Princess Flame program. Entries received after the deadline are not guaranteed.*
- *The Pageant Committee reserves the right to make changes in the pageant rules and regulations.*
