4. Fiscal Officer: FO provided financials, Payroll, PO, Payments, EFT's, BC to trustees for approval.

Jeffrey presented a discussion he had with Bill McCluskey and a motion to approve fiscal officer paying utility bills and other bills with approved PO's online, if all supporting documentation is received. This will help reducing late fees and credit denials associated with Trustee meeting schedules held after due dates. Trustees also discussed late mail delivery being a problem.

Discussed Gasoline stations closed in township and some areas due to staffing issues and covid.

Country Side Truck Service contract brought up by Fiscal Officer for clarification. Jeffrey reviewed what Bill had, identifying differences. He reported he got this from Jesse. Bill said he did create a PO for the \$4200 that was approved at last meeting, but this contract is \$900 higher. Jeffrey reported for Bill to hold off until further clarification.

Rhonda (referring to rest stop) said they are replacing the buildings there with new ones.

Motion to pay EFT' and warrants 42068-42085

Chris motioned, seconded by Tim.

Chris brought up use of Town Hall by the Boy Scouts. He said he talked to Kevin and Kevin reported the Health Department had sheets from Tim. Tim reported he got from Health Department and gave to Kevin. Chris stated the sheets were used to identify how many people could be in the building. Six square feet per person, give 45-person capacity in town hall. (This is related to meeting social distancing standards). Chris reported "he" (?) said there were only about 16 or 17 /with parents /scouts so they were letting the parent go in there instead of sitting out in the cars. Chris said he told Noreen this was okay.

Chris reported that he understands the bus drivers have to certify every year. Chris asked if the Bus drivers could use the town hall in smaller groups (pods) for classes, 2 times a year for a week long class. He said they don't have the funds to pay for the buildings. Tim and Jeffrey said would be fine. Jeffrey mentioned that Noreen needs to have the time to clean it up between times. Chris and Rhonda discussed that the Busses are sprayed between uses and maybe this could be used at the town hall. Rhonda stated that is not user friendly to be used if you are in the environment without time passing. Chris said he would talk to them (? Laurie) and Debbie about it. He said he will have Debbie make arrangements. (Debbie Diehl)

Chris made a motion the State Examiners, Laurie coordinator (?Northeast Ohio bus drivers) to use the town Hall for classes at no charge, once or twice a year, but rotating. Tim Seconded.
