**Bylaw No. 635.14, 2017**

**Purpose:** To provide a text amendment to allow Police Stations and Jail Cells as a Permitted Use within the C.1 – Central Commercial Zone.  
**Location:** 370 Muchalat Drive, Lot 2, Plan VIP53845, District Lot 637, Nootka Land District, PID 017-695-031

**Bylaw No. 635.15, 2017**

**Purpose:** To provide a text amendment to allow Dormitory Use in the P.2 – Civic Use Zone.  
**Location:** 500 Trumpeter Drive (Ray Watkins Elementary School), Lot 1, Block G, Plan 18696, District Lot 637, Nootka Land District, (except Plan VIP58554) PID 003-763-293

Written submissions (submitted in person, by mail or by email) must be received no later than 4:00 p.m. on Wednesday, April 5, 2017 to ensure their availability to Council at the public hearing.

Following the close of the public hearing, no further submissions or comments from the public or interested parties can be accepted by members of Village Council, as established by provincial case law. This is necessary to ensure a fair Public Hearing process and provide a reasonable opportunity for people to respond.
