### FIRE DEPARTMENT:

Monthly runs so far have been 19 fire and 52 EMS for a total of 581 YTD. There were a total of 19 mutual aids provided to Amanda, Lancaster, and Berne townships. Fire Chief Golden completed a demo of the new cardiac arrest machine that we received from the grant awarded by BWC. The run numbers are up to Berne Township due to the run card with them.

### **OLD BUSINESS**
