2340.10 Description Under supervision of the Field Operations Supervisor and/or Serviceperson, the Utility Worker: works with the Field Operations Supervisor and/or the Serviceperson in the construction and repair of water and sewer facilities; stocks trucks; drives service and dump trucks; operates compaction equipment, jackhammer and compressor, and other hand and power equipment as necessary and/or as directed; assists in digging, backfiiling and repairing roads and pavement; assists in the construction, maintenance and repair of District property; assists in general yard and shop work; and, shares standby and emergency responsibilities with other field personnel; and, performs additional duties as assigned.

2340.20 <u>Required Qualifications</u> He/she must possess one (1) year experience in general construction work. He/she must have sufficient formal or informal education to assure the ability to read and write and perform math calculations at a level required for successful job performance. He/she shall possess a valid and appropriate California driver's license.
