EXHIBITOR INFORMATION:

- La Porte is on Chicago time - Central Standard Time
- Doors open at 7:00 am
- Entries must check in 30 minutes before class time.
- No training of any kind in the ring. Bring your own water. Limited chairs available.

DOS entries are 7:00 – 7:30 A.M. each day (provided trial is not full)

Entries must be received **by December 10th, 2022** at the secretary's address.

DOS \$25; DOS Jr. Handler & NLC \$15; PE \$20, \$17 2nd entry same dog/same trial pre entry only. Pre entry Junior \$12.00, Pre entry NLC \$12.00 . Discount example. Ro1 and Ro2 same dog or Open and Utility same dog same trial. If you are entering Rally each trial and obedience each trial, one class would be \$80.00. If you are entering Ro1 and Ro2 each trial, would be \$20 plus \$17 each trial. All Three Classes either same dog, same trial \$50.00

After closing date, entries are \$25.00 Non-licensed classes are **\$15.00.**
Junior Handler Day of Show entries are \$15.00

Entries will run in "B" if no designation is indicated. It is exhibitors responsibility to mark entry if requesting to jump minimum height in obedience and RO3 in Rally.

Checks will be deposited on closing date.

NSF checks returned constitute an invalid entry. A returned check charge of \$35.00 will be charged to any check returned as NSF.
