n 2015, after careful assessment of the current needs for the Dixon House, the Board of Directors (BOD) created a "Project List." High on that list was upgrading the residence's security system. Although maintenance had been done over the years on our security system, technology has taken a giant leap past our old security system's capability.

A request for bids was made, as well as a grant request. The results were disappointing. Therefore, the Board of Directors reassessed the project and split it into two distinct phases: Phase 1 for cameras and monitors and Phase 2 for an emergency nurse call system.

We sent off a new bid request, as well as our annual appeal letter. Our efforts paid off and by June 2016 we had the necessary funds and a contract was awarded to Talon Security a local security firm in Trappe, Maryland. Phase 1 of the security system project was completed in August 2016 thanks to all those who responded to our annual appeal with a generous donation.

This phase provides the Dixon House with state of the art monitors and cameras, as well as additional cameras on corridors and in common areas where residents gather. It provides us with the ability to monitor access to the facility, but the biggest benefit is the added security and peace of mind for our residents, their families and staff.

We appreciate the opportunity to bring you up to date on the operations and needs of the Dixon House. With your continued support from the 2016 Annual Appeal we have begun work on Phase 2 of our security system, so stay tuned.

At age 55, Helen decided to get her high school diploma, something that had been her dream and to pursue a second career in health care. She decided to become a unit secretary at Harbor Hospital in Baltimore where she worked until she retired, at which time she moved to Cambridge with her husband. Following her husband's death, she moved back to Annapolis where she was an active volunteer for the Lutheran Mission in Annapolis. She returned to the Eastern Shore approximately 8 years ago, living at Park View Apartments in Easton and living an active life as a volunteer. She volunteered with over 500 volunteer hours with the Memorial Hospital Auxiliary and also with Saint Vincent de Paul. Her hobbies

included dancing and playing bridge. She is a woman of great faith and has been an avid church goer for her entire adult life. She is currently a member of Grace Lutheran Church here in Easton.

According to her daughter, Diane Lusby of Easton, who has cared for her mother since 2012 when her mother began to have some cognitive issues, being active has been key to Helen's longevity.
